SB 533, An act concerning school finance; relating to state aid and certain weightings; amending K.S.A. 2001 Supp. 72-6407, 72-6410, 72-6412 and 72-6442 and repealing the existing sections, by Committee on Education.

SB 534, An act concerning crimes, criminal procedure and punishment; relating to moratorium of execution of death sentences; creating a death penalty study commission and prescribing certain duties thereon, by Committee on Judiciary.

SB 535, An act concerning civil actions and civil penalties; relating to false or fraudulent medicaid claims, by Committee on Judiciary.

SB 536, An act concerning crimes, criminal procedure and punishment; creating certain crimes involving use and possession of body armor and prescribing penalties therefor, by Committee on Judiciary.

INTRODUCTION OF HOUSE BILLS AND CONCURRENT RESOLUTIONS

HB 2626, HB 2629, HB 2630 were thereupon introduced and read by title.

REPORTS OF STANDING COMMITTEES

Committee on **Assessment and Taxation** recommends **SB 408** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

Committee on Education recommends SB 393 be passed.

Also, **SB 402** be amended on page 1, in line 13, by striking "shall" and inserting "may"; in line 30, by striking "school programs" and inserting "schools"; in line 31, by striking "school programs" and inserting "schools";

On page 2, following line 3, by inserting:

- "Sec. 3. K.S.A. 2001 Supp. 72-1904 is hereby amended to read as follows: 72-1904. The board of education of any school district may authorize the establishment of a nonsectarian, outcomes-oriented educational program, hereinafter referred to as a charter school, as a means of providing new opportunities for:
 - (a) Improved pupil learning;
- (b) increased learning opportunities for pupils in special areas of emphasis in accord with themes established for charter schools;
 - (c) creative and unconventional instructional techniques and structures;
- $(\mbox{\bf d})$ new professional vistas for teachers who operate such schools or who choose to work in them; and
 - (e) freedom from conventional program constraints and mandates.";

By renumbering sections accordingly;

On page 4, by striking all in line 8; in line 9, by striking all before the comma; in line 10, by striking "30";

On page 5, in line 30, following "72-1903," by inserting "72-1904,";

In the title, in line 10, following "1903," by inserting "72-1904,"; and the bill be passed as amended.

SB 409 be amended on page 1, in line 16, by striking "sections 5 and 6,"; by striking all following line 38;

By striking all on pages 2 through 11;

On page 12, by striking all in lines 1 through 26, and inserting:

"Sec. 3. K.S.A. 72-6405 and K.S.A. 2001 Supp. 72-6426 are hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its publication in the statute book.";

In the title, in line 10, by striking all following "72-6426"; in line 11, by striking "6433"; and the bill be passed as amended.
