# INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Vratil introduced the following Senate resolution, which was read:

### SENATE RESOLUTION No. 1821-

A RESOLUTION congratulating and commending Ashley Wright upon being named the state's top high school volunteer by the Prudential Spirit of Community Awards.

WHEREAS, Ashley Wright, a 17 year old junior at Blue Valley North High School, has been named as the state's top high school volunteer in the seventh Prudential Spirit of Community Awards, a nationwide program recognizing young people for outstanding community service. This award is presented by Prudential Financial in partnership with the National Association of Secondary School Principals. She will receive a \$1,000 award, an engraved silver medallion and an all-expense-paid trip to Washington, D.C., May 4 to 7 for a series of national recognition events. There she will join honorees from the other states, 12 of whom will be named America's top volunteers for 2002; and

WHEREAS, As a community service project, Ms. Wright formed a vocal music performance class for challenged adults in her community. Working with the local parks and recreation department, she designed a brochure which was sent out with a community newsletter. Twenty special needs adults enrolled in her six-week class. She determined the musical selections, created song books and planned a class format. After four weeks of intense rehearsals the group performed at several area nursing homes. Their performances were greatly appreciated, and each nursing home asked them to return and perform longer. She plans to teach a second class in the spring; and

WHEREAS, The success of our state, the strength of our communities and the vitality of our society depend, in great measure, upon the dedication of young people like Ashley Wright who use their considerable talents to serve others: Now, therefore,

*Be it resolved by the Senate of the State of Kansas:* That we congratulate and commend Ashley Wright upon being named as the state's top high school volunteer and commend her actions to be emulated by her peers;

*Be it further resolved:* That the Secretary of the Senate provide an enrolled copy of this resolution to Ms. Ashley Wright, 12704 Woodson Street, Overland Park, Kansas 66209-3672.

On emergency motion of Senator Vratil SR 1821 was adopted unanimously.

Senator Vratil introduced and congratulated Ashley, for her outstanding community service. Accompanying Ashley were her parents Sheryl and Gardner Wright.

## **REPORTS OF STANDING COMMITTEES**

Committee on **Judiciary** recommends **SB 521** be amended on page 1, in line 15, by striking "The" and inserting "Except as provided in subsection (b), the"; in line 18, by striking all after the period; by striking all in lines 19 and 20; in line 21, by striking all before "If"; after line 24, by inserting:

"(b) Subject to the provisions of subsection (b)(1) of K.S.A. 21-4718, and amendments thereto, any fact that would increase the penalty for a crime beyond the statutory maximum, other than a prior conviction, must be submitted to a jury and proved beyond a reasonable doubt.";

Also on page 1, in line 25, by striking "(b)(1)" and inserting "(c)(1)";

On page 2, in line 9, after "victim" by inserting "or the offense was motivated by the defendant's belief or perception, entirely or in part, of the race, color, religion, ethnicity, national origin or sexual orientation of the victim whether or not the defendant's belief or perception was correct";

On page 4, in line 10, after "court" by inserting "not less than 30 days prior to the date of trial or if the trial date is to take place in less than 30 days then"; in line 16, before "within" by inserting "not less than 30 days prior to the date of trial or if the trial date is to take place in less than 30 days then";

On page 5, in line 22, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

Committee on **Ways and Means** recommends **SB 557** be amended on page 1, in line 43, after "clusively" by inserting "(1)";

On page 2, in line 8, preceding the period, by inserting: "; or (2) for other medicaid reimbursable services for persons with developmental disabilities based upon an agreement entered into by the secretary and community developmental disability organizations by written contract"; and the bill be passed as amended.
