HOUSE RESOLUTION No. 6007-

By Committee on Agriculture

A RESOLUTION urging the United States Department of Labor to award Senior Community Service Employment Program grants to Experience Works in Kansas and throughout the country.

WHEREAS, The United States Department of Labor announced an open, competitive process for all national, private sector grants under the Senior Community Service Employment Program (SCSEP); and

WHEREAS, Experience Works founded the program in 1965 as a small demonstration project to help older, low income farmers supplement their income and provide community service training and employment while providing important services to their local communities; and

WHEREAS, In 2002, Experience Works placed 38% of its SCSEP participants into good jobs through its program which is 190% of the 20% goal established by the United States Congress; and

WHEREAS, Experience Works has significantly improved the quality of life of its senior participants despite significant barriers to employment and has provided employment opportunities and resources in rural counties wherein such opportunities are frequently limited; and

WHEREAS, Experience Works operates in a very efficient manner by providing one of the lowest cost per participant rates and providing that \$.89 of every dollar goes directly to participants in the form of wages for community service assignments, benefits, training, support services and direct employment assistance; and

WHEREAS, Participants placed by Experience Works through this program have their earnings increased by 357% and participants provided 16 million hours of community service to over 10,000 organizations and agencies; and

WHEREAS, Every tax dollar invested in Experience Works returns roughly \$1.53 in the first year alone; and

WHEREAS, Experience Works is an organization with a proven, nationwide delivery service system, a state of the art information technology capability, a dedicated and knowledgeable staff, significant experience, an outstanding record of performance and fiscal accountability and an extensive delivery service system that demonstrates the benefits of employing the talents of our older citizens: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we urge the United States Department of Labor to award Senior Community Service Employment Grants to Experience Works in Kansas and throughout the country; and

Be it further resolved: That the Chief Clerk of the House of Representatives be directed to send enrolled copies of this resolution to the President of the United States, the Secretary

of the United States Department of Labor and each member of the Kansas Congressional Delegation.

A RESOLUTION in memory of Kenneth R. King.

WHEREAS, Kenneth R. King, 72, of Leon and a former member of the Kansas House of Representatives, died January 20, 2003; and

WĤEREAS, Kenneth R. King served in the Kansas House of Representatives from 1978 to 1996. He was the former chairperson of the committees on transportation and elections and vice-chairperson of the committees on public health and welfare and the joint committee on pensions, investments and benefits; other committee assignments were as a member of the committees on energy and natural resources, assessment and taxation, labor and industry, insurance, legislative, judicial and congressional apportionment, commercial and financial institutions, ways and means, appropriations, federal and state affairs, joint committee on special claims and economic development; and

WHEREAS, Kenneth R. King resided in Butler county all his life. He attended Augusta High School and graduated from Leon High School in 1948. In 1961 he took over the family farm in Bloomington township and established himself as a life-long farmer and rancher raising wheat and beef cattle. He was an avid pilot and airplane owner most of his life and took many memorable flying vacations with his family; and

WHEREAS, Kenneth R. King was very active in community service. His accomplishments included serving on the local selective service board, on Unified School District 205 as a board member and president, and as a member of the Kansas state board of education and the Kansas Turnpike Authority. He also served on the Prairie State Bank board of directors: and

WHEREAS, Kenneth R. King married Ruth Jean Schneider in 1953; she survives; also surviving are a daughter, two sons and seven grandchildren: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we extend our deepest sympathy to the family of Kenneth R. King and express our appreciation for the public service he gave to his community and state; and

COMMITTEE OF THE WHOLE

On motion of Rep. Mason, Committee of the Whole report, as follows, was adopted: Recommended that on motion of Rep. Landwehr to amend **SB 6** on page 1, by striking line 13 and inserting new material to read as follows:

"Section 1. On June 8, 2003. K.S.A. 74-8803 is hereby amended to read as follows: 74-8803. (a) There is hereby created the Kansas racing and gaming commission, consisting of five members who shall be appointed by the governor, subject to confirmation by the senate as provided by K.S.A. 75-4315b and amendments thereto. Except as provided by K.S.A. 46-2601 and amendments thereto, no person appointed to the commission shall exercise any power, duty or function as a member of the commission until confirmed by the senate.

- (b) Before appointing any person as a member of the commission, the governor shall cause the Kansas bureau of investigation to conduct a criminal history record check and background investigation of the person.
 - (c) The members of the commission shall meet the following qualifications:
- (1) Each member shall be a citizen of the United States and an actual resident of Kansas at the time of appointment and during such member's term of office with the commission;
- (2) each member shall have been a resident of Kansas for a continuous period of not less than five years immediately preceding appointment to the commission; and
- (3) no member shall have been convicted of a felony under the laws of any state or of the United States at any time prior to appointment or during such member's term of office with the commission.
 - (d) The governor shall make appointments to the commission in such a manner that:
- (1) Not more than three members belong to the same political party at the time of appointment and during their terms of office with the commission; and
- (2) subject to the provisions of K.S.A. 75-4315c and amendments thereto each congressional district has at least one member residing in such district at the time of appointment.
- (e) Except as provided by subsection (f), each member appointed before July 1, 1995, shall be appointed for a term of three years and until a successor is appointed and confirmed. Each member appointed on or after July 1, 1995, shall be appointed for a term of four years and until a successor is appointed and confirmed.

- (f) The terms of members who are serving on the commission on the effective date of this act shall expire on January 15, of the year in which such member's term would have expired under the provisions of this section prior to amendment by this act. Thereafter, members shall be appointed for terms of four years and until their successors are appointed and confirmed.
- (g) A vacancy on the commission shall be filled for the unexpired term by appointment by the governor.
- (h) The commission shall meet at such times and places within this state as the chairperson or a majority of the commission members determines. A majority of the members shall constitute a quorum for the conduct of commission business.
- (i) The governor shall designate a member of the commission as chairperson of the commission, to serve in that capacity at the pleasure of the governor. The members of the commission annually shall elect a vice-chairperson and secretary from the membership of the commission.
- (j) Members of the commission shall receive such compensation as determined by the governor, subject to the limitations of appropriations therefor, and, when attending meetings of the commission, or a subcommittee meeting thereof approved by the commission, shall be paid compensation, subsistence allowances, mileage and other expenses as provided in K.S.A. 75-3223 and amendments thereto, except that such compensation for members of the commission shall be provided at the per diem rate provided in K.S.A. 75-3223 and amendments thereto for members of the legislature.
 - Sec. 2. On June 8, 2003, K.S.A. 74-8803 is hereby repealed.
 - Sec. 3. K.S.A. 74-8840 is hereby repealed.";
