REPORTS OF STANDING COMMITTEES

The Committee on **Agriculture** recommends **HB 2055** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

The Committee on Higher Education recommends HB 2008 be passed.

The Committee on **Higher Education** recommends **HB 2009** be amended on page 1, in line 21, by striking "July" and inserting "June"; in line 27, by striking "January" and inserting "July"; in line 42, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

The Committee on **Utilities** recommends **HB 2037** be amended on page 1, in line 16, by striking "on and after" and inserting "incurred between"; in line 17, before the period, by inserting ", and June 30, 2004, inclusive"; after line 19, by inserting:

"(b) The provisions of this section and K.S.A. 66-1230 and 66-1231, and amendments thereto, shall expire on June 30, 2004."; and the bill be passed as amended.
