On page 3, in line 42, after the period by inserting "In developing programs and projects and entering into contracts or agreements for implementing the provisions of this act, the council shall not use any funds collected by the council to provide for or assist the purchase of equipment related to such programs and projects by or for a private, for profit corporation or other business association or entity.";

On page 4, after line 3, by inserting the following:

"(j) The council shall report annually to the house and senate committees on agriculture. Such report shall include details of council programs, projects and activities as provided pursuant to this act."; Also on page 4, in line 9, by striking "½" and inserting "¾0 of one"; in line 10, by striking ", unless approved by the council"; and the bill be passed as amended.
