HB 2396, An act concerning tax increment financing and sales tax revenue bonds; relating to redevelopment of certain property located throughout the state; amending K.S.A. 12-1770a and 12-1774 and K.S.A. 2002 Supp. 79-3620 and repealing the existing sections, by Committee on Appropriations.

HB 2397, An act concerning the Kansas water office; establishing the water supply storage assurance fund, by Committee on Appropriations.

HB 2398, An act regulating traffic; concerning the maximum speed limit for school buses; amending K.S.A. 8-1558 and repealing the existing section, by Committee on Appropriations.

HB 2399, An act authorizing the Kansas water office to obtain loans under certain prescribed conditions; relating to the pooled money investment board, by Committee on Appropriations. **HB 2400**, An act concerning the Kansas water office; establishing the local water project match fund, by Committee on Appropriations.

HB 2401, An act concerning agriculture; relating to filing of security by grain brokers; requirements and procedures, by Committee on Federal and State Affairs.

HB 2402, An act concerning private security guards; relating to the licensure and regulation thereof; repealing K.S.A. 12-1679, by Committee on Federal and State Affairs.
