HALL OF THE HOUSE OF REPRESENTATIVES, TOPEKA, KS, Tuesday, February 18, 2003, 11:00 a.m.

The House met pursuant to adjournment with Speaker Mays in the chair.

# MOTIONS AND RESOLUTIONS OFFERED ON A PREVIOUS DAY

On motion of Rep. Ruff, **HR 6010**, A resolution congratulating and commending Donald Lee Hollowell, was adopted.

## SPECIAL REMARKS

There being no objection, the following remarks of Rep. Ruff are spread upon the Journal.

Mr. Speaker and fellow House members, Rep. Wilk, Rep. Crow and myself take a great deal of pride in sharing with you the life and accomplishments of Donald Hollowell, a native Kansan who has lived his life as a testament to what we hold dear in our great State.

This is a man who walked with the giants of the Civil Rights movements but more importantly when the time came, he served as their lawyer and argued quite persuasively to get them out of jail. On numerous occasions he stood beside the Rev. Dr. Martin Luther King Jr. and used his excellent legal skills to defend his right to eat at a lunch counter, demonstrate against unfair hiring practices or march in protest of inhuman treatment.

As an attorney, this man who was educated in Kansas public schools, understood and appreciated the law. As a Christian, he knew the Lord called on his people to defend the weak against the tyranny of the majority. And as a Kansan raised in a home that valued discipline and respect, he never forgot where he came from.

But the fight he was waging was far from home, because Donald Hollowell was a Midwesterner, born in Wichita and raised in Leavenworth. It was in Leavenworth that he faced his first real disappointment. It was the dark days of the Great Depression, and Mr. Hollowell's father told him he'd have to forego his last year of high school and get a job.

Donald Hollowell headed to Ft. Leavenworth and joined the famous 10th Cavalry, the Buffalo Soldiers. Thus began the process of learning military organization, discipline and order, and lessons well learned. He also took advantage of Kansas State University Extension Courses to complete his high school diploma.

After three years in the Army, the opportunity to attend Lane College was gladly taken by Mr. Hollowell. Then World War II drew him back into the Army. This time he took advantage of Officer Candidate programs as well as other advanced courses in infantry and armor. He left the military a Captain.

The war had also given him the opportunity to meet the woman who would be his wife, Louise Thornton Hollowell. He credits her with being the anchor on which this successful champion of Civil Rights has depended.

And as he depended on the companionship of a strong, loving marriage, he called upon his own faith and belief in following a higher call to attend Loyola Law School in Chicago. Because his wife was from Atlanta, he decided to practice law in Georgia. And from a humble law office, he launched a legal career.

And what an outstanding career it turned out to be. Yes, he did defend Dr. King on numerous occasions. But he counts the defense of Hamilton Holmes and Charlayne Hunter-Gault among his proudest moments. Both were rejected application into the University of Georgia. The racial barriers were immense but Mr. Hollowell overcame each one. Mr. Hamilton now serves as a distinguished federal judge and Ms. Hunter-Gault is often seen on National Public Television's evening news.

At the time Mr. Hollowell said, "The day they crossed the line from fear to fortitude everything became possible."

That decision made all the difference to those two young people. And the decision Mr. Hollowell made to fight for social justice made all the difference to the people he defended.

The members of the House welcomed Mr. Hollowell with a standing ovation. He was accompanied by his wife, Louise.

Committee report to **HB 2045** be adopted; also, on motion of Rep. Sloan be amended on page 1, in line 14, before "Any", by inserting "(a)"; in lines 18 and 19, by striking ": (1) Shall" and inserting "shall"; in line 20, by striking "; or (2) if" and inserting ". If"; in line 22, before the period, by inserting "unless the board of county commissioners determines it is in the county's best interest to waive such reimbursement";

Also, on motion of Rep. Powell to amend **HB 2045**, the motion was withdrawn, and the bill be passed as amended

Committee report to HB 2106 be adopted; and the bill be passed as amended.

Committee report recommending a substitute bill to **Sub. HB 2219** be adopted; and the substitute bill be passed.

Committee report to  $HB\ 2017$  be adopted; also, be passed over and retain a place on the calendar.

#### **REPORTS OF STANDING COMMITTEES**

The Committee on Ethics and Elections recommends HB 2249 be passed.

The Committee on Health and Human Services recommends HR 6005 be adopted.

The Committee on **Health and Human Services** recommends **HCR 5008** be adopted and, because the committee is of the opinion that the concurrent resolution is of a noncontroversial nature, be placed on the consent calendar.

The Committee on **Judiciary** recommends **HB 2032** be amended on page 2, in line 22, by striking all after the period; and by striking all of lines 23 through 43;

On page 3, by striking all of lines 1 through 12, and inserting the following:

"New Sec. 3. (a) Except as provided in article 35 of chapter 58 of the Kansas Statutes Annotated, and amendments thereto, whenever any program or project is undertaken by any plaintiff who exercises the power of eminent domain which program or project will result in the displacement of any person by acquisition of real property, such plaintiff shall provide fair and reasonable relocation payments and assistance to or for displaced persons.

(b) Fair and reasonable relocation payments and assistance to or for displaced persons as provided under sections 202, 203, 204, 301, 302, 303 and 304 of the federal uniform relocation assistance and real property acquisition policies act of 1970, and amendments thereto, shall be deemed fair and reasonable relocation payments and assistance pursuant to this section.

(c) This section shall be part of and supplemental to the eminent domain procedure act.";

Also on page 3, in line 13, after "26-506", by striking the comma and inserting "and"; also in line 13, by striking ", 58-3502 and 58-3505";

On page 1, in the title, in line 10, by striking the comma and inserting "and"; also in line 10, by striking "and 58-3502"; in line 11, by striking "; also repealing K.S.A. 58-3505"; and the bill be passed as amended.

The Committee on **Judiciary** recommends **HB 2034** be amended on page 1, in line 18, by striking "or" and inserting a comma; also in line 18, after "corporation", by inserting "or other legal entity"; in line 41, by striking "of a de-"; in line 42, by striking "cedent's estate"; On page 6, in line 18, by striking all after "(10)"; by striking all of lines 19 and 20 and

On page 6, in line 18, by striking all after "(10)"; by striking all of lines 19 and 20 and inserting "to alienate the homestead without the joint consent of husband and wife when that relationship exists if the power of attorney specifically: gives the attorney in fact the power to sell, transfer and convey the homestead in question; gives the legal description and street address of the property; states that by the execution of the power of attorney it is the intention of the parties that the act shall constitute the joint consent required by Article 15, Section 9, of the Kansas Constitution and the power of attorney is executed by both the husband and wife in the same instrument;" in line 33, after "principal" by inserting "or to make, execute, modify or revoke a durable power of attorney for health care decisions pursuant to K.S.A. 58-625, *et seq.*, and amendments thereto, for the principal"

On page 8, in line 27, by striking "a conservator,"; by striking all of lines 28 through 32 and inserting "a guardian or conservator, or both for consideration by the court. If a petition to appoint a guardian or conservator, or both is filed, the court shall make the appointment in accordance with the principal's most recent nomination in the power of attorney, so long as the individual nominated is a fit and proper person.";

On page 9, in line 35, by striking "modified,"; also in line 35, by striking "or suspended"; in line 43, after the semicolon, by inserting "or";

On page 10, in line 4, by striking "; or" and inserting a period; in line 5, by striking "(4)" and inserting "(c)"; in line 13, by striking "(c)" and inserting "(d)"; in line 22, by striking "(d)" and inserting "(e)"; in line 30, by striking "(e)" and inserting "(f)"; in line 36, by striking "(f)" and inserting "(g)";

On page 17, after line 38, by inserting the following:

"New Sec. 16. This act adopts by reference 50 U.S.C. 591 of the soldiers and sailors civil relief act."; and by renumbering the remaining sections accordingly; and the bill be passed as amended.

The Committee on **Judiciary** recommends **HB 2068** be amended on page 5, in line 40, by striking "or sale"; in line 42, by striking "or" and inserting a comma; also in line 42, after "department" where it appears for the last time, by inserting ", medical emergency response team or the Kansas forest service";

On page 6, in line 1, by striking all after "serviceable" where it appears for the last time; by striking all in line 2; in line 3, by striking all before the period; in line 6, before the semicolon where it appears for the last time, by inserting ". This subsection shall apply to any breathing apparatus or any mechanical or electrical device which functions to monitor, evaluate, or restore basic life functions, only if it is recertified to the manufacturer's specifications by a technician certified by the manufacturer"; in line 7, by striking "or purchase"; by striking all in lines 17 through 30;

And by renumbering sections accordingly; and the bill be passed as amended.

The Committee on **Judiciary** recommends **HB 2100** be amended on page 1, in line 14, by striking "some combination of"; in line 15, after "dwelling", by inserting; "or any portion thereof"; in line 20, by striking "confusingly"; also in line 20, by striking all after the period; by striking all of lines 21 through 27; in line 32, after "Any", by inserting "clause or provision in an"; in line 34, after "liability", by inserting "as to any system or component of the residential dwelling covered by such report"; and the bill be passed as amended.

The Committee on **Transportation** recommends **HB 2113** be passed.

The Committee on **Transportation** recommends **HB 2073** be amended by substituting a new bill to be designated as "**Substitute for HOUSE BILL No. 2073**," as follows:

"Substitute for HOUSE BILL No. 2073 By Committee on Transportation

"AN ACT relating to the division of vehicles; concerning driver's licenses and identification cards; selective service registration requirements."; and the substitute bill be passed.

(Sub. HB 2073 was thereupon introduced and read by title.)
