## **REPORTS OF STANDING COMMITTEES**

The Committee on **Corrections and Juvenile Justice** recommends **HB 2015** be amended on page 1, in line 43, by striking all after the period;

On page 2, by striking all in line 1 and inserting the following:

"(d) Any time after a court has committed a juvenile offender to a juvenile correctional facility, the court, upon motion by the commissioner, may modify the sentence and enter any other sentence based on the medical condition of the juvenile." and the bill be passed as amended.

The Committee on **Environment** recommends **HB 2218** be passed and, because the committee is of the opinion that the bill is of a noncontroversial natuer, be placed on the consent calendar.

The Committee on **Higher Education** recommends **HB 2173** be amended by substituting a new bill to be designated as "Substitute for HOUSE BILL No. 2173," as follows:

## "Substitute for HOUSE BILL No. 2173

#### By Committee on Higher Education

"AN ACT concerning dental students admitted to accredited schools of dentistry; requiring and providing for certain agreements for service commitments and repayment of certain amounts prescribing certain powers, duties and functions for the state board of regents; authorizing cities and counties to enter certain agreements."; and the substitute bill be passed.

(Sub. HB 2173 was thereupon introduced and read by title.)

"(b) The chief of an organized fire department of any municipality may authorize any former member of such fire department to conduct investigations under subsection (a) if such former member was certified as a fire investigator by the state fire marshal under K.S.A. 31-157, and amendments thereto, at the time such person left employment with the fire department."; and the bill be passed as amended.

# HOUSE RESOLUTION No. 6011-

# By Committee on Taxation

A RESOLUTION congratulating and commending Don S. Hayward.

WHEREAS, Don S. Hayward, a Senior Assistant Revisor in the Office of Revisor of Statutes, retired December 20, 2002, after completing nearly 29 years of state service. His specialty was taxation, and in his many years supporting the House of Representatives Committee on Taxation and the Senate Committee on Assessment and Taxation, was the principal drafter of much of the state's current laws on taxation. His terse writing style is recognized and appreciated by those involved in interpreting and implementing the tax requirements of the state; and

WHEREAS, Don S. Hayward was reared in Hutchinson and graduated from Hutchinson High School in 1963 and Hutchinson Community College in 1966. He later earned a BBA in accounting from Wichita State University in 1968 and a law degree from Washburn University School of Law in 1973; and

WHEREAS, Don S. Hayward served his country honorably in the United States Army, which service included a tour of duty in Vietnam and receipt of the Army Commendation Medal; and

WHEREAS, Don S. Hayward married his home town sweetheart, Cheryl Dye, in 1967 and they are the parents of two adult children, Paul and Lesley; and

WHEREAS, Don S. Hayward enjoyed a splendid rapport with coworkers and legislators and was highly regarded for his technical drafting skills. He is a student of American history and has a passion for sports, which while vocal could sometimes be unbiased excepting his unconditional support of the St. Louis Cardinals baseball team: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we congratulate and commend Don S. Hayward for nearly 29 years of dedicated, conscientious service to the Kansas Legislature and the people of Kansas and wish him well in his retirement; and
