(a) Inflicting harm, disability or death to a police dog, arson dog. *assistance dog* or search and rescue dog is knowingly and intentionally, and without lawful cause or justification poisoning, inflicting great bodily harm, permanent disability or death, upon a police dog, arson dog, *assistance dog* or search and rescue dog.

(b) As used in this section:

(1) "Arson dog" means any dog which is owned, or the service of which is employed, by the state fire marshal or a fire department for the principal purpose of aiding in the detection of liquid accelerants in the investigation of fires.

(2) "Assistance dog" has the meaning provided by section 1, and amendments thereto.

(3) "Fire department" means a public fire department under the control of the governing body of a city, township, county, fire district or benefit district or a private fire department operated by a nonprofit corporation providing fire protection services for a city, township, county, fire district or benefit district under contract with the governing body of the city, township, county or district.

 $\frac{(3)}{(4)}$  (4) "Police dog" means any dog which is owned, or the service of which is employed, by a law enforcement agency for the principal purpose of aiding in the detection of criminal activity, enforcement of laws or apprehension of offenders.

(4) (5) "Search and rescue dog" means any dog which is owned or the service of which is employed, by a law enforcement or emergency response agency for the purpose of aiding in the location of persons missing in disasters or other times of need.

(c) Inflicting harm, disability or death to a police dog, arson dog, *assistance dog* or search and rescue dog is a class A nonperson misdemeanor.

(d) This section shall be part of and supplemental to the Kansas criminal code.";

#### HOUSE CONCURRENT RESOLUTION No. 5015-

A CONCURRENT RESOLUTION urging state agencies to use existing opportunities to improve energy performance of state facilities.

WHEREAS, Energy conservation improves comfort and saves both dollars and valuable, irreplaceable resources; and

WHEREAS, The operation of the extensive facilities of the state requires consumption of large amounts of energy and the potential for energy savings is likewise great; and

WHEREAS, State agencies have various tools to improve energy performance of state facilities, including energy audits, energy performance contracting under K.S.A. 2002 Supp. 75-37,125 and facility conservation improvement program under K.S.A. 75-37,111, *et seq.*: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That the Legislature urges all state agencies to take advantage of programs and other opportunities to improve energy performance of state facilities; and

*Be it further resolved:* That the Legislature urges the Governor to require each state agency to report to the Director of the Budget any energy conservation measures taken by the agency and the cost of and anticipated savings from such measures, including specifically any energy audit undertaken and measures taken to address the findings of such audit, and that the Director of the Budget report such information to the Legislature; and

*Be it further resolved:* That the Secretary of State is directed to provide an enrolled copy of this resolution to the Governor.
