MR. SPEAKER: I support the increase in the number of licenses, which will help land owners and tenants to re-sell these licenses to help pay for crop depredation. I am not opposed to increasing the penalties for commercialization of wildlife. However, the increase of \$5 to \$10 for a resident and \$5 to \$25 for a nonresident big game tag is too much, especially during these hard economic times. I am concerned that such a large increase may reduce the number of hunters and thus further add to deer overpopulation. However, I vote yes on **HB 2078**.—C. FRANK MILLER

Only recovery of incremental costs shall be allowed. The application shall address these issues and provide information necessary to meet these standards. If an application includes expenditures for personnel, the utility shall provide information as to the level of employees covered in the last rate order, the current level of employees and the specific basis for requesting recovery of the costs of the new personnel pursuant to K.S.A. 66-1233, and amendments thereto. The manner of recovery of security-related capital expenditures shall be the standard regulatory method of cost recovery for other capital expenditures.

(d) When an application is filed, the utility shall specify the manner in which it seeks to recover the incremental security-related costs. The commission shall review the proposal for reasonableness and efficiency. Amounts approved for recovery through a surcharge shall be identified as line items on customer bills.";

(B) "Electric transmission line" means any line or extension of a line which is at least five miles long and which is used for the bulk transfer of electricity.

(2) The authority may issue revenue bonds in amounts sufficient to pay the following described costs of construction, upgrading and acquisition, including any required interest on the bonds during such construction, upgrading and acquisition, plus all amounts required for the costs of bond issuance and any required reserves on the bonds: (A) Construction or upgrading of electric transmission lines and appurtenances to be used for the transfer of 69 kilovolts or more of electricity; (B) acquisition of the right-of-way on which transmission lines and appurtenances to be used for the transfer of 69 kilovolts or more of electricity are to be constructed; and (C) upgrading of electric transmission lines and appurtenances to be used for the transfer of 69 kilovolts or more of electricity are to be constructed; and (C) upgrading of electric transmission lines and appurtenances to be used for the transfer of 69 kilovolts or more of electricity. The bonds, and interest thereon, issued pursuant to this section shall be payable from revenues derived from use of the transmission lines.

(3) The provisions of subsection (a) shall not prohibit the issuance of bonds by the authority for the purposes of this subsection and any such issuance of bonds is exempt from the provisions of subsection (a) which would operate to preclude such issuance.";

By renumbering the remaining subsections accordingly;

HB 2307** be passed as amended.

WHEREAS, There are consumers in Kansas who wish to order and receive wines which are not available for sale in this state; and

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: The Legislature requests the Office of the Attorney General and the Division of Alcoholic Beverage Control of the Department of Revenue to conduct a study of how sales and delivery of wines which are not otherwise available to consumers in Kansas might be best implemented in this state, consistent with current regulation and taxation of such sales and delivery in Kansas; and

*Be it further resolved:* That the Legislature urges the Office of the Attorney General and the Division of Alcoholic Beverage Control to conduct hearings to receive input from interested parties and the public and to submit a report and recommendations, including any proposed legislation needed to implement such recommendations, to the Legislature at the beginning of the 2004 regular legislative session; and

*Be it further resolved:* That the Legislature directs the Kansas Legislative Research Department and the Kansas Revisor of Statutes Office to assist the Office of the Attorney General and the Division of Alcoholic Beverage Control in carrying out the study, report and recommendations pursuant to this resolution; and

*Be it further resolved:* That the Secretary of State provide an enrolled copy of this resolution to the Attorney General and the Director of Alcoholic Beverage Control.
