On motion of Rep. Hutchins, Committee of the Whole report, as follows, was adopted: Recommended that **SB 17. SB 118. SB 65** be passed.

Committee report to SB 109 be adopted; and the bill be passed as amended.

#### **REPORTS OF STANDING COMMITTEES**

The Committee on **Commerce and Labor** recommends **HB 2241** be amended on page 1, in line 30, by striking "\$300" and inserting "\$250"; in line 32, by striking "\$225" and inserting "\$150"; in line 39, by striking "\$50" and inserting "\$25";

On page 2, in line 7, by striking "\$225" and inserting "\$150"; in line 8, by striking "\$100" and inserting "\$50"; in line 12, by striking the semicolon; by striking all in line 13; in line 14, by striking all before the period; after line 25, by inserting the following:

"Sec. 2. K.S.A. 1-302a is hereby amended to read as follows: 1-302a. (a) The education requirement prescribed by K.S.A. 1-302, and amendments thereto, is satisfied by successful completion of course work consisting of at least 150 semester hours, with a concentration in accounting, at a college or university recognized by the board and the applicant is the holder of a baccalaureate or higher academic degree.

(b) On and after June 30, 1997, An applicant for admission to take the initial examination in this state as required in K.S.A. 1-302, and amendments thereto, must submit evidence satisfactory to the board of accountancy *or to the examination service* that the applicant has successfully completed coursework consisting of at least 150 semester hours, with a concentration in accounting, at a college or university recognized by the board and that the applicant is the holder of a baccalaureate or higher academic degree.

(c) The board of accountancy may define by rules and regulations the term "concentration in accounting," as the same is to be applied each place such term occurs in this section and K.S.A. 1-302b, and amendments thereto.

(d) The board, by rules and regulations, may provide for admittance to the examination in this state of persons who will have met the education requirements, as provided in this section, within 90 days after the examination to which admitted, but no report on the examination of any such person shall be made unless such person shall have met the education requirements as provided in this section. *This subsection shall expire on January 1*, 2004.

Sec. 3. K.S.A. 1-304 is hereby amended to read as follows: 1-304. (a) Each examination provided for by this act shall take place as often as may be necessary in the opinion of the board, but not less frequently than once each year. A candidate who fails shall have the right to any number of re-examinations. A candidate who passes a satisfactory the examination under this act or the act of which this section is amendatory or who has passed a satisfactory examination under the provisions of chapter 1 of the Kansas Statutes Annotated, in at least two subjects shall be deemed to have a conditional status and shall have the right to be re-examined in the remaining subjects only if a minimum grade of 50% 50 was received in each of the failed subjects, at subsequent examinations held by the board, and if the candidate passes in the remaining subjects within a period of time specified in the rules and regulations of the board, such candidate shall be considered to have passed the examination. Upon the implementation of a computer-based examination, a candidate who has conditional status on the launch date of the computer-based examination shall be given a transition period to complete any remaining examination sections under conditions to be determined by rules and regulations of the board.

(b) After considering the need for uniformity with other states, the board may prescribe, by rule and regulation, the examination process, including but not limited to, the administration of the examination, application process, methods of grading, credit and determining a passing grade.

(c) The board may contract with third parties to perform administrative services with respect to the examination.";

The Committee on Judiciary recommends SB 37 be passed.

The Committee on **Judiciary** recommends **HB 2404** be amended on page 1, in line 21, after "person" by inserting "or such person's assignee"; also in line 21, after "mortgagee" by inserting "of record"; in line 22, by striking "the tax constituting part of the judgment became due" and inserting "of the sale";

On page 2, in line 4, before the period by inserting ", except that this subsection shall not apply to any person or such person's assignee who held an interest in such real estate as mortgagee of record at the time of the sale"; after line 7, by inserting the following:

"Sec. 2. K.S.A. 79-2804h is hereby amended to read as follows: 79-2804h. No sale of real estate as provided for in article 28 of chapter 79 of the Kansas Statutes Annotated, and amendments thereto, shall be confirmed as provided for in K.S.A. 79-2804, and amendments thereto, until the purchaser at the sale; shall file files with the clerk of the court, an affidavit stating that the purchase of the real estate was not made, either directly or indirectly, for any person having the statutory right to redeem, other than any person or such person's assignee who held an interest in such real estate as mortgagee of record at the time of the sale.";

Renumber remaining sections accordingly;

Also on page 2, in line 8, after "K.S.A." by inserting "79-2804h and K.S.A."; also in line 8, by striking "is" and inserting "are";

On page 1, in the title, in line 10, after "K.S.A." by inserting "79-2804h and K.S.A."; also in line 10, by striking "section" and inserting "sections"; and the bill be passed as amended.

The Committee on Judiciary recommends SB 15 be amended on page 2, in line 13, after "landlord" by striking "and/or" and inserting "or"; also in line 13, after "tenant" by inserting "or both"; in line 17, after "statement" by inserting "in no less than ten-point boldface type"; in line 23, after the single quotation mark by inserting "If such statement does not appear in such document, a tenant's signature on such document shall not bind the tenant to any additional terms that are not contained in the rental agreement."; and the bill be passed as amended.

The Committee on Judiciary recommends SB 71 be amended on page 3, after line 3 by inserting the following:

"(h) the provisions of this section shall expire on July 1, 2005.";

#### CHANGE OF REFERENCE
