## EXPLANATIONS OF VOTE

Mr. Speaker: Known as Casey's Law, **SB** 33 allows a judge the opportunity to impound or immobilize the motor vehicle of a person convicted of driving under the influence of alcohol. This legislation was created in memory of Casey Beaver who will killed by a drunk driver who had been convicted eight different times of driving under the influence of alcohol. About one third of those arrested or convicted of a DUI are repeat offenders. Passage of this bill allows judges another tool to impress upon those repeat DUI offenders that our society is very serious about controlling individuals who choose to drink alcohol and then drive. The cursory glance this bill received certainly doesn't ensure that all necessary questions have been heard let alone satisfactorily answered. Because of past controversy, a newly proposed solution should receive close scrutiny, not the fast track, to identify all state concerns in this proposal.—Deena Horst
