SENATE CHAMBER, TOPEKA, KANSAS Wednesday, January 22, 2003—2:30 p.m.

The Senate was called to order by President Dave Kerr. The roll was called with thirty-nine senators present. Senator O'Connor was excused.

INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bills were introduced and read by title:

- **SB 40**, An act concerning fire protection; relating to the powers and duties of certain municipalities; amending K.S.A. 19-3612a and repealing the existing section, by Senator Gilstrap.
- **SB** 41, An act concerning fire safety and prevention; relating to construction standards of school buildings; amending K.S.A. 2002 Supp. 31-150 and repealing the existing section, by Committee on Federal and State Affairs.

- **SB 42**, An act concerning fire safety and prevention; concerning the powers and duties of the state fire marshal; amending K.S.A. 2002 Supp. 31-133a and repealing the existing section, by Committee on Federal and State Affairs.
- SB 43, An act concerning the department of wildlife and parks; relating to service fees; amending K.S.A. 32-989 and repealing the existing section, by Committee on Elections and Local Government.
- **SB 44**, An act relating to hospitals; providing for transfer of hospital assets under certain circumstances to a foundation created under this act; providing for the creation of such foundations and the appointment of a board of directors therefor; placing certain limitations and prohibitions on such foundations and associated persons; and defining certain terms, by Committee on Public Health and Welfare.
- SB 45, An act concerning crimes, criminal procedure and punishment; relating to aid to indigent defendants; application fee; amending K.S.A. 2002 Supp. 22-4529 and repealing the existing section, by Committee on Ways and Means.
- **SB 46**, An act concerning the Kansas pet animal act; relating to seizure and impoundment of animals, by Committee on Ways and Means.
- **SB 47**, An act concerning retirement and pensions; relating to the Kansas public employees retirement system and systems thereunder; death and disability benefits; amending K.S.A. 74-4927 and 74-4927f and repealing the existing sections, by Committee on Ways and Means
- **SB 48**, An act concerning tobacco; relating to the master settlement agreement; appeal bonds in certain litigation, by Committee on Judiciary.
- **SB** 49, An act establishing a state employee fiscal bonus program; authorizing certain bonus payments for officers and employees of certain state agencies; prescribing guidelines and powers, duties and functions for the state finance council, by Senator Bunten.
- \hat{SB} 50, An act concerning state employee compensation and benefits; establishing a state employee voluntary leave purchase program; prescribing certain powers and duties for the secretary of administration and the director of accounts and reports, by Senator Bunten.
- **SB** 51, An act concerning public utilities; relating to certain employee compensation; prohibiting inclusion in rates, by Senators Bunten and Clark.
