SENATE CHAMBER, TOPEKA, KANSAS Thursday, January 23, 2003—2:30 p.m.

FINAL ACTION OF BILLS AND CONCURRENT RESOLUTIONS

On motion of Senator Oleen an emergency was declared by a $\frac{2}{3}$ constitutional majority, and $SB\ 44$ was advanced to Final Action and roll call.

SB 44, An act relating to hospitals; providing for transfer of hospital assets under certain circumstances to a foundation created under this act; providing for the creation of such foundations and the appointment of a board of directors therefor; placing certain limitations and prohibitions on such foundations and associated persons; and defining certain terms.

EXPLANATION OF VOTE

Mr. President, I vote aye on **SB 44** only in deference to the attorney general's plea that immediate passage of this legislation is necessary to strengthen the legal position of Kansas in pending litigation. We are told that if we fail to act, the likelihood that Kansas

will lose tens of millions of dollars to Missouri after the sale of Health Midwest, Inc., to Healthcare Corporation of America is increased.

I question the wisdom of this bill. I question whether singling out hospitals for special treatment under the *cy pres* doctrine is wise and whether this ad hoc approach to cases of concern is good public policy. I question whether some of the specific language in the bill will carry out its intended and stated purposes. I question some of the specific language. I question whether adequate protections are in place to protect the financial and health care interests of Allen County, which is the site of one of the hospitals involved in the pending sale.

I also object to the process by which the language of this bill was drafted - a process that involved only a small number of legislators, none of whom were elected to represent the interests of Allen County.

Nevertheless, we are told that **SB 44** must be passed quickly - immediately - bypassing the ordinary committee process, hearing process, deliberative process, amendment process, and other safeguards normally afforded legislation. I understand and defer to that need for prompt action. As we have learned, however, legislation passed in haste is more likely to have consequences unintended by the legislature. I vote yes on **SB 44** with the assurance of the Senate President and the Senate Judiciary Committee chairman that if further reflection reveals unintended consequences, especially those that might be detrimental to rural health care in Kansas, we will fix those problems as quickly as we are passing this bill—DEBEK SCHMIDT.
