SENATE CHAMBER, TOPEKA, KANSAS Tuesday, January 28, 2003—2:30 p.m.

The Senate was called to order by Vice President John Vratil.

The roll was called with forty senators present.

REPORTS OF STANDING COMMITTEES

Committee on Agriculture recommends SB 31 be passed.

Committee on **Financial Institutions and Insurance** recommends **SB 26** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

Committee on Judiciary recommends SB 11, SB 14, SB 15, be passed.

Also **SB 18** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

SB 34 be amended on page 3, in line 37, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

Committee on **Ways and Means** recommends **SB 30** be amended by substituting a new bill to be designated as "Substitute for SENATE BILL NO. 30," as follows:

"Substitute for SENATE BILL NO. 30

By Committee on Ways and Means";

"AN ACT making and concerning appropriations for the fiscal year ending June 30, 2003, for the insurance department, state board of indigents' defense services, Kansas public employees retirement system, department of health and environment, department on aging, department of social and rehabilitation services, department of education and department of transportation; authorizing certain transfers and capital improvement projects, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing; amending K.S.A. 2002 Supp. 79-2959, 79-2964 and 79-3425i and repealing the existing sections."; and the substitute bill be passed.
