## FIFTEENTH DAY

SENATE CHAMBER, TOPEKA, KANSAS Monday, February 3, 2003—2:30 p.m.

The Senate was called to order by President Dave Kerr.

The roll was called with thirty-seven senators present.

Senators Adkins, Corbin and O'Connor were excused.

President Kerr introduced as guest chaplain, Father Harold Murphy, Pastor, St. Timothy's Catholic Church, Chicago, Ill., who delivered the invocation:

#### Heavenly Father,

God, the source of our most precious gift of life, hear our prayer. In the ever-changing tapestry of the history of humanity, our ancestors chose to give order to their lives by forming republics in which men and women were and still are elected to represent the people. #### INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bills and resolutions were introduced and read by title:

**SB 123**, An act concerning crimes and punishment; relating to possession of drugs; mandatory treatment; amending K.S.A. 65-4160 and K.S.A. 2002 Supp. 21-4603d, 21-4705, 21-4714, 22-3716 and 75-5291 and repealing the existing sections, by Special Committee on Judiciary.

**SB 124**. An act relating to the department of agriculture; renaming the department of agriculture; transferring powers and duties of the secretary of the department of health and environment to the secretary of agriculture; transferring powers and duties of the state board of education to the secretary of agriculture, by Committee on Agriculture.

**SB 125**. An act relating to wildlife and parks; creating the big game animal depredation management fund; also creating the big game animal depredation management stamp; amending K.S.A. 32-992 and K.S.A. 2002 Supp. 20-2801, 32-988 and 32-1047 and repealing the existing sections, by Committee on Agriculture.

**SB 126**, An act concerning certain unsolicited telephone calls; amending K.S.A. 2002 Supp. 50-670 and repealing the existing section, by Committee on Commerce.

**SB 127**, An act concerning insurance; relating to exemption from jurisdiction of commissioner of insurance; amending K.S.A. 40-2222 and repealing the existing section, by Committee on Financial Institutions and Insurance.

**SB 128**, An act concerning schools; relating to communications between pupils and school counselors or psychologists, by Committee on Education.

**SB 129**, An act establishing a statewide birth defects information system; providing for administration by the secretary of health and environment and for collection of data; authorizing the use of such data for certain purposes; providing for the appointment of a council to assist in the implementation and establishment of the system, by Committee on Public Health and Welfare.

SENATE CONCURRENT RESOLUTION No. 1604-

Be it resolved by the Senate of the State of Kansas, the House of Representatives concurring therein: That it expressly encourages the President and the United States Congress to approve federal energy legislation that promotes and expands the use of ethanol and biodiesel in the nation's fuel supply; and

*Be it further resolved:* That the Secretary of State be directed to send enrolled copies of this resolution to the President of the United States, the President Pro Tempore of the United States Senate, to the Speaker of the United States House of Representatives and to each member of the Kansas congressional delegation.

SENATE CONCURRENT RESOLUTION No. 1605-

#### A CONCURRENT RESOLUTION to assist the homeless.

WHEREAS, There continue to be members of our society who are homeless, either by choice or circumstance, who need assistance in various ways, both while homeless and in returning to a conventional lifestyle; and

WHEREAS, Society, either through private organizations or taxpayer supported programs, provides assistance in feeding, housing and caring for these destitute individuals, but such activities do not provide them with a home; and

WHEREAS, The cost of providing social services to our citizens continues to grow and, at this time, the state faces enlarging budget deficits; and

WHEREAS, It is proposed that private families be considered as a collateral resource for homeless missions in assisting homeless individuals; and

WHEREAS, A family would provide stable housing and emotional support for one needing such and would provide a strong incentive for the homeless person to become an active member of society; and WHEREAS, Contacting family members by homeless individuals might be facilitated by providing them with prepaid calling cards, voice mail or similar communication devices; and

WHEREAS, It is proposed that study be given as to the policies and procedures needed whereby homeless individuals could be assisted and the method by which private families could be compensated for providing assistance: Now, therefore,

Be it resolved by the Senate of the State of Kansas, the House of Representatives concurring therein: That the Department of Social and Rehabilitation Services consider the efficacy of this proposal and, if considered favorably, report to the Governor and Legislature prior to the commencement of the 2004 legislative session the department's proposal on this subject; and

*Be it further resolved:* That the Secretary of State provide one enrolled copy of this resolution to the Secretary of Social and Rehabilitation Services and four copies to David Owen, 2113 Wayne Street, Apartment No. 1, Topeka, Kansas 66611.

#### INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Kerr introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1806-

A RESOLUTION congratulating and commending Russell Hilst.

WHEREAS, Russell "Rusty" Hilst has taught mathematics at Hutchinson High School for 37 years, has chaired the mathematics department for 25 years and is a past recipient of the Davis Foundation Educator of the Year Award; and

WHEREAS, Russell Hilst teaches calculus, honors trigonometry and honors college algebra and, when Hutchinson High School begins offering the international baccalaureate program in 2004-05 school year, will teach the higher level strand international baccalaureate mathematics courses; and

WHEREAS, Through Russell Hilst's efforts, Hutchinson High School graduates are well prepared for higher level mathematics courses in college; and

WHEREAS, Russell Hilst coached the Hutchinson High School boys golf team for 31 years; during that time his teams won two state championships, were runner-up seven years and won 22 Arkansas Valley League Titles. He is recognized for his honest and calm approach in dealing with students; and

WHEREAS, Russell Hilst, Hutchinson's ambassador of golf, has been a champion of the game for 45 years, first as a player, then as a coach and later as a fair and even-handed advisor; and

WHEREAS, Russell Hilst teed up for his first rounds of golf at age 14, swinging a set of used clubs. In 1960, he sank the winning putt for Hutchinson High School to win the state golf championship; and

WHEREAS, Russell Hilst later won seven Prairie Dunes Country Club championships and five Hutchinson city match-play championships. He holds the unofficial course record at Carey Park Golf Course with a score of 60; and

WHEREAS, Russell Hilst holds a record 26 years' association with the Kansas Golf Association. He has composed score boards and score cards, marked the course, located pin placements and answered rules questions. He has been engaged in a host of United States Golf Association and other national events across the country; he was cochair of the scoring services committee of the 2002 United States Women's Open; and

WHEREAS, Russell "Rusty" Hilst of Hutchinson has been honored as one of two Kansans inducted into the Kansas Golf Hall of Fame in 2002: Now, therefore

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend Russell Hilst for his dedication to his profession of teaching and his community and for the contributions he has made to the game of golf; and

Be it further resolved: That the Secretary of the Senate be directed to provide an enrolled copy of this resolution to Mr. Russell Hilst, 59 Meadowlark Lane, Hutchinson, KS 67566 and to Dr. Wynona Winn, Superintendent, USD 308, 1520 North Plum, Hutchinson, KS 67504.

On emergency motion of Senator Kerr SR 1806 was adopted unanimously.

President Kerr introduced and congratulated Rusty on his many accomplishments. Accompanying Rusty were Dr. Wynona Winn, Superintendent, USD 308, Hutchinson; Richard Hemman, Lori Blackeslay and Patty Kerr.

The Committee on Judiciary introduced the following Senate resolution, which was read: SENATE RESOLUTION No. 1807-

A RESOLUTION urging the United States Department of Labor to award Senior Community Service Employment Program grants to Experience Works in Kansas and throughout the country.

WHEREAS, The United States Department of Labor announced an open, competitive process for all national, private sector grants under the Senior Community Service Employment Program (SCSÉP); and

WHEREAS, Experience Works founded the program in 1965 as a small demonstration project to help older, low income farmers supplement their income and provide community service training and employment while providing important services to their local communities; and

WHEREAS, In 2002, Experience Works placed 38% of its SCSEP participants into good jobs through its program which is 190% of the 20% goal established by the United States Congress; and

WHEREAS, Experience Works has significantly improved the quality of life of its senior participants despite significant barriers to employment and has provided employment opportunities and resources in rural counties wherein such opportunities are frequently limited; and

WHEREAS, Experience Works operates in a very efficient manner by providing one of the lowest cost per participant rates and providing that \$.89 of every dollar goes directly to participants in the form of wages for community service assignments, benefits, training, support services and direct employment assistance; and

WHEREAS, Participants placed by Experience Works through this program have their earnings increased by 357% and participants provided 16 million hours of community service to over 10,000 organizations and agencies; and

WHEREAS, Every tax dollar invested in Experience Works returns roughly \$1.53 in the first year alone; and

WHEREAS, Experience Works is an organization with a proven, nationwide delivery service system, a state of the art information technology capability, a dedicated and knowledgeable staff, significant experience, an outstanding record of performance and fiscal accountability and an extensive delivery service system that demonstrates the benefits of employing the talents of our older citizens: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we urge the United States Department of Labor to award Senior Community Service Employment Grants to Experience Works in Kansas and throughout the country; and

*Be it further resolved:* That the Secretary of Senate be directed to send enrolled copies of this resolution to the President of the United States, the Secretary of the United States Department of Labor and each member of the Kansas Congressional Delegation.

On motion of Senator Oleen, the Senate recessed.

## **REPORTS OF STANDING COMMITTEES**

Committee on **Ways and Means** recommends **HB 2026**, as amended by House Committee of the Whole, be amended by substituting a new bill to be designated as "SENATE Substitute for HOUSE BILL No. 2026," as follows:

#### "SENATE Substitute for HOUSE BILL No. 2026

"AN ACT making and concerning appropriations for the fiscal year ending June 30, 2003, for the insurance department, state board of indigents' defense services, Kansas public employees retirement system, department of health and environment, department on aging, department of social and rehabilitation services, department of education and department of transportation; authorizing certain transfers and capital improvement projects, imposing certain restrictions and limitations, and directing or authorizing certain receipts and disbursements and acts incidental to the foregoing; amending K.S.A. 2002 Supp. 79-2959, 79-2964 and 79-3425i and repealing the existing sections."; and the substitute bill be passed.

Also SB 73 be amended on page 4, by striking all in line 43;

On page 5, by striking all in lines 1 through 6; by striking all in lines 14 through 21;

And by renumbering sections accordingly;

Also on page 5, in line 27, by striking "996001" and inserting "99600"; in line 34, by striking "996001" and inserting "99600"; and the bill be passed as amended.

On motion of Senator Oleen the Senate adjourned until 2:30 p.m., Tuesday, February 4, 2003.
