SENATE CHAMBER, TOPEKA, KANSAS Thursday, February 6, 2003—2:30 p.m.

SB 158, An act concerning crimes, criminal procedure and punishment; relating to moratorium of imposition of death sentences; creating a death penalty study commission and prescribing the duties thereon, by Committee on Judiciary.

SB 159, An act relating to the division of vehicles; concerning drivers' licenses and identification cards; amending K.S.A. 8-243 and 8-1329 and repealing the existing sections, by Committee on Transportation.

SB 160, An act concerning insurance; relating to uninsured motorist coverage; amending K.S.A. 40-284 and repealing the existing section, by Committee on Financial Institutions and Insurance.

SB 161, An act concerning property taxation; eliminating exemption for certain housing for elderly persons; amending K.S.A. 2002 Supp. 79-201 and 79-201b and repealing the existing sections, by Committee on Assessment and Taxation.

SB 162. An act concerning property taxation; relating to school district ad valorem tax levy and exemption therefrom; amending K.S.A. 72-6431 and K.S.A. 2002 Supp. 79-201x and repealing the existing sections, by Committee on Assessment and Taxation.

SB 163, An act relating to property taxation; prescribing limitations upon certain property tax exemptions relating to certain school district levies; amending K.S.A. 2002 Supp. 79-201a and repealing the existing section, by Committee on Assessment and Taxation.

SB 164, An act concerning nonresident pharmacies; amending K.S.A. 65-1657 and repealing the existing section, by Committee on Public Health and Welfare.

SB 165, An act concerning health benefit plans; relating to drug prescriptions, by Committee on Public Health and Welfare.

SB 166, An act concerning elections; relating to vacancies in offices; amending K.S.A. 25-3901 and repealing the existing section, by Committee on Elections and Local Government.

SB 167, An act relating to cities; relating to nuisance abatement; amending K.S.A. 12-

1617e and repealing the existing section, by Committee on Elections and Local Government. **SB 168**, An act concerning origins of life instruction by school districts; providing certain standards therefor, by Committee on Education.

Committee on Elections and Local Government recommends SB 53 be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.
