A prior participant in beauty pageants, she was Miss Kansas Teen Hostess in 1990, a semi-finalist in the Miss Scholastic Beauty Pageant in 1995 and held the title of A.G.I.F. National Queen in 1997. She plans to use her title to speak to elementary, middle and high school students

on the importance of education and to be a positive role model for others, especially members of the Latino community; and

WHEREAS, Alicia Cabrera is a 2002 Cum Laude graduate of Avila College where she is currently pursuing an MBA degree in International Business. At Avila she has received the Spirit of Avila Award, the Theater Award, Who's Who Among College Graduates, an Irene Ryan nominee and a finalist for the Avila Aniston Award. In 2001 she studied in Seville, Spain, and in 2002 in Madrid, Spain, in intensive conversational and grammatical studies in Spanish plus Spanish culture and society; and

WHEREAS, At age 19 she was diagnosed with multiple connective tissue disease. She hopes to start a charity to create more awareness of the disease and to educate others concerning this condition; and

WHEREAS, Alicia, originally from the Oakland community of Topeka where her grandmother still resides, is to be an honoree at the 2003 Hispanic Day on the Hill at the Kansas Legislature on February 28: Now, therefore,

"AN ACT concerning fire districts, fire departments and fire companies; relating to expenses incurred in response to a fire that has been determined to be arson; amending K.S.A. 2002 Supp. 12-3915, 19-3601a, 19-3612e, 19-3616, 19-3620, 21-4603d, 80-1501, 80-1514a, 80-1544, 80-1904, 80-1913, 80-1917 and 80-1921 and repealing the existing sections.";

Committee on **Federal and State Affairs** recommends **SB 230** be amended on page 4, following line 13, by inserting:

"Sec. 3. K.S.A. 74-8821 is hereby amended to read as follows: 74-8821. (a) The breakage deducted from the amounts paid to winning ticket holders for each parimutuel pool shall be computed by the organization licensee and disbursed as set forth in <del>subsections (b), (c) and (d) this section.</del> An accounting of the amount and disposition of the breakage shall be made by each organization licensee as directed by the commission. Except as otherwise provided by K.S.A. 74-8836, and amendments thereto, the breakage on minus pools shall be calculated in multiples of \$.05 rather than \$.10.

(b) All breakage proceeds from parimutuel wagering conducted by the organization licensee on live horse races conducted by the licensee shall be remitted by the licensee to the commission not later than the 15th day of the month following the race from which the breakage is derived. The commission shall remit any such proceeds received to the state treasurer in accordance with the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the Kansas horse breeding development fund created by K.S.A. 74-8829, and amendments thereto.

(c) *Except as provided by subsection (e)*, all breakage proceeds from parimutuel wagering conducted by the organization licensee on live greyhound races conducted by the licensee shall be distributed by the licensee not later than the 15th day of the month following the race from which the breakage is derived as follows:

(1) An amount equal to 50% of the breakage shall be used at racetrack facilities where derived to supplement open stakes races as approved by the commission; and

 $(2)\,$  an amount equal to 50% of the breakage shall be paid as purses directly to the breeders of Kansas-whelped greyhounds pursuant to rules and regulations of the commission.

(d) All breakage proceeds from parimutuel wagering conducted by a simulcast licensee on simulcast races displayed by the licensee shall be distributed as provided by K.S.A. 74-8836, and amendments thereto.

(e) If a racetrack facility closes or discontinues conducting races and there are undistributed breakage proceeds from parimutuel wagering conducted by the organization licensee on live greyhound races, the licensee shall distribute such proceeds to charitable organizations who apply to the organizational licensee. Such proceeds shall be distributed in accordance with the licensee's charitable distribution guidelines. Within 30 days of such distribution, the licensee shall file a report with the commission disclosing the amounts of the distributions, the names of the distributes and the date on which the distributions were made.

The provisions of this subsection shall apply to any racetrack facility conducting races on or before October 31, 2001.";
