EXPLANATION OF VOTE

MR. PRESIDENT: I vote AYE on SB 123.

Passage of this bill ensures that the Kansas correctional system focuses on drug treatment for non-violent drug possession offenders.

We know that housing offenders in a secure setting, providing room and board without treatment is expensive and ineffective. Drug offenders return to Kansas prisons at an alarming rate because they receive no treatment for their addiction. Drug addiction is a disease

To achieve any measurable level of successful rehabilitation of these drug offenders, we must implement an intensive and effective drug treatment program. We must target offenders who have the best chance of success.

Yes, it will be expensive. We must balance the costs of rehabilitation with those of building and maintaining new prisons. Every year we have a net increase in prison population. We could build another prison, and by using bonds, delay the payments; but the real cost of a new prison is the staffing, the food, and the costs that go on year after year.

My vote for **SB 123** is a vote to reduce crime by breaking the drug addiction cycle. It is a vote to avoid a tax increase for new prison construction and operation. The present system doesn't work; we must change our methods of dealing with the disease of drug addiction.—Pete Brungard

Senators Allen, Buhler, Downey, Haley, Jordan, Morris, Oleen Schodorf, Teichman and Vratil request the record to show they concur with the "Explanation of Vote" offered by Senator Brungardt on SB 123.

Mr. President: **SB 123** is well intentioned and its underlying purpose is laudable. Providing treatment for those who will benefit may, indeed, reduce crime and the cost of the penal system in Kansas.

Unfortunately, I believe **SB 123** will have the opposite of the intended effect. Fewer prosecutors will be willing to charge or amend to a level 4 crime, thereby creating a greater need for prison beds. Instead of making certain treatment will only be available to those most likely to succeed, **SB 123** provides early release to those who should enjoy the continuing comforts of the penal institution.

MR. President, because I believe **SB 123** will have the opposite of the intended effect, I vote no.—Jay Scott Emler

Senators Barone, Brownlee and O'Connor request the record to show they concur with the "Explanation of Vote" offered by Senator Emler on **SB 123**.

Mr. President: I vote yes on **SB 123.** I believe this bill to be one of the most important long term public policy issues to come before the Senate this year. This bill addresses the legitimate safety concerns of citizens and the need to help people take control of their lives by mandating mandatory treatment for nonviolent and small-possession drug offenders. Costs of dealing with repeat drug offenders continue to soar. Spending funds up front to prevent problems can significantly cut unnecessary costs later on in state-run corrections, health, education and welfare programs. Treatment and rehabilitation of these drug offenders means saving lives otherwise lost and most often keeping families together.—Greta Goodwin

Senator Hensley requests the record to show he concurs with the "Explanation of Vote" offered by Senator Goodwin on SB 123.

Mr. President: The chief aim and duty of government is to protect its citizens. Thus it was with displeasure to listen to yesterday's debate on **SB 123** for there was almost no

discussion of public safety. Rather the sum and purpose of the bill seemed to be clear—it will save us money. The unraised and unanswered question remains—will this improve public safety? Clearly, the answer is "No". Thus I can not in good conscience support **SB 123.**—TIM HUELSKAMP

Senators Brownlee, Lyon and O'Connor request the record to show they concur with the "Explanation of Vote" offered by Senator Huelskamp on **SB 123**.

MR. PRESIDENT: I support giving judges more and better options to order substance abuse treatment. I oppose using that laudable goal as justification to empty prison beds.

SB 123 is before us today because once again budget policy is driving public safety policy. Our prisons are full—but not because Kansas locks up people willy-nilly. Our incarceration rate of 318 per 100,000 residents is 34th in the country, lower than three of our adjoining states, and well below the national average of 422. Our annual rate of inmate population growth averages 3.3 percent, which ranks us 31st among the states. Only 2 of 10 Midwestern states have inmate populations growing more slowly than ours.

To address our prison space problem, we should consider all options—not leap to the conclusion that our first choice should be to incarcerate fewer offenders.

To the extent this bill makes available real and effective treatment options for substance abusers, it is good medicine for Kansas. But to the extent this bill strips judges and prosecutors of a tool to incarcerate offenders whose continued presence in communities puts persons or property at risk, it contains a poison pill Kansas need not swallow.

Accordingly, I vote no on SB 123.—DEREK SCHMIDT
