SENATE CHAMBER, TOPEKA, KANSAS Wednesday, March 19, 2003—2:30 p.m.

The Senate was called to order by President Dave Kerr.

The roll was called with thirty-nine senators present.

Senator Donovan was excused.

In recognition of Armed Forces Day, several representatives of the Armed Forces were guests of the Senate.

EXPLANATION OF VOTE

MR. PRESIDENT: I vote No on **SB 195**. Kansas has the same saddening incarceration statistic as many States. A low minority population with a disproportionately high minority prison population. The supporters offer so many excuses, or reasons, for this disparity. Inadequate education. Dysfunctional families. Limited job opportunities. Poor defense legal counsel. Substance abuse. . . . the list of excuses is endless.

Once incarcerated though, most offenders work towards release or "parole". Impressing the Parole Board, once composed of *five* members in Kansas and now, with the passage of **SB 195**, composed of only *three* members is key to parole and sometimes even an early release.

An unwritten policy in Kansas has been to always have a least one member of the Parole Board be a racial minority. It seems sort of equitable since just fewer than *half* of everyone incarcerated in Kansas *is* a racial minority at least *one* of those board members, one of those keys to release and ultimately a resumption of life, would be someone who has lived in society with a similar cultural background or with a related understanding of their world, their real world; a *true* juror of the offender's peers. . . . so to speak?

To deny one be of diverse heritage of this three member board is "borderline racism"; a term that I have never, in *Nine Years*, used.

After just so proudly pledging allegiance to our Flag, "with Liberty and Justice for All" sticks in my mind. —DAVID HALEY

INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

SENATE RESOLUTION No. 1830-

A RESOLUTION honoring all veterans from Kansas who served during the Korean War.

WHEREAS, Americans across this great nation are honoring veterans of the Korean War who served and fought so bravely 50 years ago. Various citizens of Kansas are commemorating the service of Kansans who fought in this war through organizations and committees such as the Heartland Heroes, 50th Anniversary Korean War Commemoration Committee; and

WHEREAS, Veterans of the many campaigns from this war battled some of the bloodiest and horrific combat this nation ever fought. This war, with the United States of America serving as the lead nation for the first United Nations military action, was fought from June of 1950 until July 1953. Battles raged from the moment communist forces invaded South Korea and legendary actions occurred such as the heroic delaying actions of Task Force Smith, The Inchon Landing and the Pusan Perimeter Breakout. United States led coalition forces fought from the southern tip of the Korean Peninsula to the Yalu River border with China: and

WHEREAS, Many great Kansans participated in these epic battles, and Kansas National Guard units were called to service for this war. These patriotic Kansans served with honor and valiant distinction, as epitomized by great Kansas heroes such as Master Sergeant Stanley T. Adams, United States Army, of Olathe, and Corporal Jack A. Davenport, United States Marine Corps, of Mission, who were awarded the Medal of Honor for gallant service during the Korean War; and

WHEREAS, 50th anniversary commemoration events will culminate this July, 50 years after the cease fire that ended most direct-action hostilities on the Korean Peninsula. A state of war still exists in Korea, but through the stubborn and defiant efforts of soldiers, marines, airmen and sailors—many from Kansas—the cease-fire has been observed for these 50 years. This war, often dubbed "the forgotten war" because it happened so close to the end of World War II, shall not be forgotten, nor shall the efforts and heroism of the many brave veterans from Kansas who fought, died and were wounded to further America's values and freedom for the people of South Korea: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we honor our Kansas Korean War veterans upon this 50th anniversary of the Korean War and encourage the citizens of Kansas to study, learn and honor the service of these veterans; and

Be it further resolved: That the Secretary of the Senate provide an enrolled copy of this resolution to the Heartland Heroes, 50th Anniversary Korean War Commemoration Committee, and five copies to Senator Ed Pugh.

WHEREAS, The State of Kansas recognizes the significant impact of the armed forces on the State's history and its continued economic and social contributions to the benefit of the State of Kansas; and

WHEREAS, The State of Kansas has a long and proud history of military service in time of peace and in time of war, having proudly given its sons and daughters into the service of the nation; and

WHEREAS, The State of Kansas is currently sending numerous guardsmen, reservists and active duty military personnel to support the war on terrorism through Operations Enduring Freedom and Noble Eagle; and

WHEREAS, Guardsmen, reservists and active duty personnel from Kansas are also, at the same time, supporting other operations, such as NATO peacekeeping in Bosnia-Herzegovina and Kosovo, Operations Northern and Southern Watch over Iraq, and numerous other events around the world; and

WHEREAS, Many family members of military personnel remain in Kansas where they contribute to the social, political and economic welfare of the State; and

WHEREAS, The activities of individuals and units based in the State of Kansas have brought national and international recognition to Kansas; and

WHEREAS, The various armed forces installations have a significant economic impact on the State, providing jobs and income to thousands of Kansas citizens; and

WHEREAS, The State of Kansas has established the Governor's Military Affairs Coordinating Council to facilitate statewide activities in support of the various branches of the armed forces located in Kansas; and

WHEREAS, It is in the best interest of the State to foster close and effective cooperation among the various military installations, state and local governments and the private sector to facilitate the enhancement and continued strengthening of these facilities: Now, therefore

Be it resolved by the Senate of the State of Kansas: That we express our appreciation for those serving in the armed forces of our nation by observing March 19 as Armed Forces Appreciation Day.

"New Sec. 2. (a) As used in this section:

- (1) "Excessive compensation" shall have the meaning ascribed to such term as provided in rules and regulations adopted by the state corporation commission.
- (2) "Public utility" has the meaning provided by K.S.A. 66-104, and amendments thereto.
- (3) "Compensation" has the same meaning as provided by 17 CFR 229.402, as in effect on July 1, 2003, or any later version as established in rules and regulations adopted by the state corporation commission.
- (b) No public utility providing excessive compensation to any employee shall recover the value of the excess from the utility's ratepayers.
- (c) The state corporation commission shall allow a public utility to recover from rate-payers only that employee compensation, including compensation of executives and senior management employees, which the commission finds:
 - (1) Benefits ratepayers;
- (2) is justified by the productivity, cost savings, quality of service, overall performance and financial condition of the utility;
 - (3) is reasonable compensation in comparison to regional norms in the utility industry;
 - (4) was paid within any test period, for work performed during the test period;
 - 5) will not result in unjust or unreasonable rates; and
 - (6) is otherwise not excessive compensation.
- (d) The state corporation commission shall review compensation of a public utility's employees as a part of any proceeding before the commission which may result in a change of the utility's rates. The commission shall deny recovery from ratepayers that amount of the value of any compensation which the commission finds is excessive compensation or does not meet the conditions stated in subsection (c), by excluding that amount from the utility's cost of service, or otherwise excluding it from rates. Whether shareholders have approved the compensation in question shall not be considered by the commission in determining whether compensation is excessive compensation. A public utility shall have the burden of proving that compensation of current, former and departing employees, including compensation of executives and senior management employees, is not excessive compen-

sation and that such compensation meets the conditions stated in subsection (c) before recovery of such compensation shall be allowed in rates.

- (e) A publicly traded public utility shall file a clear, concise and understandable disclosure statement on or before April 1 of each year with the state corporation commission disclosing the compensation ranges of the officers of the public utility for the preceding calendar year. The disclosure statement required to be filed under this subsection shall be open for inspection by any person in accordance with K.S.A. 45-218, and amendments thereto.
- (f) Any federal or state tax liabilities of any employee or public utility for compensation considered excessive under this section shall not reduce the amount that is to be excluded from the utility's cost of service or otherwise excluded from rates.
- (g) The provisions of this section shall apply to any proceedings pending before the state corporation commission on the effective date of this act and to all proceedings filed with the commission on or after that date.
- (h) The state corporation commission may adopt reasonable rules and regulations to implement the provisions of this section.";
