INTRODUCTION OF ORIGINAL MOTIONS AND HOUSE RESOLUTIONS

The following resolution was introduced and read by title:

HOUSE RESOLUTION No. 6007-

By Representative E. Johnson

A RESOLUTION designating July 16, 2004, as Atomic Veterans Day.

WHEREAS, Many of our veterans, including veterans who are residents of Kansas, were subjected to varying amounts of radiation because of the testing of atomic weapons in the atmosphere from 1945 until the suspension of testing in 1963. The potential harm to these veterans was unknown initially, but many were exposed to harmful doses of radiation and have suffered debilitating, degenerative diseases affecting themselves and their offspring; and

WHEREAS, Early test subjects were required to sign an oath of secrecy regarding their involvement in atomic testing preventing them from taking their medical problems resulting from radiation to the Veterans Administration. In 1996 these nuclear veterans were released from their oath of secrecy. Prior to this date the National Association of Atomic Veterans was created to locate these veterans, to honor the sacrifices they made and to help these veterans and their spouses and children in obtaining medical treatment and assistance. Many were injured as if they had been in battle but they have received no medals. As the members of this group are rapidly decreasing because of their age, it is most appropriate to recognize their sacrifices for our freedom; and

WHEREAS, By engaging in a national research and education effort for atomic war veterans, the National Association of Atomic Veterans is promoting early detection of medical problems and research and documentation of the connection between radiation exposure and resultant cancer and other debilitating, degenerative diseases and genetic mutations: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we designate July 16, 2004, the anniversary of the first atomic test, as Atomic Veterans Day and urge those veterans who participated in the United States' atmospheric and underground nuclear weapons tests, the United States' occupation of Hiroshima and Nagasaki following World War II, those who were prisoners of war in Hiroshima and Nagasaki or served in gaseous diffusion plants to contact the Kansas State Commander of the National Association of Atomic Veterans, 527 W. North Street, P.O. Box 159, Leon, KS 67074 or the Kansas Commission on Veterans Affairs, 700 S.W. Jackson, Suite 701, Topeka, KS 66613; and Be it further resolved: That the Chief Clerk of the House of Representatives provide

Be it further resolved: That the Chief Clerk of the House of Representatives provide an enrolled copy of this resolution to the Kansas State Commander of the National Association of Atomic Veterans, 527 W. North Street, P.O. Box 159, Leon, KS 67074 and the Kansas Commission on Veterans Affairs, 700 S.W. Jackson, Suite 701, Topeka, KS 66613.

HOUSE CONCURRENT RESOLUTION No. 5027-

By Committee on Insurance

- A CONCURRENT RESOLUTION urging the insurance department and commissioner of insurance to pursue creation of an interstate compact or state-based regulation of certain insurance products.
- WHEREAS, The Kansas State Legislature created the Kansas Insurance Department in 1871; and
- WHEREAS, The McCarran-Ferguson Act of 1945 granted states the continued right to regulate the insurance industry; and
- WHEREAS, Kansas consumers need financially sound and up-to-date insurance products; and
- WHEREAS, An interstate insurance compact could benefit consumers, industry and regulators by promoting uniformity in the law and speed to market while maintaining the state-based regulatory system that has been protecting American consumers for more than 150 years; and
 - WHEREAS, Insurance is a ten billion dollar a year industry in Kansas; and
- WHEREAS, Insurance companies regulated by the State of Kansas pay for that regulation through premium taxes; and
- WHEREAS, The Kansas Insurance Department is the third highest revenue producer for the state general fund; and
- WHEREAS, The Kansas Legislature strongly supports and remains committed to state regulation of the insurance industry: Now, therefore,
- Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That the Legislature strongly urges the insurance department and the commissioner of insurance to continue working toward creation of a national system of state-based insurance regulation for life and annuity products through an interstate compact.
