## HOUSE CONCURRENT RESOLUTION No. 5032—

A PROPOSITION to amend section 1 of article 11 of the constitution of the state of Kansas.

Be it resolved by the Legislature of the State of Kansas, two-thirds of the members elected (or appointed) and qualified to the House of Representatives and two-thirds of the members elected (or appointed) and qualified to the Senate concurring therein:

Section 1. The following proposition to amend the constitution of the state of Kansas shall be submitted to the qualified electors of the state for their approval or rejection: Section 1 of article 11 of the constitution of the state of Kansas is hereby amended to read as follows:

"§ 1. System of taxation; classification; exemption. (a) The provisions of this subsection shall govern the assessment and taxation of property on and after January 1, 1993, and each year thereafter. Except as otherwise hereinafter specifically provided, the legislature shall provide for a uniform and equal basis of valuation and rate of taxation of all property subject to taxation. Effective January 1, 2005, the legislature shall provide by law to prohibit valuation increases on single-family residential real property with a valuation of less than \$250,000 which is owned by and the principal place of residence of Kansas residents who are 65 years of age or older as of January 1 of the tax year. The legislature may provide by law for subsequent adjustments in the age and the valuation requirements and enact such other legislation as is necessary to administer this provision. The legislature may provide for the classification and the taxation uniformly as to class of recreational vehicles, as defined by the legislature, or may exempt such class from property taxation and impose taxes upon another basis in lieu thereof. The provisions of this subsection shall not be applicable to the taxation of motor vehicles, except as otherwise hereinafter specifically provided, mineral products, money, mortgages, notes and other evidence of debt and grain. Property shall be classified into the following classes for the purpose of assessment and assessed at the percentage of value prescribed therefor:

Class 1 shall consist of real property. Real property shall be further classified into seven subclasses. Such property shall be defined by law for the purpose of subclassification and assessed uniformly as to subclass at the following percentages of value:

(1)	Real property used for residential purposes including multi-family residential real property and real property necessary to accommodate a residential community of mobile or manufactured homes including the real property upon which such homes are located	11½%
(2)	Land devoted to agricultural use which shall be valued upon the basis of its agricultural income or agricultural productivity pursuant to section 12 of article 11 of the constitution	30%
(3)	Vacant lots	12%
(4)	Real property which is owned and operated by a not-for-profit organization not subject to federal income taxation pursuant to section 501 of the federal internal revenue code, and which is included in this subclass by law	12%
(5)	Public utility real property, except railroad real property which shall be assessed at the average rate that all other commercial and industrial property is assessed	33%
(6)	Real property used for commercial and industrial purposes and buildings and other improvements located upon land devoted to agricultural use	25%
(7)	All other urban and rural real property not otherwise specifically subclassified	30%

Class 2 shall consist of tangible personal property. Such tangible personal property shall

be further classified into six subclasses, shall be defined by law for the purpose of subclassification and assessed uniformly as to subclass at the following percentages of value:

(1)	Mobile homes used for residential purposes	$11\frac{1}{2}\%$
(2)	Mineral leasehold interests except oil leasehold interests the average daily production from which is five barrels or less, and natural gas leasehold interests the average daily production from which is 100 mcf or less, which shall be assessed at 25%	30%
(3)	Public utility tangible personal property including inventories thereof, except railroad personal property including inventories thereof, which shall be assessed at the average rate all other commercial and industrial property is assessed	33%
(4)	All categories of motor vehicles not defined and specifically valued and taxed pursuant to law enacted prior to January 1, 1985	30%
(5)	Commercial and industrial machinery and equipment which, if its economic life is seven years or more, shall be valued at its retail cost when new less seven-year straight-line depreciation, or which, if its economic life is less than seven years, shall be valued at its retail cost when new less straight-line depreciation over its economic life, except that, the value so obtained for such property, notwithstanding its economic life and as long as such property is being used, shall not be less than 20% of the retail cost when new	
	of such property	25%
(6)	All other tangible personal property not otherwise specifically classified	30%

(b) All property used exclusively for state, county, municipal, literary, educational, scientific, religious, benevolent and charitable purposes, farm machinery and equipment, merchants' and manufacturers' inventories, other than public utility inventories included in subclass (3) of class 2, livestock, and all household goods and personal effects not used for the production of income, shall be exempted from property taxation."

Sec. 2. The following statement shall be printed on the ballot with the amendment as

- "Explanatory statement. This amendment would require the legislature to prohibit valuation increases of single-family residential real property with a valuation of less than \$250,000 which is owned by and the principal place of residence of Kansas residents who are 65 years of age or older. The legislature may provide for subsequent adjustments in the age and valuation requirements and other legislation to administer this provision.
- "A vote for this proposition would require the legislature to prohibit valuation increases of single-family residential real property with a valuation of less than \$250,000 which is owned by and the principal place of residence of Kansas residents who are 65 years of age or older and allow the legislature to make subsequent adjustments in the age and valuation requirements and enact other legislation as necessary to administer this provision.
- "A vote against this proposition would maintain the current system of property taxation which provides no such prohibition."
- Sec. 3. This resolution, if approved by two-thirds of the members elected (or appointed) and qualified to the House of Representatives, and two-thirds of the members elected (or appointed) and qualified to the Senate shall be entered on the journals, together with the yeas and nays. The secretary of state shall cause this resolution to be published as provided by law and shall cause the proposed amendment to be submitted to the electors of the state at the general election to be held on November 2, 2004.

## A RESOLUTION in memory of Duane S. "Pete" McGill.

WHEREAS, Duane S. "Pete" McGill, former Speaker of the Kansas House of Representatives, passed away Sunday, December 21, 2003, at the Menorah Medical Center in Overland Park. He was 81 years of age; and

WHEREAS, Mr. McGill served in the Kansas House of Representatives from 1961 to 1976, except for 1965-1966, and was the Speaker of the House of Representatives from 1973-1976; and

WHEREAS, Mr. McGill was born in Grandview, Iowa, and attended Coe College in Cedar Rapids, Iowa. In 1940 he enlisted in the United States Army, and after serving in the Pacific theater of operations was honorably discharged in 1945. Subsequently, he completed a baccalaureate degree at Southwestern College in Winfield and attended a graduate program at the University of Kansas; and

WHEREAS, Mr. McGill owned and operated several retail businesses in Winfield prior to commencing his political career. From 1978 to 1980 he was Chairman of the Kansas Turnpike Authority and later founded his own lobbying firm, Pete McGill and Associates, which became the largest independent lobbying organization in the Midwest. He served as

a delegate to the Republican National Convention five times and was the state chairman for the presidential campaigns of Ronald Reagan and George Bush; and

WHEREAS, Mr. McGill is survived by a son, Scott McGill; a daughter, Pam Shernuk; and three grandchildren, Brianna McGill, Andrew Shernuk and Kyle Shernuk: Now, therefore.

Be it resolved by the House of Representatives of the State of Kansas: That we extend our deepest sympathy to the family and friends of Duane S. "Pete" McGill and express our appreciation of the selfless service he gave to the State of Kansas; and

WHEREAS, Marlin Fitzwater, a native of Abilene, has been chosen to receive the 2004 William Allen White national citation at the University of Kansas on February 13. He was chosen for this honor by the William Allen White Foundation's board of trustees; and

WHEREAS, From 1983 to 1992 Mr. Fitzwater served as press secretary to Presidents Reagan and Bush, the only person to be appointed by two presidents. He won praise from both the public and the news media for his honesty and good humor. It was his voice which reassured the world in times of turmoil and change; and

WHEREAS, Subsequent to his press secretary service he has been an author and lecturer, and provided political analysis and television commentary during the 1996 election campaign; and

WHEREAS, Mr. Fitzwater graduated from Abilene High School and Kansas State University. He served in the United States Air Force and was employed by the Department of Transportation, Environmental Protection Agency and the Department of the Treasury prior to becoming press secretary: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we congratulate and commend Marlin Fitzwater upon his selection to receive the 2004 William Allen White national citation; and

## SPECIAL PRESENTATION

It being the hour in accordance with **HCR 5029** to meet in joint session with the Senate for the purpose of commemorating Kansas Day, commemorating the 150th year anniversary of Kansas becoming a territory of the United States, and hearing an address by "John Brown," Reps. Freeborn, Myers and Gilbert escorted President Kerr and member of the Senate to seats in the House.

Speaker Mays introduced John Brown with the following remarks:

One hundred forty-five years after his ill-fated raid on Harper's Ferry to free the slaves, John Brown remains one of the most controversial figures in American history.

He had a varied background: tanner; surveyor; land speculator; cattle breeder; shepherd, wool dealer; farmer.

He was nomadic, living at various times in Pennsylvania, Indiana, Ohio, Massachusetts, and New York. Most Americans identify him, however, as a Kansan, although he lived in Kansas for only about 18 months. At Harper's Ferry, he identified himself as "Old Brown of Osawatomie."

Perhaps more than any other one person, John Brown represents the struggle between abolition and slavery that defined the Bleeding Kansas Territorial period and American politics of the 1850s. The odyssey of John Brown raises anew the question of the ethical responsibility of citizens when faced with questions of national morality. A better understanding of John Brown leads us to a better understanding of America in the years of turmoil preceding the great Civil War.

John Brown speaks to us this morning from his jail cell at Charleston, Virginia, on the night before his public hanging December 2, 1859.

Following the first person characterization of John Brown presented by David Matheny, Professor Emeritus of Communication at Emporia State University, Rep. Aurand presented him with a 1992 Legislative mug on which the John Brown mural is depicted commemorating its 50th anniversary. He was accompanied to the House by Marion Cott, Executive Director of the Kansas Humanities Council. Mr. Matheny now resides in Surfside, Texas.
