A RESOLUTION supporting an air transportation master plan that transforms the state transportation infrastructure into a catalyst for global business and tourism expansion.

WHEREAS, Fair Fare\$ strategies brought to the citizens of Kansas AirTran Airways, the Great Lakes/Frontier codeshare and Allegiant Air, plus affordable fares, more responsive service and a rapidly growing passenger base; and

WHEREAS, The Fair Fare\$ Plan for Kansas Air Service (Plan) stabilizes and expands the low-cost advantage at Mid-Continent Airport and extends Fair Fare\$ benefits to communities across the state; and

WHEREAS, The Plan optimizes Kansas' airfield utilization and the contributions from those airfields to the Kansas economy and to Kansans' quality of life; and

WHEREAS, The Plan developed Mid-Continent Airport, the state's largest commercial airfield, into a small hub with nonstop service to the Kansas top 20 markets, low-fare competition to all of the Kansas top 50 markets and low-cost competition maintained by AirTran Airways, Frontier Airlines, Allegiant Air and eventually Southwest Airlines; and

WHEREAS, The Plan would extend this low-cost, high service environment to communities across Kansas through realigned commuter air service, enhanced ground transportation infrastructure and collaborative market development initiatives; and

WHEREAS, The Plan would expand the Fair Fare\$ alliance of organizations in support of Fair Fare\$ to include representation by the governor, lieutenant governor, state legislature, federal officials representing Kansas, and community, business and economic development leaders across the market area: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That the House of Representatives joins in partnership with the City of Wichita in promoting our state's air

transportation infrastructure to position Kansas companies as global contenders for economic development and tourist opportunities; and

I understand that the intentional failure to file this document or intentionally filing a false document is a class A misdemeanor."

Every report or statement shall be dated and signed by: (1) The treasurer or candidate for any report required by K.S.A. 25-4148; (2) the candidate, for any report required by K.S.A. 25-4144; or (3) the chairperson of the committee, for any statement required by K.S.A. 25-4145. If the form is not available, the report or statement to which it relates shall be made as required, but in such form as the person signing such report or statement chooses, and the commission may require any such report or statement to be replaced after filing by a report or statement on the forms provided by the commission.

- (b) Records in support of every report or statement filed under the campaign finance act shall be maintained and preserved by the person who files it for a period of time to be designated by the commission.
- (c) Delay in filing a report or statement beyond the time required by law shall not prevent the acceptance of the report or statement.
- (d) No treasurer shall accept or permit to be accepted any contributions or make or permit to be made any expenditures unless all reports or statements required of such treasurer prior to the time of such contributions or expenditures have been filed.";

- A CONCURRENT RESOLUTION urging the Kansas State Board of Education to expand community service and service learning programs for increased youth volunteer service to enhance appreciation of the needs of elderly persons.

WHEREAS, Community service and service learning programs provide Kansas citizens services that strengthen our communities; and

WHEREAS, Community service and service learning programs provide Kansas students important knowledge of and involvement in serving the needs of Kansans; and

WHEREAS, The Legislature enacted K.S.A. 72-1126 which requires the State Board of Education to provide for a community service program to be offered to all accredited high schools in this state; and

WHEREAS, The community service program in Kansas is defined as a program of service performed by high school students, without monetary compensation or remuneration, for the purpose of benefitting the students' community; and

WHEREAS, The services performed under the community service program may include, but are not limited to, mentoring or tutoring elementary school pupils, assisting persons in nursing homes or adult care centers, providing lawn care or performing other tasks for senior citizens or disabled persons, assisting in homeless shelters or soup kitchens, organizing or assisting in fund raisers for disaster victims and other needy persons, assisting community-based nonprofit agencies that provide programs and services for low-income people, the disabled and the elderly, assisting fraternal organizations in charitable activities; and

WHEREAS, Research findings show that community service and service learning programs benefit students by boosting academic achievement, fostering a lifetime commitment to civic participation, improving social skills, and preparing students to enter the workforce; and

WHEREAS, By teaching young people that they can and should play a positive role in their community, community service and service learning programs encourage life-long civic participation and gives students a sense of competency; they see themselves as active contributors rather than passive recipients of adult support; and

WHEREAS, Community service and service learning programs also help address real community needs, build stronger connections between schools and communities and improve the overall school climate; and

WHEREAS, The State of Kansas has a fast growing population of elderly residents and the need for assistance and community-based services for older Kansans continues to grow; and

WHEREAS, The assistance and services provided to elderly Kansans by students through community service and service learning programs meet significant needs for such assistance and services and participation in such programs enhance the knowledge, awareness and appreciation of the needs of elderly persons in Kansas communities: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That the Kansas State Board of Education provide increased support for community service and service learning programs to enhance appreciation of the needs of elderly persons.

A CONCURRENT RESOLUTION supporting the inclusion of older job seekers as a hard-to-serve population under the Workforce Investment Act, the funding of statewide worker training and employment services from the 15% state-level set-aside reserve under that act and increased support for and expansion of existing work training and retraining services for older Kansans, including the Older Kansans Employment Program (OKEP), and urges evaluation of certain existing workforce training and retraining programs administered by the Department of Commerce to ensure that such programs meet the needs of older Kansas workers.

WHEREAS, An increasing number of older workers have been losing their jobs in recent years through no fault of their own; and

WHEREAS, Despite the positive attributes they bring to the work place, they are among the first to be laid off in downsizing or corporate restructuring and they experience longer periods of unemployment, discrimination in the hiring process and often lack access to job placement services in rural communities; and

WHEREAS, Today's older workers have a considerable education deficit compared to their younger counterparts; about half of these workers did not complete high school, and the education acquired at that time is outdated; lacking computer skills and the knowledge required for the modern job market, they require careful assessment to determine their best skills and the most suitable training or retraining programs to help them stay in the labor force or re-enter it; yet government-sponsored programs often have an age 35 cut-off for eligibility, or do not adequately address the needs of older learners; and

WHEREAS, Preparation for retirement throughout one's working life, and the transition into retirement, whether abrupt or gradual, by choice or not, are critical issues for both the individual and society; older workers who lose their jobs in their peak earning years will not be able to save enough to live well for the final third of their lives, will lose ground more rapidly in their health status, and will be less able to contribute to our communities; and

WHEREAS, The nature of work has changed rapidly over the last decade; nonstandard forms of employment, part-time, contract and seasonal jobs, self-employment, etc., often with poor security, low wages and few or no benefits, have replaced many of the full-time positions workers used to hold throughout their careers; and

WHEREAS, With inadequate income, older workers barely meet day-to-day needs, let alone invest in their future by saving for retirement and cannot replace pensions or investments depleted by changes in the stock market, mutual funds, interest rates or Individual Retirement Accounts (IRA's); and

WHEREAS, The youth-dominated society of the last few decades will dramatically change in the future; the United States Census Bureau estimates that senior citizens will

account for up to 25% of the population by the year 2031; global competitiveness dictates our attention to this demographic shift; the United States of America, and Kansas in particular, cannot expect to maintain a trained and productive work force if the needs of older workers are ignored; as a result, programs designed to continually update the work skills of older Kansans are essential for a thriving future economy; and

WHEREAS, By taking into account the long-term impact of such programs, a cohesive set of social policy reforms can help Kansas become the best possible place to live, work and grow older: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That the Legislature supports inclusion of older job seekers as a hard-to-serve population under the Workforce Investment Act and the funding of statewide worker training and employment services from the 15% state-level set-aside reserve; and

Be it further resolved: That the Legislature supports a requirement that a portion of Workforce Investment Act funding be retained from the 15% state-level set-aside reserve from the Workforce Investment Act discretionary fund in the amount of \$200,000, and use of such moneys be utilized to provide additional opportunities for the development and funding of special services for older workers; and

Be it further resolved: That the Legislature supports increased financial support for job training and retraining programs designed to serve older Kansans including the Older Kansans Employment Program (OKEP); and

Be it further resolved: That the Legislature urges evaluation of existing workforce training and retraining programs administered by the Department of Commerce, including, but not limited to the Kansas Industrial Training (KIT) and Kansas Industrial Retraining (KIR) programs and the State of Kansas Investment in Lifelong Learning (SKILL) projects, to ensure that such programs are adequately designed and properly administered to meet the needs of older Kansas workers.
