Committee on **Appropriations** recommends **SB 312**, be amended on page 1, in line 22, by striking "1.0%" and inserting ".80%"; in line 24, following the stricken material, by inserting "for calendar year 2004, and each calendar year thereafter,"; in line 32, following the stricken material, by inserting "beginning with calendar year 2002 and each calendar year thereafter,"; preceding line 40, by inserting new material to read as follows:

- "(c) For the purposes of maintaining the fire service training program of the university of Kansas and the payment of the expenses incident thereto, each fire insurance company doing business in this state shall pay to the commissioner of insurance, on or before March 15 each year, beginning with calendar year 2004, and each calendar year thereafter, in addition to the taxes, fees and charges now required by law to be paid by it, such levy as may be made by the Kansas fire service training commission. The levy shall not be more than .20% of a sum equal to the gross cash receipts as premiums of such company on all fire business transacted by it in the state of Kansas during the calendar year next preceding, as shown by its annual statement under oath to the state insurance department.
- (d) The director of the fire service training program of the university of Kansas shall submit a report concerning expenditures and activities of the fire service training program of the university of Kansas to the house committee on appropriations on or before February 1, 2005, and each ensuing year thereafter.

Sec. 2. K.S.A. 2003 Supp. 75-1514 is hereby amended to read as follows: 75-1514. (a) The commissioner of insurance shall remit all moneys received by the commissioner under subsection (a) of K.S.A. 75-1508, and amendments thereto, to the state treasurer in

accordance with the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the fire marshal fee fund for the fiscal years ending June 30, 2003, and June 30, 2004, and the state treasurer shall credit 20% of each such deposit to the state general fund and shall credit the remainder of each such deposit to the fire marshal fee fund for the fiscal year ending June 30, 2005, and ensuing fiscal years.

- (b) There is hereby created the fire marshal fee fund in the state treasury. All expenditures from the fire marshal fee fund shall be made in accordance with appropriations acts upon warrants of the director of accounts and reports issued pursuant to vouchers approved by the state fire marshal or a person or persons designated by the state fire marshal.
- (c) The commissioner of insurance shall remit all moneys received by the commissioner under subsection (b) of K.S.A. 75-1508, and amendments thereto, to the state treasurer in accordance with the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the emergency medical services board operating fund.
- (d) The commissioner of insurance shall remit all moneys received by the commissioner under subsection (c) of K.S.A. 75-1508, and amendments thereto, to the state treasurer in accordance with the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the fire service training program fund.";

By renumbering the remaining sections accordingly;

Select Committee on Kansas Security recommends HB 2489 be amended on page 2, in line 12, by striking all following "to"; in line 13, by striking all preceding the comma and inserting "security measures"; by striking all in lines 15 and 16 and inserting "such security measures, that protect: (A) Systems, facilities or equipment used in the production, transmission or distribution of energy, water or communications services; (B) transportation and sewer or wastewater treatment systems, facilities or equipment; (C) a public body or agency, public building or facility or the information system of a public body or agency; or (D) private property or persons, if the matter is submitted to the agency for purposes of this paragraph. For purposes of this paragraph, security means measures that protect against criminal acts intended to intimidate or coerce the civilian population, influence government policy by intimidation or coercion or to affect the operation of government by disruption of public services, mass destruction, assassination or kidnapping. Security measures include, but are not limited to, intelligence information, tactical plans, resource deployment, responses to actual events and vulnerability assessments; and"; in line 18, by striking the semicolon; by striking all in lines 19 through 28; in line 29, by striking all preceding the period; and the bill be passed as amended.

Select Committee on Kansas Security recommends HB 2490 be amended on page 6, in line 7, following "Records" by inserting ", other than criminal investigation records,"; in line 10, by striking "or" where it appears preceding "(B)"; also in line 10, following "(B)" by inserting "transportation and"; in line 11, following "equipment" by inserting "; or (C) private property or persons, if the records are submitted to the agency for purposes of this paragraph"; in line 16, following the period, by inserting "Security measures include, but are not limited to, intelligence information, tactical plans, resource deployment, responses to actual events and vulnerability assessments."; by striking all in lines 22 through 33; and the bill be passed as amended.

"AN ACT concerning bioscience; creating a Kansas bioscience authority and providing for the powers and duties thereof; providing for bioscience development and funding; amending K.S.A. 12-1771 and 12-1772 and K.S.A. 2003 Supp. 12-1770a, 74-8017 and 74-8905 and repealing the existing sections."; and the substitute bill be passed.

(Sub. HB 2647 was thereupon introduced and read by title.)

Committee on Federal and State Affairs recommends HB 2751 be passed.

Committee on **Health and Human Services** recommends $HB\ 2698$ be amended by substituting a new bill to be designated as "Substitute for HOUSE BILL No. 2698," as follows:

"Substitute for HOUSE BILL No. 2698 By Committee on Health and Human Services

"AN ACT providing for the regulation and licensing of radiologic technologists and X-ray operators; establishing a registry of X-ray operators; granting powers and duties of the state board of healing arts; establishing a radiologic technology council and providing for the functions thereof; declaring unlawful acts and penalties."; and the substitute bill be passed.
