HALL OF THE HOUSE OF REPRESENTATIVES, TOPEKA, KS, Friday, February 27, 2004, 9:30 a.m.

INTRODUCTION OF GUESTS

Mr. Ensley has fished and hunted on four continents. Rep. Ballou presented him with a framed certificate. Mr. Ensley addressed a few remarks to the members of the House.

MOTIONS AND RESOLUTIONS OFFERED ON A PREVIOUS DAY

On motion of Rep. McKinney, **HR 6024**, A resolution celebrating the 50th anniversary of the United States Supreme Court's decision in *Brown v. Board of Education*, was adopted. On behalf of Reps. Mays and Lane, Rep. McKinney introduced Frank Kirtdoll, Fred Sanders, Sonny Scroggins and Marquis Burnett, and there being no objection, the following remarks of Rep. McKinney are spread upon the Journal:

Speaker Mays and I felt privileged to be cosponsors of **HR 6024**. We felt it was important symbolically to sponsor it as leaders on both sides of the aisle. As the Speaker pointed out when we celebrated George Washington Carver Day, black history month is in no way shape or form a partisan issue.

We have with us today leaders from the Topeka community who are helping with the celebration of the 50th anniversary of the Brown decision. We have Frank Kirtdoll and Fred Sanders of the Monroe Neighborhood Improvement Association which is organizing the opening of the Monroe National Historic Site. Sonny Scroggins is here in the character of James Whitfield Ross, a Kansan who escaped slavery seven times, later joined the 1st Kansas Colored Infantry Regiment, and then worked as a mason on the construction of the Capitol. In his infantry uniform he also draws attention to the hope that the Speaker and I both have the 1st Kansas Colored Infantry will some day soon be commemorated in the murals on the Capitol walls. This regiment was the first African-American regiment to be organized, to see action, and to take casualties in the Civil War. Also here is Marquis Burnett, son of McKinley Burnett who was one of the primary organizers in the Brown vs. Topeka Board of Education case.

As a Kansan I am proud of the heritage of our state. Frequently Kansans have been on the cutting edge of major changes in our nation. The walls of the House Chamber carry the names of those active in the Bleeding Kansas era. Our ancestors were at the forefront in establishing a strong system of public schools, of the populist era, and the progressive era which was led by people such as William Allen White and Arthur Capper. And a hundred years after the era of Bleeding Kansas we moved to the front of the civil rights movement with the Brown vs. Topeka Board of Education case. In each of these movements the people of Kansas endured a brief but sometimes bitter struggle which brought us closer to providing for every one the equal protection of the laws.

In the Old Supreme Court Room there is a seal of justice which is quite unique in that the scales of justice are held by an arm extended from heaven. This symbolizes the idea that justice is a divine concept, not a human concept. Justice is something that the Good Lord expects us to establish. In each of these movements, the people of Kansas have moved

us closer to that ideal that "all men are created equal, that they are endowed by their creator with certain unalienable rights, that among these are life, liberty, and the pursuit of happiness."

MR. Speaker: Regarding ${\bf Sub.}$ HB 2583 we are told that neither side (the neighboring land owners or the trail developers) likes this legislation.

We understand that County Governments potentially significantly affected by this legislation were scarcely aware of this legislation and were not involved in deliberations at the committee level.

We believe there is no urgency of time in this matter and that progress is being made outside of the legislative arena in addressing these issues.
