# INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Barnett introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1822—

A RESOLUTION congratulating and commending Teresa Walters.

WHEREAS, Teresa Walters, an Emporian, has been chosen to receive the KiKi Camarena Honorable Mention National Award from the National Family Partnership, a leading organization supporting America's families by promoting healthy, drug-free youth through prevention and education. She was chosen for this honor by the National Family Partnership Award Committee; and

WHEREAS, Since 1998 Mrs. Walters has served as the Executive Director of the Emporians for Drug Awareness, Inc. and is considered a leader in the field of drug prevention in the state of Kansas. As a result of her involvement, Emporians for Drug Awareness was the first recipient of a Drug-Free Communities Grant in the state of Kansas; and

WHEREAS, Mrs. Walters has worked to educate numerous individuals across Kansas about fetal alcohol syndrome and its relationship to mental retardation in children, and she applied and received funds to establish the first fetal alcohol syndrome diagnostic clinic in Emporia; and

WHEREAS, Mrs. Walters initiated P.R.O.U.D. (Public Officials Opposed to Underage Drinking) and as a result, alcohol use among youth has decreased. She also obtained a grant from the Kansas Department of Transportation and cooperated with the Emporia Police Department on underage drinking enforcement and DUI checkpoints. She also co-chaired the Kansas Leadership to Keep Children Alcohol Free; and

WHEREAS, Teresa Walters has achieved numerous "firsts" in her community, not only by developing new programs but also being able to find the funds to support them. She is a positive role model in her community and for the great state of Kansas: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend Teresa Walters for her involvement in reducing drug and alcohol abuse in her community; and

Be it further resolved: That the Secretary of the Senate provide an enrolled copy of this resolution to Mrs. Teresa Walters, 2850 Rio Vista Drive, Emporia, KS 66801.

On emergency motion of Senator Barnett SR 1822 was adopted unanimously.

Senator Barnett and members of the Senate congratulated Teresa Walters on her many accomplishments with a standing ovation. Accompanying Teresa were her husband, Francis Walters; Margi Grimwood; Michelle Voth; Dan Mauer; Marie Torrez-Anderson and Pete Bodyk.

#### REPORTS OF STANDING COMMITTEES

Committee on **Education** recommends **SB 293**, as amended by Senate Committee, be amended as recommended by the Committee on Education and the bill be passed as amended.

Also, **SB 540** be amended on page 1, in line 13, by striking "July 1, 2005" and inserting "January 1, 2006"; by striking all in lines 15 through 20 and inserting:

- "(1) Print on a person's identification card, such person's social security number or an identification number or code which contains three or more of the same digits, in the same sequence, in such person's social security number.
- (2) Make available by the reading of the magnetic strip or other encoded information on a person's identification card, such person's social security number or an identification number or code which contains three or more of the same digits, in the same sequence, in such person's social security number.
  - (b) As used in this section:
- (1) "Person" means an employee of or a student enrolled at a postsecondary educational institution.
  - (2) "Postsecondary educational institution";

In the title, in line 10, by striking "student or employee's" and inserting "the use of"; and the bill be passed as amended.

Committee on Federal and State Affairs recommends SB 400 be passed.

Also, the following appointment was referred to and considered by the committee and your committee recommends that the Senate approve and consent to such appointment:

Committee on **Judiciary** recommends **HB 2154** be amended on page 1, in line 14, by striking "a contract or" and inserting "an"; in line 16, by striking "railroad right of"; in line 17, by striking "entry,"; also in line 17, by striking ", appliance"; in line 19, by striking "under a construction contract"; and inserting ", except that no deed, lease, easement, license or other instrument granting an interest in or the right to possess property shall be deemed to be a construction contract even if the instrument includes the right to design, construct, alter, renovate, repair or maintain improvements on such real property"; in line 26, after "or" by inserting "other agreement, including, but not limited to, a right of entry,"; in line 27, after "contract" by inserting a comma; after line 29, by inserting the following:

"(c) This act shall not be construed to affect or impair the contractual obligation of a contractor or owner to provide railroad protective insurance or general liability insurance.";

And by relettering the remaining subsection accordingly; and the bill be passed as amended;

Committee on Ways and Means recommends SB 320 be amended on page 2, after line 8, by inserting the following:

(b) A grandparent shall not be eligible to participate in the grandparents as foster parents program if the parent or parents of the grandchild reside with the grandparents.";
Also on page 2, in line 9, by striking "(b)" and inserting "(c)"; and the bill be passed as

amended.

"Sec. 22. K.S.A. 2003 Supp. 75-52,129 is hereby amended to read as follows: 75-52,129. (a) The secretary of corrections is hereby authorized to negotiate and enter into contracts with Kansas cities and counties for the placement of inmates, who are classified as medium custody or any higher custody or security classification, in facilities owned and operated by the cities and counties. If the secretary of corrections proposes to place any inmates classified as medium custody or any higher custody classification for confinement in facilities other than correctional or other institutions or facilities owned and operated by the department of corrections or any other state agency, the secretary of corrections shall give first consideration to entering into contracts with Kansas cities and counties under this section before attempting to place any such inmate for confinement at any private contract prison, as defined in section 2, and amendments thereto, or any location outside the state of Kansas if the facilities to be provided under such contracts are substantially equal to private contract prisons or facilities at locations outside the state of Kansas and if arrangements can be made in a timely manner. Except as provided in subsection (b), the provisions of this section and any contract or preliminary letter of commitment entered into pursuant to this section shall not apply to any minimum custody or community custody status inmates, or any other custody or security classification lower than medium custody, or to any inmate who may be placed in a work release or prerelease program, center or facility by the secretary of corrections, who is eligible for parole or who is placed pursuant to the interstate corrections

compact. Contracts entered into pursuant to this section shall not be subject to competitive bid requirements under K.S.A. 75-3739 and amendments thereto.

(b) The secretary shall not enter into any contract as provided in subsection (a) with any city or county of this state for the placement of inmates that does not provide that such city or county shall provide and maintain appropriate and recognized standards of safety, health and security.

Sec. 23. K.S.A. 2003 Supp. 75-52,129 is hereby repealed.";
