HOUSE CONCURRENT RESOLUTION No. 5005-

By Committee on Agriculture

A CONCURRENT RESOLUTION urging the United States Department of Agriculture to delay the lifting of the United States ban on cattle imports from Canada.

WHEREAS, Most export markets for United States beef were closed on Christmas Day, 2003 after one cow out of our nation's more than 96 million head of cattle tested positive for BSE; and

WHEREAS, That cow was a dairy cow imported from Canada; and

WHEREAS, Within 24 hours of that discovery 58 countries closed their border to American beef; and

WHEREAS, The shutdown of exports of approximately 2.58 billion pounds of American beef to these foreign markets has cost the U.S. economy more than an estimated \$3.3 billion a year; and

WHEREAS, The United States government and beef industry officials have worked mightily to reassure consumers and government officials throughout the world of the safety and wholesomeness of American beef; and

WHEREAS, Consequently, markets are beginning to reopen but much work remains to be done as most markets are still closed to American beef producers; and

WHEREAS, In January of 2005, two more cases of BSE have been found in Canada and an American governmental technical team has been sent to Canada to conduct investigation and analysis; and

WHEREAS, The USDA plan to lift the ban on importation of Canadian cattle into the United States may increase health risks in the United States and may have a negative long-term economic impact; and

WHEREAS, Lifting of the ban on importation of Canadian beef at this critical time in our nation's sensitive negotiations to open up other nations' markets to American beef will make it much harder to persuade those nations to start accepting American beef imports: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas, the Senate concurring therein: That we urge the United States Department of Agriculture to delay the lifting of the ban on importation of Canadian beef until the enhanced investigation and surveillance for BSE has been completed in Canada and until the American beef industry has fully recovered its lost worldwide market share occurring since 2003; and

Be it further resolved: That the Secretary of State is directed to send enrolled copies of this resolution to the President of the United States and the Secretary of the United States Department of Agriculture.

HOUSE CONCURRENT RESOLUTION No. 5006—

By Committee on Governmental Organization and Elections

A PROPOSITION to amend article 15 of the constitution of the state of Kansas by adding a new section thereto, concerning open government.

Be it resolved by the Legislature of the State of Kansas, two-thirds of the members elected (or appointed) and qualified to the House of Representatives and two-thirds of the members elected (or appointed) and qualified to the Senate concurring therein:

Section 1. The following proposition to amend the constitution of the state of Kansas shall be submitted to the qualified electors of the state for their approval or rejection: Article 15 of the constitution of the state of Kansas is amended by adding a new section thereto to read as follows:

- "§ 16. Open government. (a) Every person has the right to inspect and to receive, upon payment of an amount not to exceed the actual cost of duplication, a copy of any public record and to observe, following a reasonable attempt to provide adequate meeting accommodations, the deliberation of any public body or agency of state government or its subdivision, except in cases in which the demand of privacy clearly exceeds the merits of public disclosure.
- (b) A statute, court rule or other authority, including those in effect on the effective date of this act, shall be broadly construed if it furthers the people's right of access and narrowly construed if it limits the right of access.

- (c) All current state laws and court rules that are in effect on the enacting date of this measure wherein public access to records or meetings is limited shall remain in force until they are repealed.
- (d) The legislature may provide by general law, passed by an affirmative vote of twothirds of all the members elected (or appointed) and qualified in each house, exception of meetings and of records from the requirements set forth herein provided that such law shall state with specificity the public necessity justifying the exemption and shall be no broader than necessary to accomplish the stated purpose of the law."

Sec. 2. The following statement shall be printed on the ballot with the amendment as a whole:

"Explanatory statement. This amendment (1) would provide that people have a constitutional right of access to information concerning the conduct of the people's business through access to public documents and access to deliberations of any public body, political subdivision or agency of the state government except in cases in which the demand for privacy or public necessity exceeds the need for public disclosure, (2) would provide for broad construction of statutes, court rules and other authority to further the people's right of access and (3) would provide that general laws providing new exceptions to public access be passed by a two-thirds vote of each house of the legislature.

- "A vote for this proposition would establish a constitutional right of access to public documents and deliberations of public bodies, political subdivisions or agencies of the state government with limited exceptions provided.
- "A vote against this proposition would not establish such constitutional right of access."

Sec. 3. This resolution, if approved by two-thirds of the members elected (or appointed) and qualified to the House of Representatives, and two-thirds of the members elected (or appointed) and qualified to the Senate shall be entered on the journals, together with the yeas and nays. The secretary of state shall cause this resolution to be published as provided by law and shall cause the proposed amendment to be submitted to the electors of the state at the general election in November of the year 2006 unless a special election is called at a sooner date by concurrent resolution of the legislature, in which case it shall be submitted to the electors of the state at the special election.
