SENATE CHAMBER, TOPEKA, KANSAS Friday, February 18, 2005—9:30 a.m.

## INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Hensley introduced the following Senate resolution, which was read:

#### SENATE RESOLUTION No. 1822—

A RESOLUTION expressing our appreciation of cub scouting upon its  $75 \mathrm{th}$  anniversary.

WHEREAS, Cub scouting is celebrating its 75th anniversary with a theme of "75 Years of Fun, Family and Friends"; and

WHEREAS, Since 1930 cub scouting has served more than 57 million boys; and

WHEREAS, One hundred three organizations in the Jayhawk Area Council use the cub scout program as a part of their youth work; and

WHEREAS, The success of the home-centered cub scout program has depended on the dedicated leadership of 16 million volunteers since 1930; and

WHEREAS, Cub scouting offers an effective program for the character, citizenship and personal fitness training of boys who are in the first through fifth grade or are 7, 8, 9 or 10 years of age: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That the year 2005 is designated as a time of celebration for the 4,213 boys and volunteer leaders who now participate in cub scouting in the Jayhawk Area Council; and

Be it further resolved: That the appreciation of all of our citizens is extended to those who make it possible for boys to take part in the educational cub scout program.

On emergency motion of Senator Hensley SR 1822 was adopted unanimously.

President Morris and members of the Senate showed their appreciation with a standing ovation in honor of the Cub Scouts "75th" Anniversary. Those present were Paul Bures and Cubs representing Pack 11, Christ the King Church; Jessica Grafton and Cubs representing Pack 500, Williams Magnet Center and Kyle Ellerbeck, Shawnee District Director, JAC, BSA

Accompanying the Cub Scouts were mascots, Baloo the Bear and Akela, the Wolf.

#### REPORTS OF STANDING COMMITTEES

Committee on **Education** recommends **SB 244** be amended on page 2, in line 39, following "district" by inserting "finance";

On page 3, in line 38, by striking "committee" and inserting "commission"; also in line 38, by striking "council" and inserting "commission"; in line 40, by striking "council" and inserting "commission"; in line 41, by striking "legislature" and inserting "legislative coordinating council"; and the bill be passed as amended.

Committee on **Elections and Local Government** recommends **SB 54** be amended on page 1, in line 12, by striking all after "1."; by striking all in lines 13 through 43;

On page 2, by striking all in lines 1 through 3 and inserting:

"(a) From and after July 1, 2006, any provision of a restrictive covenant that requires the use of any particular roofing material in the construction or replacement of the roof which also does not require a roofing material that meets or exceeds class C fire resistant standards is hereby declared to be contrary to the public policy of this state and unenforceable.

- (b) For the purposes of this section, a roofing material shall be deemed to comply with the requirements of subsection (a) if the roofing material has been tested in accordance with one of the following documents as such document exists on July 1, 2005, and found to be in compliance with the class C fire resistant standards contained therein:
- (1) United Laboratories Standard 790 (UL 790) entitled "Standard Test Methods for Fire Tests of Roof Coverings";
- (2) ASTM E108 entitled "Standard Test Methods for Fire Tests of Roof Coverings"; or
- (3) ASTM D2898 entitled "Standard Test Methods for Accelerated Weathering of Fire-Retardant-Treated Wood for Fire Testing".;

Also on page 2, by renumbering the remaining section accordingly;

and the bill be passed as amended.

Committee on **Ways and Means** recommends **SB 225** be amended on page 3, in line 43, by striking "\$0.00" and inserting "\$95.40";

On page 6, by striking all in lines 7 through 9 and inserting the following:
