A constitutional majority having failed to vote in favor of the bill, SB 117 did not pass.

#### EXPLANATION OF VOTE

MR. PRESIDENT: I vote yes on **SB 117**. This honors those victims of sexual abuse who deserve to know where their perpetrators are locating when they are released from prison.

We also owe this to our school children as a safety measure. Perpetrators are locating within several feet of our schools and **SB 117** would mandate notification in an effort to protect our children from becoming victims of sexual abuse. — Karin Brownlee

Senators Bruce, Gilstrap, Goodwin, Jordan, O'Connor, V. Schmidt, Umbarger and Vratil request the record to show they concur with the "Explanation of Vote" offered by Senator Brownlee.

MR PRESIDENT: This is perhaps the most difficult and politically dangerous vote I have cast during my tenure in this honored body. I must first qualify this no vote by saying I support the current law. I support the provisions of this bill requiring notice to schools and daycare. The retroactivity to 24 years ago is a fundamental change in public policy. Now many convicted of minor crimes after 1979 such as adultery, patronizing a prostitute, or lewd behavior are required to register for life. They will now be subject to felony prosecution if they fail to register. There is no requirement to give notice of this new duty to register. We only require regulations be propounded. There is no funding, there is no estimate of the cost, there is only the desire to place this scarlet letter. It is not clear whether expungement would relieve the defendant of the duty to register. Many of the offenses required to be registered now cannot be expunged. Many are able to be expunged and the requirement that they register nullifies the public policy behind expungement. Law enforcement opposes this Bill. — PHILLIP B. JOURNEY
