The House met pursuant to adjournment with Speaker Mays in the chair.

The roll was called with 122 members present.

Reps. Kiegerl and Showalter were excused on verified illness.

Rep. Goico was excused on legislative business.

On motion of Rep. Aurand, the House resolved into Committee of the Whole, with Rep. Hayzlett in the chair.

#### COMMITTEE OF THE WHOLE

On motion of Rep. Hayzlett, Committee of the Whole report, as follows, was adopted: Recommended that **HB 2005** be passed.

On motion of Rep. Landwehr, **HB 2004** be amended on page 1, in line 30, by subtracting \$50,000 from the dollar amount which reads "\$200,000" and by adjusting the dollar amount in line 30 which reads "\$200,000" accordingly;

Also on page 1, following line 30, by inserting the following material: "Young Kansans — safe kids program

Also on page 1, following line 37, by inserting the following material:

"(c) On July 1, 2005, or as soon thereafter as moneys are available, the director of accounts and reports shall transfer \$250,000 from the social welfare fund of the department of social and rehabilitation services to the state general fund for the purpose of financing the young Kansans — safe kids program of the attorney general.";

Also on page 1, in the title, in line 10, after "attorney general" by inserting "and the department of social and rehabilitation services";

Also, on motion of Rep. Schwab to amend HB 2004, the motion was withdrawn.

Also, on motion of Rep. Kirk to amend HB 2004, the motion did not prevail.

Also, on motion of Rep. Crow, **HB 2004** be amended on page 1, in line 38, by inserting: "Sec. 3. For fiscal year 2006, the requirement in K.S.A. 46-3001, that a member of the committee from the house of representatives shall be a member of the committee on insurance is waived.":

Also, on motion of Rep. Lane to amend HB 2004, the motion was withdrawn.

Also, on motion of Rep. Kelley, **HB 2004** be amended on page 1, in line 16, after "ending" by inserting "June 30, 2005, and"; following line 37, by inserting the following material:

"Sec. 3. On the effective date of this act, section 83 of 2005 Senate Substitute for House Bill No. 2482 is hereby amended to read as follows: Sec. 83. (a) On and after the effective date of this act, during the fiscal year ending June 30, 2005, and during the fiscal year ending June 30, 2006, no expenditures shall be made by any state agency from any moneys appropriated for any state agency from the state general fund or any special revenue fund for fiscal year 2005 and or fiscal year 2006 by chapter 123 or 184 of the 2004 Session Laws of Kansas or by 2005 Senate Bill No. 225 or by this or other appropriation act 2005 Senate Substitute for House Bill No. 2482 of the 2005 regular session of the legislature, or by this or other appropriation or other act of the special session of 2005 of the legislature for media advertising by any state agency of the state of Kansas unless such media advertising includes a disclosure the specific statement that such media advertising is funded, in whole or in part, by state taxpayer dollars, as the case may be and includes the following specific statement: "Paid for by your Kansas tax dollars". The specific statement shall be included so that the specific statement is easily seen and read or can be easily heard, in the case of media advertising utilizing audible broadcast media.

- (b) As used in this section "state agency" has the meaning ascribed thereto by K.S.A. 75-3701 and amendments thereto; and "media advertising" includes all forms of (1) advertising that are expressed or otherwise communicated, in any fashion, utilizing or otherwise through the use of (A) billboards, newspapers, advertisements, handbills, mailings or any other printed materials, or (B) television, radio, internet or any other broadcast media or technology; or, (2) promotional activities, products or other items that are provided with or through the use of any product or item including any pencil, pen, beverage container, tote or other carry bag, poster, map, or other gift or giveaway item.
- (c) The provisions of this section shall be broadly construed, applied and administered to be as inclusive as possible. The provisions of this section shall not apply to any media advertising that has been printed or manufactured prior to July 1, 2005.

Sec. 4. On the effective date of this act, section 83 of 2005 Senate Substitute for House Bill No. 2482 is hereby repealed.";

And by renumbering sections accordingly;

On page 1, in the title, in line 9, after "ending" by inserting "June 30, 2005, and"; in line 10, striking "the attorney general" and inserting "state agencies"; in line 13, before the period by inserting "; amending section 83 of 2005 Senate Substitute for House Bill No. 2482 and repealing the existing section";

Also, on motion of Rep. DeCastro, **HB 2004** be amended on page 1, in line 38, by inserting:

"Sec. 3. For fiscal year 2006, the requirement in K.S.A. 46-3001, that a member of the Children's Issues Committee from the house of representatives shall be a member of the appropriation committee is waived."; and **HB 2004** be passed as amended.
