MR. SPEAKER: Daily, there are reports of businesses leaving Missouri and relocating in Kansas along with their jobs. Apparently, there is incentive enough for out-of-state businesses to locate in Kansas. **HB 2619** provides more incentives at an unacceptable cost. The

burden again falls on the homeowner, who is the only one who cannot pass it on. Taxes on income producing enterprises should give relief to the homeowner. This bill reverses that. Please take care of those who sent you here. I vote NO on **HB 2619.**—MICHAEL J. PETERSON

Committee on **Environment** recommends **HB 2716** be amended on page 1, in line 23, by striking all after "at"; by striking all in lines 24 through 33; in line 34, by striking all before the period and inserting "the east half of the southeast quarter of the southwest quarter of Section 31, Township 11 South, Range 24 East, the east half of the northeast quarter of the southwest quarter of Section 31, Township 11 South, Range 24 East, and the southeast quarter of Section 31, Township 11 South, Range 24 East. Less that part of the above described tract lying northerly of the northerly high bank of the Kansas River and less that part of such tract lying southerly of the southerly high bank of the Kansas River";

On page 2, after line 1, by inserting the following:

"(d) Water district no. 1 of Johnson county Kansas, shall assume full responsibility for any costs arising under this act."; and the bill be passed as amended.

Committee on **Environment** recommends **HB 2757** be amended on page 1, in line 13, after "landowners" by inserting "or the representatives of such landowners"; and the bill be passed as amended.

Committee on **Governmental Organization and Elections** recommends **HB 2667** be amended on page 2, in line 38, by striking "through 14" and inserting "and 4"; and the bill be passed as amended.

Committee on Governmental Organization and Elections recommends HB 2809 be amended on page 1, in line 15, by striking all following "commission"; in line 16, by striking all preceding the period and inserting "appointed pursuant to section 2, and amendments thereto"; in line 17, by striking "Tribune, Kansas" and inserting "any city located in Greeley county"; in line 20, by striking "Two members" and inserting "One member shall be appointed by the governing body of the city of Tribune, one member"; in line 21, following "city" by inserting "of Horace"; in line 24, by striking "city" and inserting "cities";

On page 2, in line 38, following the "(e)" by inserting "(1)"; in line 39, by striking "an election called and held thereon" and inserting "the next regular general election held in November of an even-numbered year. If the statutorily mandated duties of an elective office are to be eliminated or if the office is to be eliminated and the duties transferred to a nonelective office, the question of elimination of such duties or office shall be submitted to the voters as a separate ballot question"; in line 41, by striking "bond" and inserting "election".

On page 3, preceding line 10, by inserting the following:

"(2) Any proposed unification which eliminates an elective office shall provide that the elimination of such office shall become effective upon the date of normal expiration of the term of such office.

(3) If the final plan provides for the unification of the city of Horace with the county or the unification or elimination of any of the offices or powers, duties and functions of such offices of the city of Horace and a majority of the qualified electors of the city of Horace voting on the plan do not vote in favor thereof, the city of Horace and officers thereof shall continue in existence and operation as if no unification had occurred.

(4)":

On page 5, in line 3, by striking "All" and inserting "(A) Except as provided by paragraph (B), all"; in line 6, by striking the period and inserting "; or

(B) all the territory of the county located within the incorporated areas of the county, for the purpose of exercising the powers, duties and functions of a city. The provisions of this paragraph shall apply only if the final plan provides for the unification of the city of Horace with the county and a majority of the qualified electors of the county and a majority of the qualified electors of the city of Horace voting on the plan vote in favor thereof."; and the bill be passed as amended.

Committee on **Health and Human Services** recommends **HB 2497** be amended on page 1, in line 17, after "who" by inserting ", in this state or in other states or the federal government"; in line 23, after the first "act" by inserting "or a conviction of conspiracy under K.S.A. 21-3302, and amendments thereto, to commit such act, or similar statutes of other states or the federal government"; in line 30, after the comma by inserting "or similar statutes of other states or the federal government,"; in line 34, by striking "validated" and inserting "determined by a finding";

On page 2, in line 11, by striking "2004 Supp."; in line 20, after "information" by inserting "including, but not limited to, diversion agreements,"; in line 26, after "records" by inserting "and may require submission of fingerprints for identification purposes and"; in line 35, by striking "validated" and inserting "determined to be a finding"; in line 42, by striking "in writ-"; in line 43, by striking "ing"; also in line 43, by striking "to the secretary";

On page 3, in line 15, by striking "in writing"; and the bill be passed as amended.

Committee on Insurance recommends HB 2693 be passed.

Committee on Judiciary recommends HB 2616 be passed.

Committee on **Judiciary** recommends **HB 2617** be amended on page 1, in line 25, by striking "or" and inserting a comma; in line 26, after "vision" by inserting "or at any other time during the criminal case"; in line 31, after "or" by inserting "or"; in line 33, by striking all after "thereto"; by striking all in line 34; in line 35, by striking all before the period; and the bill be passed as amended.
