INTRODUCTION OF GUESTS

In recognition of Armed Forces Appreciation Day, Rep. Merrick introduced Adj. Gen. Todd Bunting of the Kansas National Guard, who addressed a few remarks to the members of the House.

Rep. Craft introduced Brig. Gen. Dana Pittard, Fort Riley, who addressed the following remarks to the members of the House:

It is an honor to represent Fort Riley and the United States Army.

Military Appreciation Day rolls out the red carpet for all of the service members here in Kansas who have taken the oath to support and defend the Constitution of the United States. The role the military plays is very important in the fight against terrorism.

Americans believe in the freedom to live without fear of terrorism whether it is flying anywhere in the world or going to work, school or church and not having to look over their shoulders. Fort Riley is home to approximately 10,000 soldiers but we are growing by approximately 10,000 additional service members and 13,000 family members by the year 2011.

Currently, Fort Riley has just under 700 active duty soldiers deployed in support of Operation Iraqi Freedom. We recently welcomed home more than 3,000 soldiers from their year-long deployment to Iraq. These soldiers helped to increase the number of trained and equipped Iraqi security forces by 50 percent in just the past eight months. Our soldiers have assisted with many humanitarian efforts along with fighting for Iraq's freedom. Our soldiers were there for three elections that turned out some 11 million Iraqi voters. All of our soldiers can be justifiably proud of their critical role in Iraq and Afghanistan.

And we've deployed more than 20,000 active duty and reserve component soldiers out of our installation in support of the global war on terrorism — many of them Kansas natives. As our post grows and we implement the Army's changes, we will welcome the 1st Infantry Division back to Fort Riley. Fort Riley is one of the posts to have benefitted from the base realignment and closure actions. It's an exciting time for the military, Fort Riley and the State of Kansas.

Fort Riley is proud of its tradition and proud to be a part of Kansas' history.
