SB 421, An act concerning the Kansas funeral picketing act; amending K.S.A. 21-4015 and repealing the existing section, by Senators Schodorf and McGinn, Apple, Barnett, Barone, Betts, Brownlee, Bruce, Brungardt, Donovan, Francisco, Gilstrap, Goodwin, Haley, Hensley, Jordan, Journey, Kelly, Lee, Morris, Ostmeyer, Petersen, Pine, D. Schmidt, V. Schmidt, Steineger, Taddiken, Teichman, Umbarger, Vratil, Wilson and Wysong.

SB 422, An act concerning surety bonds; eliminating requirements for multiple sureties; amending K.S.A. 19-621, 32-950, 41-805, 58-2802, 68-1402, 75-110 and 78-102 and repealing the existing sections, by Committee on Financial Institutions and Insurance.

SB 423, An act concerning property taxation; relating to appeals of orders of the board of tax appeals; attorney fees and costs; amending K.S.A. 74-2426 and repealing the existing section, by Committee on Assessment and Taxation.

SB 424, An act concerning commerce; implementing the business ownership registration act, by Committee on Ways and Means.

SB 425, An act concerning hospitals and ambulatory surgical centers; relating to disclosure of prices, by Committee on Ways and Means.

SB 426, An act relating to minors; concerning the donation of blood; amending K.S.A. 38-123a and repealing the existing section, by Committee on Ways and Means.

SB 427, An act concerning the consolidation of certain counties and the political and taxing subdivisions therein; amending K.S.A. 18-146 and 18-1,105 and K.S.A. 2005 Supp. 19-205 and repealing the existing sections, by Committee on Ways and Means.

SB 428, An act relating to state employees; concerning veterans service representatives; relating to compensation; amending K.S.A. 46-235 and 73-1211 and repealing the existing sections, by Senators Ostmeyer and D. Schmidt.

SB 429, An act concerning sales taxation; relating to retailers' sales tax in Sherman county; amending K.S.A. 12-195b and K.S.A. 2005 Supp. 12-187 and 12-189 and repealing the existing sections, by Senator Ostmeyer.

SB 430, An act concerning state gaming revenues; relating to disposition; amending K.S.A. 79-4801 and K.S.A. 2005 Supp. 79-4806 and repealing the existing sections, by Committee on Federal and State Affairs.

SB 431, An act concerning expungements; relating to convictions and diversions; amending K.S.A. 2005 Supp. 12-4516 and 21-4619 and repealing the existing sections, by Senator Emler.

SB 432, An act concerning traffic regulation; relating to juvenile traffic offenders; amending K.S.A. 8-2117 and repealing the existing section, by Senator Emler.
