SENATE CHAMBER, TOPEKA, KANSAS Friday, January 27, 2006—9:30 a.m.

EXPLANATION OF VOTE

MR. PRESIDENT: I vote yes for **SB** 334 because we cannot afford not to protect our children. This bill is not about prison beds, it's not about money; it's about doing right by those who have been preyed upon by predators who have no sense of the value or dignity of human life. We are standing for those whose lives have been forever damaged by predators.—Karin Brownlee

Senators Gilstrap, O'Connor, Palmer, Pine and Pyle request the record to show they concur with the Explanation of Vote offered by Senator Brownlee on **SB 334**.

MR. PRESIDENT: As the proud father of four young children....today is our youngest daughter, Malori's, fourth birthday, coincidentally...and as the fiduciary, a veritable custodian, of innocence under attack across my district and across this land...it is with extreme reluctance that I vote against **SB 334.** I believe public safety *is* better served by **SB 334**'s passage and although I would not be the 20th senator (thereby defeating the bill) to vote "No".

As a fiscal conservative, it is obvious to me that we cannot "square a circle on three sides." The price tag, estimated to be 1,000 (one thousand) *additional* prison bed spaces construction is foolish...and will be revisited when the majority of the legislature in some future session realizes what I am telling you today...simply Kansas can't afford it. There has got to be a better way, a more practical way. No one in this legislature has been more consistently outspoken against all predators than I have whether against humans, animals, motorists or even payday lenders. Our children are the most vulnerable of all. By protecting them, we protect our future. We should review our proportionality and our stacking measures in order to protect their financial well being as well.—David Haley

MR. PRESIDENT, I vote aye on **SB 334**. I do understand the fiscal concerns expressed about this bill, especially the additional prison requirements. But we must understand every full prison cell equals one less sexual predator free to pray on our children.—TIM HUELSCAMP

MR. PRESIDENT: I vote now in favor of **SB 334** with reservations. I know this legislation in its current form will protect our children from the worst criminals in society, sending a message that Kansas will not tolerate the victimization of our children. **SB 334** may cast the net too broadly. It lacks proportionality. I supported the mitigating factors for downward departure improving the bill. **SB 334** does not have the most effective mechanism to sort those we should be mad at from those we should fear. Like the highway plan that once we are on this path there will be no turning back. This bill will consume hundreds of millions of dollars. My original amendment would have been as effective in removing predators from our society with less cost. I will not support tax increases to fund this bill, we must look for cuts from other programs keeping our children and our economy safe.—PHILLIP B. JOURNEY
