## TWENTY-FIFTH DAY

SENATE CHAMBER, TOPEKA, KANSAS Monday, February 13, 2006—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with thirty-eight senators present. Senators Betts and O'Connor were excused. Invocation by Chaplain Fred S. Hollomon:

Heavenly Father,

Yesterday was President Abraham Lincoln's one hundred and ninety-seventh birthday anniversary. Today my prayer consists of excerpts from his Proclamation on Prayer and Fasting spoken on April 30, 1863 in the middle of the Civil War.

"It is the duty of nations as well as of men to owe their dependence upon the overruling power of God, to confess their sins and transgressions in humble sorrow, yet with assured hope that genuine repentance will lead to mercy and pardon; and to recognize the sublime truth, announced in the Holy Scriptures and proven by all history, that those nations only are blessed whose God is the Lord.

"...We have been recipients of the choicest bounties of Heaven. We have been preserved, these many years, in peace and prosperity. We have grown in numbers, wealth, and power as no other nation has ever grown; but we have forgotten God.

"...We have forgotten the gracious hand which preserved us in peace, and multiplied and enriched and strengthened us; and we have vainly imagined, in the deceitfulness of our hearts, that all these blessings were produced by some superior wisdom and virtue of our own. Intoxicated with unbroken success, we have become too self-sufficient to feel the necessity of redeeming and preserving grace, too proud to pray to the God that made us:

"It behooves us, then, to humble ourselves before the offended Power, to confess our national sins, and to pray for clemency and forgiveness.."

I pray his words in the Name of Jesus Christ,

**SB 551**, An act concerning tax credits; relating to reporting requirements as a condition of claiming certain tax credits; amending K.S.A. 74-50,132 and K.S.A. 2005 Supp. 79-32,153 and 79-32,160a and repealing the existing sections, by Committee on Commerce.

**SB 552**, An act concerning sales taxation; relating to sales tax exemption for certain sales of clothing, personal computers and school supplies; amending K.S.A. 2005 Supp. 79-3606 and repealing the existing section, by Senator Brownlee.

KANSAS WATER OFFICE

February 9, 2006

Tracy Streeter, Director, submitted five water supply contracts negotiated under the provision of the State Water Plan Storage Act (K.S.A. 82a-1301 *et al.*) and approved by the Kansas Water Authority during calendar year 2005. K.S.A. 82a-1307 states in part:

On or before the 30th calendar day of each legislative session, the director shall transmit to the house of representatives and the senate of this state, and to the secretary of state, copies of each contract made and executed under K.S.A. 82a-1305, and amendments thereto, since the 30th day of the regular legislative session occurring most recently prior to such transmission. . . At any time after the 30th calendar day of the regular legislative session when a contract is transmitted as provided in this section, the legislature may disapprove and revoke such contract by adoption of a concurrent resolution so providing. No contract under K.S.A. 82a-1305, and amendments thereto, shall be subject to revocation by the legislature after the 90th calendar day of such regular legislative session.

The five water supply contracts negotiated are:

Between the State of Kansas and Jost Farms for an Interim Irrigation Water Supply from Marion Lake (Surplus Water Purchase Contract Number 05-1); between the State of Kansas and Jost Farms for an Interim Irrigation Water Supply from Marion Lake (Surplus Water Purchase Contract Number 05-2); between the State of Kansas and D. Randall Heilman for an Interim Irrigation Water Supply from Council Grove Lake (Surplus Water Purchase Contract Number 05-4); between the State of Kansas and Rural Water District No. 3 of Osage County, Kansas for a Public Water Supply from Pomona Reservoir (Water Purchase Contract Number 05-5); between the State of Kansas and City of Harveyville, Wabaunsee

County, Kansas for a Public Water Supply from Melvern Reservoir (Water Purchase Contract Number 05-6).

# INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

SENATE RESOLUTION No. 1811-

A RESOLUTION congratulating and commending the 2006 Horizon Award Program educators.

WHEREAS, National Board Certification, a voluntary process established by the National Board for Professional Teaching Standards, is a symbol of professional teaching excellence. It is achieved through a performance-based assessment process that measures a teacher's practice against high and rigorous advanced standards to demonstrate accomplished practice. Through a series of assessments teachers demonstrate their subject matter knowledge, provide evidence that they know how to teach their subjects to students most effectively, and demonstrate their ability to manage and measure student learning; and

WHEREAS, The National Board for Professional Teaching Standards is an independent, nonprofit, nonpartisan and nongovernmental organization. Its mission is to advance the quality of teaching and learning by: Maintaining high and rigorous standards for what accomplished teachers should know and be able to do; providing a national voluntary system certifying teachers who meet these standards; and advocating related education reforms to integrate National Board Certification in American education and to capitalize on the expertise of National Board Certified teachers: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That we congratulate and commend each of these outstanding educators who have attained the status of National Board Certified teachers; and

Be it further resolved: That the Secretary of the Senate provide 29 enrolled copies of this resolution to the Commissioner of Education for forwarding to each of the teachers so honored plus a copy to the Commissioner of Education.

# REPORTS OF STANDING COMMITTEES

Committee on Agriculture recommends SCR 1620 be adopted.

Also, **SB 500** be amended on page 1, in line 23, after "any" by inserting "fee"; and the bill be passed as amended.

Committee on **Education** recommends **SB 481** be passed.

Committee on **Public Health and Welfare** recommends **SB 470** be amended on page 7, in line 22, after "or" by inserting: "if the temporary licensee does not take the license examination within six months subsequent to the date of issuance of the temporary license and no extenuating circumstances have been approved by the board,";

On page 9, in line 13, after "or" by inserting: "if the temporary licensee does not take the examination within the first 12 months subsequent to the issuance of the temporary license and no extentuating circumstances have been approved by the board,"; and the bill be passed as amended.

Committee on **Utilities** recommends **SB 463** be amended by substituting a new bill to be designated as "Substitute for SENATE BILL No. 463," as follows:

"Substitute for SENATE BILL No. 463

By Committee on Utilities

"AN ACT repealing K.S.A. 50-675a; concerning telemarketing; relating to the notification requirements of telecommunications carriers."; and the substitute bill be passed.

Also **HB 2673** be passed and, because the committee is of the opinion that the bill is of a noncontroversial nature, be placed on the consent calendar.

On motion of Senator D. Schmidt the Senate adjourned until 2:30 p.m., Tuesday, February 14, 2006.
