# SENATE CONCURRENT RESOLUTION No. 1621—

By Senator Brungardt

A CONCURRENT RESOLUTION recognizing the establishment of the first Boy Scout troop in America at Salina and supporting the establishment of the Museum of Scouting at Salina.

WHEREAS, Fund raising efforts are underway to construct a Museum of Scouting at Salina to commemorate Boy Scouts and Girl Scouts. The 6,000 square foot building will be constructed on the Yesteryear Museum grounds on the north edge of town; and

WHEREAS, Although not widely known, the first Boy Scout troop in America was established in Salina in 1910. F. John Romanes, an Englishman, brought scouting to Salina

and America. Romanes had served in the English army and was acquainted with Lord Baden Powell, the originator of scouting. He had been involved in scouting in Beauly, Scotland, before coming to America on a visit with family members. While visiting a former classmate in Salina, he was persuaded to join the staff at St. John's Military School; and

WHEREAS, Mr. Romanes started promoting scouting shortly after joining the school staff in 1909. The first troop was formally organized on January 21, 1910, and was composed of the 10 boys in the church choir at Christ Cathedral church. A second troop was organized consisting of boys from Salina, and shortly thereafter a troop was established in Minneapolis. As today the scout troops existed to develop scouts physically, mentally and spiritually. Early activities consisted of camping organized in a military manner. Cooking was over an open fire, and a daily schedule was followed which included instruction in crafts and first-aid plus ample opportunity for singing, swimming and physical training; and

WHEREAS, With a large donation from Stewart and Ellen Horejsi, the project has generated \$300,000 in donations and pledges, enough to assure its completion but with further funds being required. The museum will have equal space for Boy Scouts and Girl Scouts but is not affiliated or sponsored by the scouting organizations: Now, therefore,

Be it resolved by the Senate of the State of Kansas, the House of Representatives concurring therein: That the Kansas legislature recognizes the establishment of the first Boy Scout troop in America at Salina and indicates its support for the establishment of the Museum of Scouting at Salina which will preserve memorabilia of the Boy Scouts and Girl Scouts and promote Salina and north-central Kansas as a tourist destination.

- (b) (1) For the purposes of determining the amount of supplemental general state aid, the state board shall determine the ranking of each of the former school districts of which the district is composed as required by subsection (a)(2) of K.S.A. 72-6434, and amendments thereto, for the school year prior to the effectuation of the consolidation or attachment.
- (2) For the school year in which the consolidation or attachment is effectuated and the next succeeding two school years, the ranking of the district for the purposes of subsection (a)(2) of K.S.A. 72-6434, and amendments thereto, shall be the ranking of the district receiving the highest amount of supplemental general state aid determined under paragraph (1).":
