# THIRTY THIRD DAY

Senate Chamber, Topeka, Kansas Thursday, February 23, 2006 — 9:30 a.m.

The Senate was called to order by President Stephen Morris.

The roll was called with forty senators present.

President Morris introduced guest chaplain Arnold D. Fitzgerald, Jr., Pastor, Second Baptist Church, Topeka, Kansas, who delivered the invocation:

Almighty God and Father of heaven, we arise to honor you on this grand day. In our heart we bow to you who are the Creator and the life giver of all living things. We surrender each day within a universe of spectacular places and amid a human stream of exceptional persons. Thus, you have composed this honored body of the Kansas State Senate. and ingenious inventors. Remember the works of so many obscure, unrecorded, uncelebrated contributors everywhere and of every background in our land. Especially during this month, lift the abandoned and the disenfranchised who march with a limp from raw deals - broken dreams of promises caviled with, or lost. Let us all celebrate the high marks set by the renowned among the Black heritage. Also, send the education and tidings of the heritage of blest Black genius toward tasks which would alleviate stark poverty and the urban grind associated with the prison industry. We cry to you, O Lord, because it was under your guiding eye that you brought us here to America, the beautiful. Let us be climbing the heights of achievement today. Give us power to bring even the undeserving along with us to a better life. For past challenges to unity abound in us reason and wit. Help us bear a capacity to forgive and to move on together among all people. Where there is lack of supply, have us make provision. Quell our natural tendencies for dispute, and let us to attain the dignity and the grace of ensuing repair and cooperation.

Lord, we thank you that we have been given this day as a special gift. Whether our lot soars high, or our situation sows an amount of sadness, let us hunt down and then receive "the love of God which passes all understanding". We will echo this joyful hope. You have lifted our gaze. Since you have the master plan, we know you are working things together to better everyone in life. That echo returns on the hope borne by divine wings, and it replies, "You have brought all of us here to be together" in the great State of Kansas and the nation of America. Thank you, Lord. We petition you in the honorable name of your Son.

I pray to you in the name of Jesus Christ, my Lord and Savior. Amen.

#### EXPLANATION OF VOTE

Mr. President: I am concerned that **SB 414** does not strike an appropriate balance between gas utility companies and the due process protections that customers deserve.

The surcharge can increase consumer rate every year for five years, without the protections of the traditional rate case review. When the utility files for the surcharge, the commission can only "confirm" that the costs are the type allowed and that they are properly calculated. It does not limit projects to those required by new federal or state actions but can include projects that may already be scheduled to address existing safety requirements.

Rather than a volumetric fee, the bill requires that the surcharge be collected through a fixed charge making the charge the same for a small volume user as it will be for a large volume user. While the bill caps the surcharge for residential customers at 40 cents per month per year, there is no limit for the surcharge on our small businesses, schools, and other commercial and industrial customers.

The utilities have been providing safe and reliable service without these surcharges. I cannot vote to allow for annual rate increases with out additional restrictions or more due process for customers. — MARCI FRANCISCO

- (2) The land is owned by or held in trust for the city or any agency thereof.
- (3) The land adjoins the city and is owned by or held in trust for any governmental unit other than another city, except that no city may annex land owned by a county which has primary use as a county-owned and operated airport, or other aviation related activity or which has primary use as a county owned and operated zoological facility, recreation park or exhibition and sports facility without the express permission of the board of county commissioners of the county.

- (4) The land lies within or mainly within the city and has a common perimeter with the city boundary line of more than 50%.
- (5) The land if annexed will make the city boundary line straight or harmonious and some part thereof adjoins the city, except no land in excess of 21 acres shall be annexed for this purpose.
- (6) The tract is so situated that 2/3 of any boundary line adjoins the city, except no tract in excess of 21 acres shall be annexed under this condition.
- (7) The land adjoins the city and a written petition for or consent to annexation is filed with the city by the owner.
- (b) No portion of any unplatted tract of land devoted to agricultural use of 21 acres or more shall be annexed by any city under the authority of this section without the written consent of the owner thereof.
- (c) No city may annex, pursuant to this section, any improvement district incorporated and organized pursuant to K.S.A 19-2753 et seq., and amendments thereto, or any land within such improvement district. The provisions of this subsection shall apply to such improvement districts for which the petition for incorporation and organization was presented on or before January 1, 1987.
- (d) Subject to the provisions of this section and subsection (e) of K.S.A. 12-520a, and amendments thereto, a city may annex, pursuant to this section, any fire district or any land within such fire district.
- (e) Whenever any city annexes any land under the authority of paragraph 2 of subsection (a) which does not adjoin the city, tracts of land adjoining the land so annexed shall not be deemed to be adjoining the city for the purpose of annexation under the authority of this section until the adjoining land or the land so annexed adjoins the remainder of the city by reason of the annexation of the intervening territory.
- (f) No city may annex the right-of-way of any highway under the authority of this section unless at the time of the annexation the abutting property upon one or both sides thereof is already within the city or is annexed to the city in the same proceeding. The board of county commissioners may notify the city of the existence of any highway which has not become part of the city by annexation and which has a common boundary with the city. The notification shall include a legal description and a map identifying the location of the highway. The governing body of the city shall certify by ordinance that the certification is correct and declare the highway, or portion of the highway extending to the center line where another city boundary line abuts the opposing side of the highway, annexed to the city as of the date of the publication of the ordinance.
- (g) The governing body of any city by one ordinance may annex one or more separate tracts or lands each of which conforms to any one or more of the foregoing conditions. The invalidity of the annexation of any tract or land in one ordinance shall not affect the validity of the remaining tracts or lands which are annexed by the ordinance and which conform to any one or more of the foregoing conditions.
- (h) Notwithstanding any other language in this section to the contrary, the governing body of any city located in a county having a population of less than 100,000 shall not be permitted to annex land pursuant to paragraphs (1) through (6) of subsection (a).

- (d) The council shall elect a chairperson and vice-chairperson from among the members of the council.
  - (e) The council shall:
- (1) Appoint a standing local government advisory group to consult and advise the council concerning local government criminal justice issues and the impact of state criminal justice policy and decisions on local units of government. The advisory group shall consist of a sheriff, chief of police, county or district attorney, a member of a city governing body and a county commissioner. Appointees to such advisory group shall serve without compensation or reimbursement for travel and subsistence or any other expenses;
- (2) define and analyze issues and processes in the criminal justice system, identify alternative solutions and make recommendations for improvements;
- (3) perform such criminal justice studies or tasks as requested by the governor, the attorney general, the legislature or the chief justice, as deemed appropriate or feasible by the council;
- (4) oversee development and management of a criminal justice database including assuming the designation and functions of the state statistical analysis center currently assigned to the Kansas bureau of investigation pursuant to K.S.A. 75-712a and amendments thereto. All criminal justice agencies as defined in subsection (c) of K.S.A. 22-4701 and amendments thereto and the juvenile justice authority shall provide any data or information, including juvenile offender information which is requested by the council, in a form and manner established by the council, in order to facilitate the development and management of the criminal justice council database;
- (5) develop and oversee reporting of all criminal justice federal funding available to the state or local units of government including assuming the designation and functions of administering the United States bureau of justice assistance grants;
- (6) form such task groups as necessary and appoint individuals who appropriately represent law enforcement, the judiciary, legal profession, state, local, or federal government, the public, or other professions or groups as determined by the council, to represent the various aspects of the issue being analyzed or studied, when analyzing criminal justice issues and performing criminal justice studies. Members of the legislature may be appointed ex officio members to such task groups. A member of the council shall serve as the chairperson of each task group appointed by the council. The council may appoint other members of the council to any task group formed by the council; and
- (7) review reports submitted by each task group named by the council and shall submit the report with the council's recommendations pertaining thereto to the governor, the attorney general, the chief justice of the supreme court, the chief clerk of the house of representatives and the secretary of the senate; and

- (8) (A) Establish the sex offender policy board to consult and advise the council concerning issues and policies pertaining to the treatment, sentencing, rehabilitation, reintegration and supervision of sex offenders.
- (B) The sex offender policy board shall consist of the secretary of corrections, the commissioner of juvenile justice, the secretary of social and rehabilitation services, the director of the Kansas bureau of investigation and the chief justice of the supreme court or the chief justice's designee and two persons appointed by the criminal justice coordinating council. Of the persons appointed by the criminal justice coordinating council, one shall be a mental health service provider and the other shall be engaged in the provision of services involving child welfare or crime victims.
- (C) Each member of the board shall receive compensation, subsistence allowances, mileage and other expenses as provided for in K.S.A. 75-3223, and amendments thereto, except that the public members of the board shall receive compensation in the amount provided for legislators pursuant to K.S.A. 75-3212, and amendments thereto, for each day or part thereof actually spent on board activities. No per diem compensation shall be paid under this subsection to salaried state, county or city officers or employees.
- (D) The sex offender policy board shall elect a chairperson from its membership and shall meet upon the call of its chairperson as necessary to carry out its duties.
- (E) Each appointed member of the sex offender policy board shall be appointed for a term of two years and shall continue to serve during that time as long as the member occupies the position which made the member eligible for the appointment. Each member shall continue in office until a successor is appointed and qualifies. Members shall be eligible for reappointment, and appointment may be made to fill an unexpired term.
- (F) The board shall submit its reports to the criminal justice coordinating council and to the governor, the attorney general, the chief justice of the supreme court, the chief clerk of the house of representatives and the secretary of the senate.
- (i) The board shall submit a report regarding public notification pertaining to sex offenders, restrictions on the residence of released sex offenders, utilization of electronic monitoring, and the management of juvenile sex offenders by the first day of the 2007 legislative session.
- (ii) The board shall submit a report regarding treatment and supervision standards for sex offenders, suitability of lifetime release supervision and safety education and prevention strategies for the public by the first day of the 2008 legislative session.
- (iii) The board shall submit reports regarding any other studies, issues or policy recommendations as completed.";

#### INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senators V. Schmidt and Schodorf introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1815—

A RESOLUTION congratulating and commending the Kansas recipients of the 2005 Milken Family Foundation Educator Awards.

WHEREAS, Stanley Bergkamp, a science teacher at Maize High School, Maize USD 266, and Matt Copeland, an English teacher at Washburn Rural High School, Auburn Washburn USD 437, have been selected as the 2005 Kansas recipients of the Milken Family Foundation Educator Awards. Each will receive an unrestricted award of \$25,000 plus recognition by the recipient's community, school and peers; and

WHEREAS, The Milken Educator Awards program was established by the Milken Family Foundation in 1985. The first Awards were presented in 1987; and

WHEREAS, The Milken Family Foundation National Educator Awards program provides public recognition and financial rewards to elementary and secondary school teachers, principals and other education professionals who are furthering excellence in education. By honoring outstanding educators, the program strives to attract, retain and motivate talented people to the challenge and adventure of teaching; and

WHEREAS, The Milken Educator Awards are announced each fall at surprise notifications held in all-school assemblies. Foundation representatives and the chief state school officer make the announcements. This year 48 states and the District of Columbia participated in the program. By publicizing these awards our communities are reminded of the crucial, positive impact of educators. Furthermore, it is hoped these awards will attract the attention of those who might consider teaching as a rewarding career choice: Now, therefore,
