# THIRTY FIFTH DAY

SENATE CHAMBER, TOPEKA, KANSAS Tuesday, February 28, 2006—2:30 p.m.

The Senate was called to order by President Stephen Morris. The roll was called with thirty-three senators present. Senators Barnett, Donovan, Gilstrap, Goodwin, Haley, Huelskamp and Pyle were excused. Invocation by Chaplain Fred S. # INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senator Betts introduced the following Senate resolution, which was read:

## SENATE RESOLUTION No. 1819

# A RESOLUTION regarding motion pictures.

WHEREAS, Motion pictures increasingly depict shocking, violent and graphic images; and

WHEREAS, Movie theater operators are accountable for the health and safety of their patrons while viewing movies; and

WHEREAS, It is the responsibility of movie theater operators to inform patrons of the possible emotional and physical stress which they may incur when viewing shocking, violent and graphic material; and

WHÊREAS, Movie theater operators choosing to offer movies containing shocking, violent and graphic images could be held liable for the impact these images may have on patrons viewing them on their premises; and

WHEREAS, In at least one incident, a patron suffered a heart attack when viewing the shocking, violent and graphic images in *The Passion of the Christ* and later died; and

WHEREAS, Kansas movie theater operators should post a notice in close proximity to the ticket purchasing window stating which movies being shown contain shocking, violent and graphic images: Now, therefore,

*Be it resolved by the Senate of the State of Kansas:* That Kansas movie theater operators in Kansas should recognize the physical and emotional impacts on patrons viewing shocking, graphic and violent material; and

*Be it further resolved:* That Kansas movie theater operators should meet voluntarily to develop the wording of a notice to advise patrons of movies which contain shocking, violent and graphic images.
