EXPLANATION OF VOTE

Mr. President: **HB 2616** upsets the delicate balance of fairness in our criminal justice system. It distorts the purpose of a preliminary hearing to give the state an unfair advantage in criminal prosecution. The proponents of the legislation cite State V Trudell 243 Kan.29. That citation misconstrues that case and its intended meaning.

The main reason in support of the legislation submitted by its proponents was to make the witness comfortable in court testifying. Other means are available to accomplish that goal such as rehearsing testimony in a courtroom after closing of the courthouse rather than incurring the additional expense of court reporters and other staff to have a preliminary hearing that the defendant intends to waive. Sole purpose of a preliminary hearing is to establish probable cause of a crime and that the defendant committed that crime. When a defendant waives preliminary hearing, he admits both of those points.

HB 2616 will taint the jury pool and deny the defendant the right to cross examination during trial. HB 2616 will allow prosecutors to abuse the criminal process in an effort to gain unfair advantage. Kansas juries deserve to hear the facts themselves and not a transcript of a hearing.—PHILLIP B. JOURNEY

all before the semicolon; in line 35, by striking all after "(d)"; in line 36, by striking all before "ascribed" and inserting ""special education" has the meaning";

On page 2, in line 29, by striking all after "education"; in line 32, by striking all after

On page 2, in line 29, by striking all after "education"; in line 32, by striking all after "education"; in line 36, by striking "of children with disabilities"; in line 41, by striking all after "education";

On page 4, in line 37, by striking "to children with disabilities"; in line 39, by striking "to children with disabilities"; and the bill be passed as amended.

Also, **HB 2634** be amended on page 1, following line 32, by inserting:

"Sec. 2. (a) As used in this section:

- (1) "School district" means unified school district No. 404, unified school district No. 493, unified school district No. 499 and unified school district No. 508.
- (2) "Property" means any property, and improvements thereon, comprising a racetrack gaming facility or lottery gaming facility under the Kansas expanded lottery act located in Cherokee county.
- (3) "State aid," means general state aid, supplemental general state aid, capital improvements state aid, capital outlay state aid and any other state aid paid, distributed or allocated to school districts under the school district finance and quality performance act or other law, and any other state aid paid, distributed or allocated to school districts on the basis of the assessed valuation of school districts.
- (b) For the purposes of computing the assessed valuation of school districts for the payment, distribution or allocation of state aid and the levying of school taxes, ½ of the assessed valuation of such property shall be assigned to each of the school districts.
- (c) The provisions of this section shall not apply if the property is not or ceases to be used as a racetrack gaming facility or a lottery gaming facility under the Kansas expanded lottery act.":

And by renumbering the remaining section accordingly; and the bill be passed as amended.

Committee on Federal and State Affairs recommends SCR 1621 be adopted.

Committee on Financial Institutions and Insurance recommends HB 2159, as amended by House Committee, HB 2659, as amended by House Committee, be passed.

Committee on Ways and Means recommends HB 2394, as amended by House Committee, be passed.

COMMITTEE OF THE WHOLE

On motion of Senator D. Schmidt, the Senate resolved itself into Committee of the Whole for consideration of bills on the calendar under the heading of General Orders with Senator Umbarger in the chair.

On motion of Senator Umbarger the following report was adopted:

Recommended **HB 2595**, **HB 2645**, **HB 2663**, **HB 2756** be passed.

The committee report on HB 2875 recommending a S Sub for HB 2875 be adopted, and the substitute bill be passed.

HB 2554 be amended by adoption of the committee amendments, be further amended by motion of Senator O'Connor as amended by Senate Committee, on page 3, after line 36, by inserting the following:

- "(5) If charges against a person, who is required to submit such specimen or sample, are dismissed, a conviction against such person is expunged or a verdict of acquittal with regard to such person is returned, then upon the person's request, the Kansas bureau of investigation shall forthwith destroy such specimen or sample, but retain the record in the Kansas bureau of investigation database.
- (6) If a person, who is required to submit such specimen or sample, has not been charged and the statute of limitations on the crime charged has expired, then upon the person's request, the Kansas bureau of investigation shall forthwith destroy such specimen or sample, but retain the record in the Kansas bureau of investigation database.";

On page 5, in line 5, by striking "expunged and"; in line 6, by striking "or acquittal at trial" and inserting "expungement, acquittal at trial or statute of limitations expiration"

Senator Haley's motion to lay the bill on the table was ruled out of order.

Senator Haley then moved $\dot{H}B$ 2554 be rereferred to the Committee on Judiciary.

The motion failed, and HB 2554 be passed as further amended.

The following amendment offered by Senator Journey to amend **HB 2554**, was rejected: As amended by Senate Committee, on page 2, in line 23, by striking "be punishable as contempt of court and"; in line 42, by striking "at the same time such person is"; in line 43, by striking all before the period and inserting "after a court determination that probable cause exists for the arrest or placement into custody";

On page 3, in line 4, by striking "at the same time"; in line 5, by striking all before the period and inserting "after a court determination that probable cause exists for the arrest or placement into custody"; in line 23, by striking all after the stricken material; by all striking all in lines 24 through 27; in line 28, by striking all before the period and inserting "Such DNA samples shall be submitted to the Kansas bureau of investigation for placement into the DNA database. The court shall ensure, upon the person's first appearance, that such DNA samples have been taken and submitted to the Kansas bureau of investigation"; after line 36, by inserting the following:

"(5) The clerk of the district court shall notify the Kansas bureau of investigation of final disposition of the criminal proceedings. If the charge for which the specimen was taken is dismissed or the defendant is acquitted at trial, the Kansas bureau of investigation shall destroy the specimen and all records thereof, provided there is no other pending qualifying warrant for an arrest, charges or other conviction that would otherwise require the specimen remain in the database.";

On page 5, in line 28, by striking all after the first comma; in line 29, by striking all before the period and inserting "refuses to provide a DNA specimen or fails to cooperate with the collection of the specimens and any deliberate act by that person intended to impede, delay or stop the collection of the specimens shall be punishable as contempt of court"; in line 30, after "a" by inserting "DNA"; also in line 30, by striking "upon arrest,"; in line 31, by striking all before "pursuant" and inserting "after a court determination that probable cause exists for the arrest or placement into custody"
