INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

SB 447, An act concerning agriculture; relating to the agricultural and specialty chemical remediation act; increasing reimbursement limits; extending deposit loan program; amending K.S.A. 2-3708, 2-3713 and 2-3714 and repealing the existing sections, by Committee on Natural Resources.

SB 448, An act relating to corporations; concerning the application of general corporation code to certain cooperatives, by Committee on Judiciary.

SB 449, An act amending the uniform commercial code; relating to secured transactions; amending K.S.A. 2007 Supp. 84-9-521 and repealing the existing section, by Committee on Judiciary.

SB 450, An act relating to cemetery corporations; concerning the investment of permanent maintenance fund; amending K.S.A. 17-1349 and repealing the existing section, by Committee on Judiciary.

SB 451, An act relating to motor vehicles; concerning certificates of title; amending K.S.A. 2007 Supp. 8-135 and repealing the existing section, by Senators Umbarger and Vratil.
