CONFERENCE COMMITTEE REPORT BRIEF SENATE BILL NO. 131

As Agreed to May 7, 2010

Brief*

SB 131 would amend the Private and Out-of-State Postsecondary Educational Institutions Act. Under current law, each institution would have to apply to the State Board of Regents for a certificate of approval, but would not have to obtain additional approval for a branch campus. The bill would require that institutions notify the State Board of Regents about the existence of the branch campus. The branch campus would be subject to fees and review by the Board to ensure it is in compliance with laws and regulations.

Other provisions of the bill include new definitions of regulated institutions, changes to the application and renewal process for branch campuses, clarifying the types of degrees requiring a certificate of approval, and providing for greater penalties for violations of the Act.

The bill also would establish a broad range of fees for degree and non-degree granting institutions. The fee changes are shown on subsequent pages. The fee increases would be in effect for one year only, for FY 2011.

Finally, the bill would require any faculty member employed by a state educational institution who receives an annual salary of \$150,000 or more, other than an adjunct faculty member, file a statement of substantial interests with the Kansas Governmental Ethics Commission.

Conference Committee Action

The Conference Committee agreed to delete the contents of SB 131 and insert the contents of the House version of SB 485. In addition, the Conference Committee agreed to reduce the maximum fees for private postsecondary educational institutions to the State Board of Regents' proposed regulation amounts which were lower than the Board's proposed statutory maximums. The Conference Committee agreed to amend the portion of SB 416 which would eliminate the requirement that certain faculty members employed by state education institutions submit a statement of substantial interests to the Kansas Governmental Ethics Commission: instead the Conference Committee agreed to require any faculty member employed by a state educational institution who receives an annual salary of \$150,000 or more other than an adjunct faculty member, file a statement of substantial interests with the Kansas Governmental Ethics Commission.

Background

The original SB 131, as amended, would allow the governing body of a technical college to change the name of the college by adopting a resolution. The bill also would direct the State Board of Education to establish an Early High School Graduation Incentive Program. These contents were deleted by the Conference Committee.

SB 416, a portion of which the Conference Committee added to SB 131, amended state law to require that a faculty member employed by a state education institution who receives an annual salary of \$50,000 or more, other than an adjunct faculty member, file a statement of substantial interest with the Kansas Governmental Ethics Commission (KGEC).

SB 485, which was inserted into SB 131 by the Conference Committee, was introduced by the Legislative Educational Planning Committee on behalf of the State Board

of Regents. The President of the State Board of Regents was a proponent of the bill. There were no opponents.

The Senate Education Committee amended the bill by clarifying language in the bill. The House Education Committee amended the bill by including specialists in the definition of "academic degree."

The Division of the Budget fiscal note for the original SB 485 indicated that the Private Postsecondary Division within the Board of Regents office carries out the administrative responsibilities related to the Private and Out-of-State Postsecondary Educational Institutions Act with costs financed from fees paid by the regulated institutions. According to the fiscal note if the bill is enacted, fees would be set at a level that would cover program costs. The estimated revenue for FY 2010 under current law is \$182,200 and the estimate for FY 2011 under provisions of the original bill would be \$390,100, an increase of \$207,600.

There was no fiscal note for SB 131 as agreed upon by the Conference Committee.
