Be it enacted by the Legislature of the State of Kansas:

- Section 1. (a) For the fiscal years ending June 30, 2012, June 30, 2013, and June 30, 2014, appropriations are hereby made, restrictions and limitations are hereby imposed, and transfers, capital improvement projects, fees, receipts, disbursements and acts incidental to the foregoing are hereby directed or authorized as provided in this act.
- (b) This act shall not be subject to the provisions of subsection (a) of K.S.A. 75-6702, and amendments thereto.
- (c) The appropriations made by this act shall not be subject to the provisions of K.S.A. 46-155, and amendments thereto.

- (h) During the fiscal years ending June 30, 2012, June 30, 2013, and June 30, 2014, all expenditures by the department of social and rehabilitation services from the community based services waiting list priority autism account shall be for purposes of providing services for persons on the waiting lists for the home and community based services waiver for persons with autism.
- (i) During fiscal years ending June 30, 2012, June 30, 2013, and June 30, 2014, all expenditures by the department of social and rehabilitation services from the community based services community capacity expansion autism account shall be for increased rates of payment to service providers under the home and community based services waiver for persons with autism.
