1 AN ACT concerning commercial vehicles; requiring an annual commercial
2 vehicle fee; amending K.S.A. 79-306d and K.S.A. 2011 Supp. 8-1,152,
3 79-6a01, 79-6a02, 79-6a03, 79-6a04, 79-1439, 79-3425i and 79-5101
4 and repealing the existing sections.

5
6 Be it enacted by the Legislature of the State of Kansas:

7 New Section 1. (a) On and after January 1, 2014, any truck or truck
8 tractor registered for a gross weight of more than 10,000 pounds which is
9 operating as a commercial vehicle shall, in addition to the annual fee
10 prescribed under K.S.A. 8-143, and amendments thereto, pay an annual
11 commercial vehicle fee as follows:

30 (b) Truck or truck tractors registered under this section shall be
31 eligible for apportioned registration under the provisions of K.S.A. 8-1,100
32 et seq., and amendments thereto.

33 (c) Upon the payment of the commercial vehicle fee and applicable
34 registration fees under K.S.A. 8-143, and amendments thereto, except for
35 vehicles registered under K.S.A. 8-1,100 et seq., and amendments thereto,
36 the division shall provide for the registration of and the issuance of license

1 plates for commercial motor vehicles in accordance with the provisions of
2 this section. License plates issued under this section shall be permanent in
3 nature and designed in such a manner as to remain with the commercial
4 motor vehicle for the duration of the life span of the commercial motor
5 vehicle or until the commercial motor vehicle is deleted from the owner's
6 fleet. Such license plates shall be distinctive and shall contain the word
7 "commercial" and there shall be no year date thereon. License plates
8 issued under this section shall not be transferable to any other commercial
9 motor vehicle, except that the unused registration fee may be transferred to
10 another commercial motor vehicle which is registered at the same or
11 greater weight.

12 (d) Amounts collected by the county treasurer as annual commercial
13 vehicle fees under this section shall be remitted or distributed in the
14 following manner:

15 (1) Amounts collected from non-Kansas-based motor carriers, shall
16 be remitted to the state treasurer in accordance with the provisions of
17 K.S.A. 75-4215, and amendments thereto. Upon receipt of each such
18 remittance, the state treasurer shall deposit the entire amount in the state
19 treasury to the credit of the state general fund.

20 (2) Amounts collected from Kansas-based motor carriers shall be
21 allocated and distributed in the same manner as taxes levied against motor
22 vehicles under article 51 of chapter 79 of the Kansas Statutes Annotated.

23 (e) If an applicant registers a motor vehicle described under this
24 section where such vehicle or vehicles are to have a tax situs in another
25 county, then the county treasurer of the county registering such vehicle or
26 vehicles shall collect the fees prescribed under this section and remit them
27 to the county where the vehicle retains its tax situs. Any county treasurer
28 registering a fleet registered under K.S.A. 8-1,101, and amendments
29 thereto, shall remit the commercial vehicle portion of the fee to the county
30 where the fleet is registered. Upon the transfer and receipt of fees under
31 this subsection, the county treasurer of the receiving county shall remit or
32 distribute such fees as provided in subsection (d).

33 (f) As used in this section, "commercial vehicle" means any self-
34 propelled or towed motor vehicle in commerce that is used to transport
35 property or passengers when the vehicle:

36 (1) Has a gross weight or gross combination weight of 10,001 pounds
37 or more;

38 (2) is designed or used to transport 15 or more passengers, including
39 the driver; or

40 (3) is used to transport hazardous materials in a quantity requiring
41 placarding.

42 The term "commercial vehicle" shall not include any motor vehicle
43 required to pay a license fee under subsection (b) (6) of K.S.A. 8-143, and

1 amendments thereto, or any motor vehicle valued under article 5a of
2 chapter 79 of the Kansas Statutes Annotated, and amendments thereto.

3 New Sec. 2. (a) Each commercial vehicle registering under the
4 provisions of K.S.A. 8-143, 8-1,100, or 8-1,152, and amendments thereto,
5 shall be assessed a fee of four dollars. Such fee shall be collected by the
6 county treasurer and shall be remitted in the following manner:

7 (1) Two dollars of such fee assessed and collected pursuant to this
8 section shall be remitted to the state treasurer in accordance with the
9 provisions of K.S.A. 75-4215, and amendments thereto, who shall then
10 credit the entire amount thereof to the commercial vehicle administrative
11 system fund, which fund is hereby established in the state treasury. All
12 moneys deposited in such fund shall be used by the Kansas department of
13 revenue solely for the operation, maintenance and enhancement of the
14 work processes, computer hardware and software and related equipment
15 associated with the division of vehicle's functions related to commercial
16 motor vehicles.

17 (2) Two dollars shall be deposited by the county treasurer in the
18 special fund created pursuant to K.S.A. 8-145, and amendments thereto,
19 and such amounts shall be used by the county treasurer for all purposes for
20 which such fund has been appropriated by law.

21 Sec. 3. K.S.A. 2011 Supp. 8-1,152 is hereby amended to read as
22 follows: 8-1,152. (a) As used in this section, "fleet motor vehicle" means
23 ~~any motor vehicle of a commercial fleet of 250 or more motor vehicles~~
24 ~~which is registered for a gross weight of at least 12,000 pounds but not~~
25 ~~more than 26,000 pounds, except that if a vehicle is registered for a gross~~
26 ~~weight of more than 26,000 pounds and is part of a commercial fleet, and~~
27 ~~such vehicle is not driven out of state, such vehicle shall be deemed a fleet~~
28 ~~motor vehicle for purposes of this section.~~

29 (1) *Any motor vehicle which is part of a public utility commercial*
30 *fleet of 250 or more and which is not required to file for apportioned*
31 *registration pursuant to K.S.A. 8-1,100 through K.S.A. 8-1,124, inclusive,*
32 *and amendments thereto; or*

33 (2) *any motor vehicle of a motor carrier who registers a fleet of*
34 *interstate apportioned registration commercial vehicles of 250 or more in*
35 *any international registration plan jurisdiction, and will register a fleet of*
36 *250 or more commercial vehicles as Kansas fleet registration vehicles,*
37 *which are registered for a gross weight of at least 12,000 pounds, and is*
38 *part of the commercial fleet, and such vehicle is not driven out of state,*
39 *such commercial vehicle shall pay the commercial vehicle fee prescribed*
40 *in section 1, and amendments thereto, at the allocation factor of 35% of*
41 *the commercial vehicle fee.*

42 (b) *Upon the payment of the applicable registration fees under K.S.A.*
43 *8-143, and amendments thereto, the division shall provide for the*

1 registration of and the issuance of license plates for fleet motor vehicles in
2 accordance with the provisions of this section. ~~Fleet motor vehicles~~
3 ~~registered under the provisions of this section shall annually pay the~~
4 ~~applicable registration fees under K.S.A. 8-143, and amendments thereto.~~
5 ~~Upon registration, the owner of the fleet motor vehicles who are not~~
6 ~~exempt from personal property taxes, shall provide evidence of the taxes~~
7 ~~assessed under K.S.A. 79-6a01 et seq., or 79-5101 et seq., and~~
8 ~~amendments thereto.~~ License plates issued under this section shall be
9 permanent in nature and designed in such a manner as to remain with the
10 fleet motor vehicle for the duration of the life span of the fleet motor
11 vehicle or until the fleet motor vehicle is deleted from the owner's fleet.
12 Such license plates shall be distinctive and there shall be no year date
13 thereon. Fleet motor vehicles registered under the provisions of this
14 section shall be issued a permanent registration cab card for the duration of
15 the life span of the fleet motor vehicle or until the fleet motor vehicle is
16 deleted from the owner's fleet. License plates issued under this section
17 shall not be transferable to any other fleet motor vehicle, except that the
18 unused registration fee may be transferred to another fleet motor vehicle
19 which is registered at the same or greater weight. The data required for
20 registration under this section shall be submitted electronically.

21 (c) The secretary of revenue may adopt rules and regulations in order
22 to administer the provisions of this section.

23 Sec. 4. K.S.A. 79-306d is hereby amended to read as follows: 79-
24 306d. (a) This section shall not apply: (1) To motor vehicles which are
25 assessed and taxed by the director of property valuation under the
26 provisions of chapter 79, article 6a, of the Kansas Statutes Annotated, *and*
27 *amendments thereto*; (2) to motor vehicles of ~~public service companies a~~
28 *public utility* whose property is assessed by the director of property
29 valuation *under the provisions of chapter 79, article 5a, of the Kansas*
30 *Statutes Annotated*; (3) ~~to motor vehicles owned by a manufacturer of~~
31 ~~motor vehicles with respect to motor vehicles returned for taxation~~
32 ~~purposes by such manufacturer on an average inventory basis~~; (4) ~~motor~~
33 ~~vehicles owned and/or possessed by motor vehicle dealers which are taxed~~
34 ~~under the provisions of K.S.A. 79-1016 et seq.~~; and (5) to motor vehicles
35 valued and taxed under the provisions of article 51 of chapter 79 of the
36 Kansas Statutes Annotated, and amendments thereto; *and (4) commercial*
37 *vehicles required to be annually registered pursuant to section 1, and*
38 *amendments thereto.*

39 (b) It shall be the duty of the county appraiser to value each vehicle
40 and place it on the tax roll for taxation purposes. In making such valuation
41 the county appraiser shall use the valuation schedules furnished by the
42 director of property valuation except that said appraiser may deviate from
43 such valuation schedules if the vehicle being valued should be assessed at

1 a lower amount than that shown in the schedule because it has been
2 damaged.

3 (c) Motor vehicles acquired, purchased, traded or sold after January 1
4 and prior to September 1 of any year shall be valued in the following
5 manner: In each case the tentative value shall be determined pursuant to
6 the provisions of subsection (b) hereof, and such tentative value divided by
7 twelve to arrive at the monthly value. The value of the motor vehicle shall
8 then be determined as follows: (1) In the case where the vehicle acquired
9 is not a replacement vehicle, the monthly value as defined above shall be
10 multiplied by the number of months or fractions thereof remaining in the
11 calendar year. The value thus determined shall constitute the value of the
12 motor vehicle for said calendar year. (2) In the case where the vehicle
13 acquired is a replacement vehicle, the newly acquired vehicle shall be
14 valued as in subsection (c)(1) above and the vehicle replaced shall be
15 valued by multiplying the monthly value as defined above times the
16 number of full calendar months in the calendar year that the vehicle was
17 owned and for which assessment is being made. The values of the vehicles
18 thus ascertained shall be added together and the sum of the values shall
19 constitute the valuation of the motor vehicles for said calendar year.
20 Motor vehicles acquired, or purchased, after September 1 of any year shall
21 not be subject to assessment and taxation for the year in which they are
22 acquired. As used in this subsection, the term "replacement vehicle" means
23 the vehicle which replaces a motor vehicle previously listed for assessment
24 and taxation for the calendar year in which such vehicle is acquired.

25 (d) The county treasurer, upon accepting an application for title of a
26 vehicle, shall forthwith furnish the county appraiser with such information
27 as is shown on the title application.

28 (e) The director of property valuation shall prescribe such forms as
29 are necessary to administer this section.

30 (f) Whenever any motor vehicle assessed and taxed under the
31 provisions of this section is sold or becomes subject to taxation under the
32 provisions of article 51 of chapter 79 of the Kansas Statutes Annotated,
33 *and amendments thereto*, prior to the end of the tax year, such vehicle shall
34 be valued by multiplying the monthly value as determined in the manner
35 provided by subsection (c) by the number of months or fractions thereof in
36 the calendar year that such vehicle is owned and not subject to taxation
37 under article 51 of chapter 79 of the Kansas Statutes Annotated, *and*
38 *amendments thereto*.

39 Sec. 5. K.S.A. 2011 Supp. 79-6a01 is hereby amended to read as
40 follows: 79-6a01. *Prior to January 1, 2014*, the director of property
41 valuation shall value and assess annually the over-the-road motor vehicles
42 and rolling equipment of motor carriers described in this act. The local
43 deputy assessor shall value and assess within the taxing district where

1 located all other property, real and personal, belonging to such motor
2 carriers.

3 As used in this act, "over-the-road motor vehicles and rolling
4 equipment" shall include all motor-driven vehicles, trailers, semitrailers,
5 buses and trucks owned, used or operated in the state of Kansas by such
6 motor carriers in the transportation of persons or property other than motor
7 vehicles and rolling equipment used solely or mainly for local
8 transportation in a particular community or local area, or for local pickup
9 and delivery, or passenger automobiles used for purposes other than
10 transportation of persons or property for hire. "Motor carriers" as used in
11 this act shall include every person, firm or corporation who or which holds
12 a certificate of convenience and necessity, a certificate of public service, or
13 an interstate license as a common or exempt carrier from the corporation
14 commission of the state of Kansas or is required to register motor carrier
15 equipment pursuant to 49 U.S.C. ~~44506~~ § 14504a.

16 Sec. 6. K.S.A. 2011 Supp. 79-6a02 is hereby amended to read as
17 follows: 79-6a02. On or before ~~March 20 in each year~~ *May 15, 2012 and*
18 *2013*, every person, firm or corporation which was a motor carrier on
19 January 1 of such year and who or which owned, used or operated any
20 over-the-road motor vehicles or rolling equipment in the state of Kansas
21 during the preceding year shall (if a firm or corporation by its president,
22 secretary or principal acting officer or agent) return to the director of
23 property valuation, upon forms furnished by the director, a sworn
24 statement or schedule as follows:

25 1. A list of all certificates, licenses and permits which have been
26 issued to the operator as a motor carrier by the Kansas state corporation
27 commission.

28 2. The total number of miles for which all over-the-road motor
29 vehicles used in the state of Kansas were operated in Kansas and
30 everywhere during the calendar year prior to making such report.

31 3. The complete list of over-the-road vehicles and rolling equipment
32 owned, used or operated in the state of Kansas by such motor carrier
33 during the preceding calendar year and giving the name and number,
34 model and value of the same, except that interchange equipment and trip-
35 leased equipment shall be listed only by the owner.

36 4. In case any motor carrier holding a certificate of convenience and
37 necessity, an interstate license as a common or exempt carrier from the
38 corporation commission of the state of Kansas between January 1 and
39 ~~March 1 of any year~~ *2012 and 2013* did not own, use or operate any over-
40 the-road motor vehicle or rolling equipment in the state of Kansas during
41 the preceding calendar year such motor carrier shall on or before March 20
42 of such year file with the director of property valuation a complete list and
43 number of over-the-road motor vehicles and rolling equipment owned,

1 used or operated by such motor carrier in the state of Kansas between
2 January 1 and March 1 of ~~the year~~ 2012 and 2013, in which such list is
3 filed together with a verified statement estimating the number of miles
4 such motor carrier expects such equipment to be operated in the state of
5 Kansas and everywhere during such year.

6 5. In case any motor carrier required to file a statement under the
7 provisions of this act fails to make and file such statement on or before
8 ~~March 20~~ May 15, the director of property valuation shall, after the
9 director has ascertained the value of the property, of such motor carrier
10 from any other sources available to the director, add 50% additional value
11 as a penalty for failure to file a report, but such assessment shall not
12 relieve the motor carrier from the duty to file such report or statement,
13 except that for good cause shown the director of property valuation may
14 extend the time in which to make and file such statement, except that
15 whenever, in the judgment of the director of property valuation the failure
16 of any motor carrier to comply with this provision is due to a good and
17 reasonable cause, the director of property valuation may at the director's
18 discretion waive or reduce any of the penalty herein provided upon making
19 a record of the director's reason therefor. In the event a motor carrier shall
20 file a statement for any year within one year after such statement was due,
21 the director of property valuation shall recompute the assessment, tax and
22 penalty on the basis of such statement.

23 Sec. 7. K.S.A. 2011 Supp. 79-6a03 is hereby amended to read as
24 follows: 79-6a03. *Prior to January 1, 2014*, the director of property
25 valuation shall value and assess all over-the-road motor vehicles owned,
26 used and operated in the state of Kansas during the preceding calendar
27 year by every motor carrier for the purpose of taxation by the state of
28 Kansas in an amount to be determined in the following manner and
29 according to the following method:

30 (1) The true value of all over-the-road motor vehicles and rolling
31 equipment operated in the state of Kansas shall be determined;

32 (2) the ratio which the total number of miles of the equipment listed
33 operated in the state of Kansas bears to the total number of miles operated
34 everywhere by such equipment shall be determined;

35 (3) the assessed value of all over-the-road motor vehicles and rolling
36 equipment owned, used or operated in the state of Kansas by such motor
37 carrier shall be determined by multiplying the true value by the mileage
38 ratio;

39 (4) the amount so determined shall be the value and assessment of all
40 over-the-road motor vehicles and rolling equipment owned, used or
41 operated in the state of Kansas by such motor carrier in the state of
42 Kansas, except that if any motor carrier who or which holds a certificate of
43 convenience and necessity, or an interstate license as a common or exempt

1 carrier from the corporation commission of the state of Kansas between
2 January 1 and March 1 of ~~any year 2012 and 2013~~, did not own, use or
3 operate any over-the-road motor vehicles or rolling equipment in Kansas
4 during the preceding calendar year, the director of property valuation shall
5 determine the mileage ratio of miles operated in the state of Kansas to
6 miles operated everywhere by use of the estimate of mileage furnished by
7 such motor carrier, and apply the same to the assessed valuation of the
8 equipment listed by such motor carrier to determine the assessed value of
9 such equipment and the tax due thereon; and in any such case, when the
10 carrier files such carrier's return the following year, showing the actual
11 mileage of such vehicles in the state of Kansas and everywhere during
12 such year, the director of property valuation shall recompute the tax and
13 refund any excess tax paid by such carrier, or if an additional amount of
14 tax is determined to be due from the taxpayer, such additional amount shall
15 become due upon mailing of notice of such additional tax to the motor
16 carrier by the director of property valuation, which additional tax may be
17 collected as provided in K.S.A. 79-6a07 and 79-6a11, and amendments
18 thereto.

19 Sec. 8. K.S.A. 2011 Supp. 79-6a04 is hereby amended to read as
20 follows: *79-6a04. Prior to January 1, ~~2014~~ 2014*, the director of property
21 valuation each year, shall make a levy for purposes of taxation, against the
22 value assessed and determined to exist in accordance with the manner and
23 method set forth in article 6a of chapter 79 of Kansas Statutes Annotated,
24 and amendments thereto, at a rate which shall equal the average rate of
25 levy for all purposes in the several taxing districts of the state for the
26 preceding year.

27 For the purposes of such valuation, assessment and taxation, the taxable
28 situs of the over-the-road vehicles and other rolling equipment determined
29 to be taxable under this act is hereby declared to be within this state
30 whether owned, used or operated by a motor carrier who is a resident or
31 nonresident of Kansas and irrespective of whether such motor carrier be
32 domiciled in Kansas or otherwise.

33 The director of property valuation shall cause to be sent to each motor
34 carrier on or before the first day of August a statement of the amount of the
35 valuation or assessment, the rate of levy and the amount of the tax. The
36 determination contained in such statement shall not require an adjudicative
37 proceeding under the Kansas administrative procedure act. The statement
38 shall inform the motor carrier of the right to an informal conference as
39 provided in this section. The failure to request an informal conference shall
40 not preclude any appeal under K.S.A. 74-2438, and amendments thereto. If
41 a motor carrier has any objection to the statement as issued, the motor
42 carrier must, within 15 days of the date of mailing of such notice, notify
43 the director of property valuation in writing of such objection, setting forth

1 the basis therefor and all facts relating thereto. Within 30 days of the date
2 of receipt by the director of property valuation of such written objection,
3 the director shall hold an informal conference with the motor carrier and
4 shall issue a written finding, ruling, order, decision or other final action
5 thereon, which finding, ruling, order, decision or other final action shall
6 become effective for purposes of the appeal as provided by K.S.A. 74-
7 2438, and amendments thereto, three days following the mailing of a copy
8 thereof to the motor carrier. Informal conferences held pursuant to this
9 section may be conducted by the director or the director's designee. The
10 rules of evidence shall not apply to an informal conference and no record
11 shall be made except at the request and expense of the director or the
12 motor carrier.

13 The tax as finally determined shall be paid by the motor carrier to the
14 director of property valuation. The motor carrier may, at its option, pay the
15 full amount thereof on or before December 20 of each year, or ½ thereof
16 on or before December 20 and the remaining ½ thereof on or before May
17 10 next ensuing, but in the event a motor carrier so charged with tax
18 hereunder fails to pay the first ½ thereof, the full amount shall become
19 immediately due and payable. If such motor carrier's taxes are less than
20 \$50, the amount thereof shall be paid on or before December 20 or be
21 subject to the penalties herein provided. In case the first ½ of such taxes
22 remains unpaid after December 20, the entire and full amount of taxes
23 charged shall draw interest at the rate prescribed by K.S.A. 79-2004a, and
24 amendments thereto, from December 20 to date of payment. All taxes
25 levied hereunder of the preceding year and accrued interest thereon which
26 shall remain due and unpaid on May 11 shall draw interest at the rate
27 prescribed by K.S.A. 79-2004a, and amendments thereto, from May 10
28 until paid. All moneys collected under the provisions of this act, except as
29 provided in K.S.A. 79-6a09, and amendments thereto, shall be remitted to
30 the state treasurer in accordance with the provisions of K.S.A. 75-4215,
31 and amendments thereto. Upon receipt of each such remittance, the state
32 treasurer shall deposit the entire amount in the state treasury to the credit
33 of the state general fund.

34 Sec. 9. K.S.A. 2011 Supp. 79-1439 is hereby amended to read as
35 follows: 79-1439. (a) All real and tangible personal property which is
36 subject to general ad valorem taxation shall be appraised uniformly and
37 equally as to class and, unless otherwise specified herein, shall be
38 appraised at its fair market value, as defined in K.S.A. 79-503a, and
39 amendments thereto.

40 (b) Property shall be classified into the following classes and assessed
41 at the percentage of value prescribed therefor:

42 (1) Real property shall be assessed as to subclass at the following
43 percentages of value:

1 (A) Real property used for residential purposes including multi-
2 family residential real property, real property necessary to accommodate a
3 residential community of mobile or manufactured homes including the real
4 property upon which such homes are located, residential real property used
5 partially for day care home purposes if such home has been registered or
6 licensed pursuant to K.S.A. 65-501 et seq., and amendments thereto, and
7 residential real property used partially for bed and breakfast home
8 purposes at 11.5%. As used in this paragraph "bed and breakfast home"
9 means a residence with five or fewer bedrooms available for overnight
10 guests who stay for not more than 28 consecutive days for which there is
11 compliance with all zoning or other applicable ordinances or laws which
12 pertain to facilities which lodge and feed guests;

13 (B) land devoted to agricultural use valued pursuant to K.S.A. 79-
14 1476, and amendments thereto, at 30%;

15 (C) vacant lots at 12%;

16 (D) real property which is owned and operated by a not-for-profit
17 organization not subject to federal income taxation pursuant to section 501
18 of the federal internal revenue code and included herein pursuant to K.S.A.
19 79-1439a, and amendments thereto, at 12%;

20 (E) public utility real property, except railroad property which shall
21 be assessed at the average rate all other commercial and industrial property
22 is assessed, at 33%. As used in this paragraph, "public utility" shall have
23 the meaning ascribed thereto by K.S.A. 79-5a01, and amendments thereto;

24 (F) real property used for commercial and industrial purposes and
25 buildings and other improvements located upon land devoted to
26 agricultural use at 25%; and

27 (G) all other urban and rural real property not otherwise specifically
28 subclassed at 30%.

29 (2) Personal property shall be classified into the following classes and
30 assessed at the percentage of value prescribed therefor:

31 (A) Mobile homes used for residential purposes at 11.5%;

32 (B) mineral leasehold interests, except oil leasehold interests the
33 average daily production from which is five barrels or less, and natural gas
34 leasehold interests, the average daily production from which is 100 mcf or
