1 AN ACT concerning food and lodging; relating to inspections and
2 licensing; amending K.S.A. 36-505, 36-515a, 36-517, 65-660, 65-674
3 and 65-682 and K.S.A. 2011 Supp. 36-501, 36-502, 36-506, 36-510,
4 36-515, 36-515b, 36-518, 36-519, 36-520, 65-655, 65-656, 65-657, 65-
5 658, 65-685, 65-688, 65-689 and 65-690 and repealing the existing
6 sections; also repealing K.S.A. 36-508, 36-511, 36-513, 36-515c, 65-
7 619, 65-620, 65-621, 65-622, 65-623, 65-624, 65-625, 65-631, 65-632,

15 *Be it enacted by the Legislature of the State of Kansas:*

16 New Section 1. (a) Except as otherwise provided in this section, any
17 license issued under the provisions of this act shall expire on March 31
18 following the date of issuance. Licensees may renew licenses by applying
19 to the secretary on or before the expiration date. Application for renewal of
20 a license shall be made on a form prescribed by the secretary and shall be
21 accompanied by the license fee required for the issuance of an original
22 license. If the secretary refuses to renew any license, the secretary shall
23 give written notice thereof to the licensee. In giving written notice, the
24 secretary shall specify changes necessary for complete compliance with
25 rules and regulations, and the secretary shall state that if compliance is
26 achieved within the time designated then the license shall be renewed. If
27 the licensee fails to achieve complete compliance within the prescribed
28 time, the secretary, after notice and an opportunity for a hearing in
29 accordance with the Kansas administrative procedure act, shall deny the
30 application for a license. If for any reason, a licensee fails to renew a
31 license prior to the expiration date, the licensee may obtain a renewal of
32 such license within 30 days following the expiration date. In order to
33 renew a license during this thirty-day period, the licensee must comply
34 with the foregoing provisions of this section and pay a \$25 late fee. If the
35 licensee does not renew within the thirty-day period, then the license is
36 treated as expired, and the licensee must apply for a new license.

1 (b) (1) The secretary shall inspect or cause to be inspected every
2 licensed food establishment or food processing plant in this state. If upon
3 inspection, the secretary determines that a food establishment or food
4 processing plant does not comply with rules and regulations, the secretary
5 shall give written or electronic notice to the owner, proprietor, or agent in
6 charge of such food establishment or food processing plant. In giving
7 notice, the secretary shall specify changes necessary for complete
8 compliance, and the secretary shall designate a time period for achieving
9 compliance. The prescribed time period shall not be less than 10 days,
10 unless the secretary believes time is essential to protect public health and
11 safety. If time is essential to protect public health and safety, the secretary
12 may designate a shorter period for compliance. Also, in giving notice, the
13 secretary shall state that if compliance is not achieved within the time
14 prescribed, the license for the food establishment or food processing plant
15 shall be subject to suspension or revocation.

16 (2) When a licensee of any food establishment or food processing
17 plant receives notice of noncompliance, the licensee may apply to the
18 secretary to extend the time period for achieving compliance. Upon review
19 of any such application, the secretary may deny the application or the
20 secretary may modify the time period for compliance.

21 (3) After the secretary has issued the notice of noncompliance, the
22 secretary may inspect to determine if the food establishment or food
23 processing plant has achieved compliance within the prescribed time. If
24 the food establishment or food processing plant is noncompliant, the
25 secretary, after following the Kansas administrative procedure act, may
26 suspend or revoke the issued license.

27 (c) If after following the Kansas administrative procedure act, the
28 secretary determines that any person has engaged in or is engaging in any
29 act or practice constituting a violation of any provision of this act, or any
30 rules and regulations or order issued thereunder, the secretary may require
31 that such person cease and desist from the unlawful act or practice. The
32 secretary may take such affirmative action when in the secretary's
33 judgment affirmative action carries out the purposes of the violated or
34 potentially violated provision of this act or rules and regulations or order
35 issued thereunder.

36 (d) Any party aggrieved by a final order of the secretary made under
37 this section may appeal such order to the district court in the manner
38 provided by the Kansas judicial review act.

39 New Sec. 2. (a) The secretary is hereby authorized and empowered to
40 contract with the governing body of any municipality for the enforcement
41 of this act, and the rules and regulations adopted thereunder whenever the
42 secretary shall determine that such municipality has adequate personnel to
43 provide proper enforcement. Any municipality entering into a contract

1 with the secretary to enforce statutes, rules or regulations shall act as an
2 agent of the secretary in carrying out such duties. No such municipality
3 shall charge any facility a fee for services performed as an agent of the
4 secretary under such contract, which is in addition to and separate from,
5 any fee such facility is required to pay to the secretary under the provisions
6 of this act. Such municipality shall enforce such standards within the
7 municipality as designated by contract. Any inspection of any premises by
8 officers, employees or agents of any such municipality, and any notice of
9 noncompliance issued as a result of any such inspection, shall have the
10 same force and effect as if performed by the secretary.

11 (b) The secretary and the state fire marshal are hereby authorized and
12 empowered to enter into a contract authorizing the state fire marshal or the
13 fire marshal's deputies or lawful agents to enforce all or any portion of the
14 standards promulgated pursuant to this act. Such contract shall designate
15 specific facilities or types of facilities wherein such authority may be
16 exercised. Any inspection of such facilities by the state fire marshal or the
17 fire marshal's lawful agents to determine compliance with standards
18 established pursuant to this act, and any notice of noncompliance issued as
19 a result of any such inspection, shall have the same force and effect as if
20 performed by the secretary. Such contract also may provide similar
21 authority for the secretary with respect to enforcement of all or any portion
22 of the Kansas fire prevention code in specified facilities or types of
23 facilities. Any inspection of such establishments by the secretary to
24 determine compliance with the Kansas fire prevention code shall have the
25 same force and effect as if performed by the state fire marshal or the fire
26 marshal's deputies or lawful agents.

27 Sec. 3. K.S.A. 2011 Supp. 36-501 is hereby amended to read as
28 follows: 36-501. (a) *K.S.A. 36-501 through 36-520, and amendments*
29 *thereto, shall be known and may be cited as the lodging inspection act.*

30 (b) As used in the ~~food-service-and~~ *lodging inspection act*, the
31 following words and phrases shall have the *following* meanings
32 ~~respectively ascribed to them herein~~:

33 ~~(a)~~ (1) "Hotel" means every building or other structure which is kept,
34 used, maintained, advertised or held out to the public as a place where
35 sleeping accommodations are offered for pay primarily to transient guests
36 and in which four or more rooms are used for the accommodation of such
37 guests, regardless of whether such building or structure is designated as a
38 cabin camp, tourist cabin, motel or other type of lodging unit.

39 ~~(b)~~ (2) "Rooming house" means every building or other structure
40 which is kept, used, maintained, advertised or held out to the public to be a
41 place where sleeping accommodations are furnished for pay to transient or
42 permanent guests and in which eight or more guests may be
43 accommodated, but which does not maintain common facilities for the

1 serving or preparation of food for such guests.

2 ~~(e) (3) "Boarding house" means every building or other structure~~
3 ~~which is kept, maintained, advertised or held out to the public to be a place~~
4 ~~where sleeping accommodations are furnished for pay to transient or~~
5 ~~permanent guests and in which eight or more guests may be~~
6 ~~accommodated, and which maintains common facilities for the serving or~~
7 ~~preparation of food for such guests. The term "boarding house" shall not~~
8 ~~include facilities licensed under paragraph (5) of subsection (a) of K.S.A.~~
9 ~~75-3307b, and amendments thereto.~~

10 ~~(d) (4) "Lodging establishment" means a hotel, rooming house, *guest*~~
11 ~~*house* or boarding house.~~

12 ~~(e) "Food service establishment" means any place in which food is~~
13 ~~served or is prepared for sale or service on the premises or elsewhere.~~
14 ~~Such term shall include, but not be limited to, fixed or mobile restaurant,~~
15 ~~coffee shop, cafeteria, short-order cafe, luncheonette, grill, tea room,~~
16 ~~sandwich shop, soda fountain, tavern, private club, roadside stand,~~
17 ~~industrial-feeding establishment, catering kitchen, commissary and any~~
18 ~~other private, public or nonprofit organization or institution routinely~~
19 ~~serving food and any other eating or drinking establishment or operation~~
20 ~~where food is served or provided for the public with or without charge.~~

21 ~~(f) (5) "Food" means any raw, cooked or processed edible substance,~~
22 ~~beverage or ingredient used or intended for use or for sale, in whole or in~~
23 ~~part, for human consumption.~~

24 ~~(g) "Food vending machine" means any self-service device which,~~
25 ~~upon insertion of a coin, coins or tokens, or by other similar means,~~
26 ~~dispenses unit servings of food, either in bulk or in packages without the~~
27 ~~necessity of replenishing the device between each vending operation but~~
28 ~~shall not include any vending machine dispensing only bottled or canned~~
29 ~~soft drinks, or prepackaged and nonpotentially hazardous food, chewing~~
30 ~~gum, nuts or candies.~~

31 ~~(h) "Food vending machine company" means any person who is in~~
32 ~~the business of operating and servicing food vending machines.~~

33 ~~(i) "Food vending machine dealer" means any manufacturer,~~
34 ~~remanufacturer or distributor of food vending machines who sells food~~
35 ~~vending machines to food vending machine companies. *has the same*~~
36 ~~*meaning as provided in K.S.A. 65-656, and amendments thereto.*~~

37 ~~(6) "*Guest house*" means every building or other structure which is~~
38 ~~*kept, used, maintained, advertised or held out to the public to be a place*~~
39 ~~*where sleeping accommodations are furnished for pay to transient or*~~
40 ~~*permanent guests. A guest house shall accommodate no more than seven*~~
41 ~~*guests in no more than three rooms furnished with sleeping*~~
42 ~~*accommodations, regardless of whether common facilities for the serving*~~
43 ~~*or preparation of food are maintained.*~~

1 (+) (7) "Person" means an individual, partnership, corporation or other
2 association of persons.

3 (~~+~~) (8) "Municipality" means any city or county of this state.

4 (+) (9) "Secretary" means the secretary of agriculture *and the*
5 *secretary's authorized representatives.*

6 (~~+~~) (10) "Department" means the Kansas department of agriculture.

7 Sec. 4. K.S.A. 2011 Supp. 36-502 is hereby amended to read as
8 follows: 36-502. (a) It shall be unlawful for any person to engage in the
9 business of conducting a lodging establishment unless such person shall
10 have in effect a valid license therefor issued by the secretary of agriculture.
11 Applications for such licenses shall be made on forms prescribed by the
12 secretary, and each such application shall be accompanied by the
13 appropriate license fee required by subsection (c) ~~of this section.~~ Prior to
14 the issuance of any such license, the secretary shall inspect or cause to be
15 inspected the lodging establishment designated in the application, to
16 determine that it complies with the standards for lodging establishments
17 promulgated pursuant to this act. If such lodging establishment is found to
18 be in compliance, *and the completed application and accompanying fees*
19 *have been submitted,* the secretary shall issue the license. ~~If the application~~
20 ~~for license is denied, the secretary shall give written notice thereof to the~~
21 ~~applicant, stating also that the applicant is entitled to a hearing thereon if a~~
22 ~~written request therefor is filed with the secretary within 20 days of the~~
23 ~~date such notice is sent. Such hearing shall be held~~ *If such lodging*
24 *establishment is found not to be in compliance, the secretary shall deny*
25 *such application after providing notice and opportunity for a hearing in*
26 *accordance with the provisions of the Kansas administrative procedure act.*

27 (b) Each license shall designate whether the licensed lodging unit is a
28 hotel, rooming house or boarding house. Any person obtaining a license to
29 engage in the business of conducting a rooming house or boarding house
30 shall not have the right to use the name "hotel" in connection with such
31 business. Every license issued hereunder shall be displayed conspicuously
32 in the lodging establishment for which it is issued, and no such license
33 shall be transferable to any other person or location. Whenever any such
34 license is lost, destroyed or mutilated, a duplicate license shall be issued to
35 any otherwise qualified licensee upon application therefor and the payment
36 of a fee in the amount of \$5.

37 (c) The fee for a license to conduct a lodging establishment in this
38 state for all or any part of any calendar year shall be \$30, except that the
39 fee for any lodging establishment containing 10 sleeping rooms shall be
40 \$40 and for every additional 10 rooms therein, an additional fee of \$10
41 shall be charged. All lodging establishments which are newly constructed,
42 newly converted to use as a lodging establishment or have a change of
43 ownership shall pay an application fee which may be adjusted in

1 accordance with the type of establishment or based on other criteria as
2 determined by the secretary, but in no event shall any application fee
3 exceed \$200 in addition to the license fee.

4 ~~(d) Any person who, on the effective date of this act, has a valid~~
5 ~~license to operate a hotel or rooming house shall be a licensee under the~~
6 ~~provisions of this act, and any such license is hereby deemed to be a~~
7 ~~license to operate a lodging establishment issued under the provisions of~~
8 ~~this act. Any lodging establishment that also has a food establishment~~
9 ~~license shall have a fee set by rule and regulation of the secretary. Such~~
10 ~~fee shall not exceed the fees for lodging establishments as provided in~~
11 ~~subsection (c).~~

12 *(e) A guest house shall not be required to have a lodging license, but*
13 *such guest house shall be required to be inspected if the secretary receives*
14 *a complaint concerning such guest house, and shall be subject to the*
15 *temporary closure provisions of subsection (b) of K.S.A. 36-515a, and*
16 *amendments thereto.*

17 *(f) A lodging establishment operated in connection with any premises*
18 *licensed, registered or permitted by the secretary of health and*
19 *environment, the secretary of social and rehabilitation services, the*
20 *secretary of corrections or the secretary of aging, which is inspected and*
21 *regulated pursuant to the respective law or rule and regulation of such*
22 *secretary, shall not require a license as provided in this section, and the*
23 *secretary of agriculture shall not be authorized to inspect or cause such*
24 *premises to be inspected. This subsection shall not apply to a lodging*
25 *establishment whose primary function is not in connection with any*
26 *premises licensed, registered or permitted pursuant to the respective law*
27 *or rule and regulation of such secretary.*

28 Sec. 5. K.S.A. 36-505 is hereby amended to read as follows: 36-505.
29 Except as otherwise provided in this section, any license issued under the
30 provisions of this act shall expire on ~~December 31~~ *March 31 following the*
31 *date of issuance of the year in which it is issued*, and may be renewed by
32 making application to the secretary on or before the expiration date.
33 Application for renewal of a license shall be made on a form prescribed by
34 the secretary and shall be accompanied by the license fee required for the
35 issuance of an original license. ~~Prior to the renewal of any such license, the~~
36 ~~secretary shall inspect or cause to be inspected the licensed premises or~~
37 ~~food vending machines which are to be operated and serviced under~~
38 ~~authority of a license issued under this act to determine the compliance of~~
39 ~~such premises with the applicable standards promulgated pursuant to this~~
40 ~~act. Lodging establishments shall not be required to be inspected prior to~~
41 ~~license renewal. If an inspection of the premises is required and such~~
42 ~~inspection is not made prior to the expiration date of the license sought to~~
43 ~~be renewed, such license shall be valid until the inspection has been made~~

1 and the secretary has granted or denied the application for renewal. No
2 license shall be renewed unless and until the licensed premises for which it
3 is issued is found to be in compliance with the applicable standards
4 promulgated pursuant to this act. A food vending machine dealer license
5 shall be renewed without inspection. If the secretary shall refuse to renew
6 any license, the secretary shall give written notice thereof to the licensee,
7 specifying the changes or alterations necessary in the establishment to
8 effect complete compliance with the applicable standards and stating that,
9 if such compliance is effected within the period of time designated in the
10 notice, the license shall be renewed. If the licensee fails to effect complete
11 compliance with the applicable standards within the time prescribed in
12 such notice, the application for renewal of a license shall be denied, and
13 the secretary shall give written notice thereof to the applicant, stating also
14 that the applicant is entitled to a hearing thereon, if a written request
15 therefor is filed with the secretary within 20 days of the date such notice is
16 sent. Such hearing shall be held in accordance with the provisions of the
17 Kansas administrative procedure act. If, for any reason, a licensee fails to
18 renew a license prior to the expiration date thereof, the licensee may obtain
19 a renewal of such license within 30 days following the expiration date
20 thereof, by complying with the foregoing provisions of this section and
21 paying a restoration fee in the amount of \$10 \$25 late fee. If the licensee
22 does not renew within the 30-day period, then the license is treated as
23 expired and the licensee must apply for a new license.

24 Sec. 6. K.S.A. 2011 Supp. 36-506 is hereby amended to read as
25 follows: 36-506. (a) *The secretary is hereby authorized and empowered to*
26 *administer and enforce the provisions of the lodging inspection act, and*
27 *rules and regulations adopted thereunder.* The secretary of agriculture
28 shall adopt rules and regulations establishing minimum standards for the
29 safe and sanitary operation of lodging establishments *and the*
30 *administration and enforcement thereof.* The lodging standards
31 promulgated by such rules and regulations shall relate to:

- 32 (1) Water supply;
- 33 (2) heating;
- 34 (3) lighting;
- 35 (4) ventilation;
- 36 (5) toilet and other sanitary facilities;
- 37 (6) conditions increasing the hazards of fire, accidents or other
38 calamities;
- 39 (7) bedding and furnishings;
- 40 (8) sewage disposal; ~~and~~
- 41 (9) such other minimum conditions which the secretary deems
42 necessary for the operation and maintenance of a lodging establishment in
43 a safe and sanitary manner.; *and*

1 (10) *licensure of lodging establishments and fees related to the*
2 *licensure and inspection thereof.*

3 (b) The standards promulgated pursuant to the rules and regulations
4 adopted hereunder shall be designed to ensure the health, comfort and
5 safety of the guests in lodging establishments. Such standards may be
6 based upon or incorporate by reference specific editions, or portions
7 thereof, of nationally recognized codes establishing lodging standards.
8 Such standards shall be applicable uniformly throughout the state, except
9 that the secretary may establish different standards for each of the various
10 classes of lodging establishments. Any provision of an ordinance or
11 resolution of any municipality, prescribing safety and sanitation standards
12 for lodging establishments, which does not conform to the minimum
13 standards promulgated by the secretary pursuant to this section, shall be
14 null and void; but nothing herein shall be construed as precluding any
15 municipality from establishing by ordinance or resolution standards which
16 are more stringent than those established by the secretary.

18 follows: 36-510. (a) The secretary shall be responsible for the enforcement
19 of the lodging ~~and food service~~ standards promulgated pursuant to this act,
20 but the secretary is hereby authorized and empowered to contract with the
21 governing body of any municipality for the enforcement of all or any
22 portion of such standards, whenever the secretary shall determine that such
23 municipality has adequate personnel to provide proper enforcement. Any
24 municipality entering into a contract with the secretary to enforce such
25 standards shall act as an agent of the secretary in carrying out such duties,
26 and no such municipality shall charge any lodging establishment ~~or food~~
27 ~~service establishments~~ a fee for services performed as an agent of the
28 secretary under such contract which is in addition to and separate from any
29 fee such establishment is required to pay to the secretary under the
30 provisions of this act. Such municipality shall enforce such standards
31 within such municipalities of this state as are designated in the contract.

40 Such contract shall designate specific lodging ~~or food service~~
41 establishments, or types of lodging ~~or food service~~ establishments, wherein
42 such authority may be exercised. Any inspection of such establishments by
43 the state fire marshal or the fire marshal's deputies or lawful agents, to

1 determine compliance with lodging ~~or food service~~ standards established
 2 pursuant to this act, and any notice of noncompliance issued as a result of
 3 any such inspection, shall have the same force and effect as if such had
 4 been done by the secretary.

5 Such contract also may provide similar authority for the secretary ~~of~~
 6 ~~agriculture~~ and the secretary's officers, employees and agents with respect
 7 to enforcement of all or any portion of the Kansas fire prevention code in
 8 specified lodging ~~or food service~~ establishments, or in types of lodging ~~or~~
 9 ~~food service~~ establishments. Any inspection of such establishments by the
 10 secretary, or the secretary's officers, employees and agents, to determine
 11 compliance with the Kansas fire prevention code, shall have the same
 12 force and effect as if performed by the state fire marshal or the marshal's
 13 deputies and agents.

14 Sec. 8. K.S.A. 2011 Supp. 36-515 is hereby amended to read as
 15 follows: 36-515. (a) After notice and opportunity for a hearing in
 16 accordance with the provisions of the Kansas administrative procedure act,
 17 the secretary may deny, suspend, revoke, refuse to renew or modify the
 18 license to operate a ~~food service establishment~~, a lodging establishment ~~or~~
 19 ~~food vending machines~~ if the licensee has:

20 (1) ~~failed to comply with the standards, provisions or requirements~~
 21 ~~established pursuant to this act; or~~

22 (2) ~~failed to comply with any provision or requirement of the Kansas~~
 23 ~~food service and lodging act, and amendments thereto, or any rule or~~
 24 ~~regulation adopted thereunder.~~

25 (b) ~~Upon conviction, any person who violates any provision of this~~
 26 ~~act shall be guilty of a class C misdemeanor, except that upon any~~
 27 ~~subsequent conviction such person shall be guilty of a class B~~
 28 ~~misdemeanor the lodging inspection act, or any rule or regulation adopted~~

30 (e) (b) The secretary may seek injunctive relief from the appropriate
 31 district court to enjoin any operator of a ~~food service establishment,~~
 32 ~~lodging establishment or food vending machine company~~ from conducting
 33 business when such operator has:

34 (1) Failed to make application for or to obtain a license for such
 35 purpose as required by the ~~food service and lodging inspection act;~~

36 (2) ~~or when had~~ such license ~~has been~~ suspended, *denied* or
 37 *revoked;* or

38 (3) *failed to comply with the standards established pursuant to the*
 39 *lodging inspection act, or rules and regulations adopted thereunder.*

40 Sec. 9. K.S.A. 36-515a is hereby amended to read as follows: 36-
 41 515a. (a) If the secretary finds that the public health or safety is
 42 endangered by the continued operation of a lodging establishment ~~or food~~
 43 ~~service establishment~~, the secretary may suspend temporarily the license

1 of such establishment, *or if the lodging establishment is a guest house,*
2 *order the temporary closure thereof,* without notice or hearing in
3 accordance with the emergency adjudication procedures of the provisions
4 of the Kansas administrative procedure act.

5 (b) In no case shall a temporary suspension of a license *or closure of*
6 *a guest house* under this section be in effect for a period of time in excess
7 of 90 days. At the end of such period of time, the licensee *lodging*
8 *establishment* shall be reinstated to full licensure *or, if such lodging*
9 *establishment is a guest house, allowed to reopen,* unless the secretary has
10 suspended or revoked the license, ~~after notice and hearing obtained an~~
11 ~~injunction against such licensee or operator,~~ or the license has expired as
12 otherwise provided under the ~~food service and lodging inspection act.~~ *All*
13 *suspensions and revocations as provided in this subsection shall be made*
14 *after notice and opportunity for a hearing in accordance with the*

19 follows: 36-515b. (a) Any person who violates any provision of the ~~food~~
20 ~~service and lodging inspection act~~ or any rule and regulation adopted
21 pursuant thereto, in addition to any other penalty provided by law, may
22 incur a civil penalty imposed under subsection (b) in an amount not to
