1 AN ACT concerning motor vehicles; relating to temporary vehicle  
2 registration permits; extending the thirty-day registration to sixty days;  
3 amending K.S.A. ~~{8-127 and K.S.A.}~~ 2011 Supp. 8-135~~{, 8-135c, 8-~~  
4 ~~143, 8-198}~~ and 8-2409 and repealing the existing sections.  
5

6 *Be it enacted by the Legislature of the State of Kansas:*

7 **{Section 1. K.S.A. 8-127 is hereby amended to read as follows: 8-**  
8 **127. (a) Every owner of a motor vehicle, motorized bicycle, trailer or**  
9 **semitrailer intended to be operated upon any highway in this state,**  
10 **whether such owner is a resident of this state or another state, or such**  
11 **motor vehicle, motorized bicycle, trailer or semitrailer is based in this**  
12 **state or another state shall, before any such vehicle is operated in this**  
13 **state, shall apply for and obtain registration in this state under the**  
14 **provisions of K.S.A. 8-126 to 8-149, inclusive, and acts amendatory**  
15 **thereof or supplemental amendments thereto, except as otherwise**  
16 **provided by law or by any interstate contract, agreement, arrangement**  
17 **or declaration made by the director of vehicles.**

18 **(b) Any truck or truck tractor bearing registration of a state other**  
19 **than Kansas which is engaged in intrastate movements within this state**  
20 **shall have Kansas registration, except such vehicles which are registered**  
21 **under the provisions of K.S.A. 8-1,101 to 8-1,123, inclusive, and**  
22 **amendments thereto, and except such vehicles as are entitled to engage**  
23 **in intrastate movements within this state under any interstate contract,**  
24 **agreement, consent, arrangement or declaration made by the director of**  
25 **vehicles.**

26 **(c) Whenever any person has a current motorcycle, motorized**  
27 **bicycle, passenger vehicle, truck or truck tractor registration and license**  
28 **plate for a vehicle which has been sold, traded or otherwise disposed of**  
29 **not later than 30 60 days, inclusive of weekends and holidays, after**  
30 **acquiring another motorcycle, motorized bicycle, passenger vehicle,**  
31 **truck or truck tractor to which the registration and license plate will be**  
32 **transferred and such person has complied with all of the conditions**

1 *precedent to the transfer of the registration except having the*  
2 *registration transferred in the office of the county treasurer, such person*  
3 *may operate the motorcycle, motorized bicycle, passenger vehicle, truck*  
4 *or truck tractor acquired for a period of not to exceed 30 60 days,*  
5 *inclusive of weekends and holidays, after acquiring the same and*  
6 *pending transferral of registration and license plate in the office of the*  
7 *county treasurer by displaying the motorcycle license plate on the*  
8 *motorcycle acquired, the motorized bicycle license plate on the motorized*  
9 *bicycle acquired, the passenger vehicle license plate on the passenger*  
10 *vehicle acquired, or the truck or truck tractor license plate on the truck*  
11 *or truck tractor acquired. If the acquired vehicle is a new vehicle, such*  
12 *person also must carry and have in possession the assigned certificate of*  
13 *title or bill of sale when operating the acquired vehicle during said thirty-*  
14 *day such sixty-day period.}*

15 ~~Section 1.~~ *{Sec. 2.}* K.S.A. 2011 Supp. 8-135 is hereby amended to  
16 read as follows: 8-135. (a) Upon the transfer of ownership of any vehicle  
17 registered under this act, the registration of the vehicle and the right to use  
18 any license plate thereon shall expire and thereafter there shall be no  
19 transfer of any registration, and the license plate shall be removed by the  
20 owner thereof. Except as provided in K.S.A. 8-172, and amendments  
21 thereto, and 8-1,147, and amendments thereto, it shall be unlawful for any  
22 person, other than the person to whom the license plate was originally  
23 issued, to have possession thereof. When the ownership of a registered  
24 vehicle is transferred, the original owner of the license plate may register  
25 another vehicle under the same number, upon application and payment of a  
26 fee of \$1.50, if such other vehicle does not require a higher license fee. If a  
27 higher license fee is required, then the transfer may be made upon the  
28 payment of the transfer fee of \$1.50 and the difference between the fee  
29 originally paid and that due for the new vehicle.

30 (b) Subject to the provisions of subsection (a) of K.S.A. 8-198, and  
31 amendments thereto, upon the transfer or sale of any vehicle by any person  
32 or dealer, or upon any transfer in accordance with K.S.A. 59-3511, and  
33 amendments thereto, the new owner thereof, within ~~30~~60 days, inclusive  
34 of weekends and holidays, from date of such transfer shall make  
35 application to the division for registration or reregistration of the vehicle,  
36 but no person shall operate the vehicle on any highway in this state during  
37 the ~~thirty-day~~sixty-day period without having applied for and obtained  
38 temporary registration from the county treasurer or from a dealer. After the  
39 expiration of the ~~thirty-day~~sixty-day period, it shall be unlawful for the  
40 owner or any other person to operate such vehicle upon the highways of  
41 this state unless the vehicle has been registered as provided in this act. For  
42 failure to make application for registration as provided in this section, a  
43 penalty of \$2 shall be added to other fees. When a person has a current

1 motorcycle or passenger vehicle registration and license plate, including  
2 any registration decal affixed thereto, for a vehicle and has sold or  
3 otherwise disposed of the vehicle and has acquired another motorcycle or  
4 passenger vehicle and intends to transfer the registration and the license  
5 plate to the motorcycle or passenger vehicle acquired, but has not yet had  
6 the registration transferred in the office of the county treasurer, such  
7 person may operate the motorcycle or passenger vehicle acquired for a  
8 period of not to exceed ~~30~~ {60} days by displaying the license plate on the  
9 rear of the vehicle acquired. If the acquired vehicle is a new vehicle such  
10 person also must carry the assigned certificate of title or manufacturer's  
11 statement of origin when operating the acquired vehicle, except that a  
12 dealer may operate such vehicle by displaying such dealer's dealer license  
13 plate.

14 (c) Certificate of title: No vehicle required to be registered shall be  
15 registered or any license plate or registration decal issued therefor, unless  
16 the applicant for registration shall present satisfactory evidence of  
17 ownership and apply for an original certificate of title for such vehicle.  
18 The following paragraphs of this subsection shall apply to the issuance of  
19 a certificate of title for a nonhighway vehicle, salvage vehicle or rebuilt  
20 salvage vehicle, as defined in K.S.A. 8-197, and amendments thereto,  
21 except to the extent such paragraphs are made inapplicable by or are  
22 inconsistent with K.S.A. 8-198, and amendments thereto, and to any  
23 electronic certificate of title, except to the extent such paragraphs are made  
24 inapplicable by or are inconsistent with K.S.A. 2011 Supp. 8-135d, and  
25 amendments thereto, or with rules and regulations adopted pursuant to  
26 K.S.A. 2011 Supp. 8-135d, and amendments thereto.

27 The provisions of paragraphs (1) through (14) shall apply to any  
28 certificate of title issued prior to January 1, 2003, which indicates that  
29 there is a lien or encumbrance on such vehicle.

30 (1) An application for certificate of title shall be made by the owner  
31 or the owner's agent upon a form furnished by the division and shall state  
32 all liens or encumbrances thereon, and such other information as the  
33 division may require. Notwithstanding any other provision of this section,  
34 no certificate of title shall be issued for a vehicle having any unreleased  
35 lien or encumbrance thereon, unless the transfer of such vehicle has been  
36 consented to in writing by the holder of the lien or encumbrance. Such  
37 consent shall be in a form approved by the division. In the case of  
38 members of the armed forces of the United States while the United States  
39 is engaged at war with any foreign nation and for a period of six months  
40 next following the cessation of hostilities, such application may be signed  
41 by the owner's spouse, parents, brother or sister. The county treasurer shall  
42 use reasonable diligence in ascertaining whether the facts stated in such  
43 application are true, and if satisfied that the applicant is the lawful owner

1 of such vehicle, or otherwise entitled to have the same registered in such  
2 applicant's name, shall so notify the division, who shall issue an  
3 appropriate certificate of title. The certificate of title shall be in a form  
4 approved by the division, and shall contain a statement of any liens or  
5 encumbrances which the application shows, and such other information as  
6 the division determines.

7 (2) The certificate of title shall contain upon the reverse side a form  
8 for assignment of title to be executed by the owner. This assignment shall  
9 contain a statement of all liens or encumbrances on the vehicle at the time  
10 of assignment. The certificate of title shall also contain on the reverse side  
11 blank spaces so that an abstract of mileage as to each owner will be  
12 available. The seller at the time of each sale shall insert and certify the  
13 mileage and the purchase price on the form filed for application or  
14 reassignment of title, and the division shall insert such mileage on the  
15 certificate of title when issued to purchaser or assignee. The signature of  
16 the purchaser or assignee is required on the form filed for application or  
17 reassignment of title, acknowledging the odometer and purchase price  
18 certification made by the seller, except that vehicles which are 10 model  
19 years or older and trucks with a gross vehicle weight of more than 16,000  
20 pounds shall be exempt from the mileage acknowledgment requirement of  
21 the purchaser or assignee. Such title shall indicate whether the vehicle for  
22 which it is issued has been titled previously as a nonhighway vehicle or  
23 salvage vehicle. In addition, the reverse side shall contain two forms for  
24 reassignment by a dealer, stating the liens or encumbrances thereon. The  
25 first form of reassignment shall be used only when a dealer sells the  
26 vehicle to another dealer. The second form of reassignment shall be used  
27 by a dealer when selling the vehicle to another dealer or the ultimate  
28 owner of the vehicle. The reassignment by a dealer shall be used only  
29 where the dealer resells the vehicle, and during the time that the vehicle  
30 remains in the dealer's possession for resale, the certificate of title shall be  
31 dormant. When the ownership of any vehicle passes by operation of law,  
32 or repossession upon default of a lease, security agreement, or executory  
33 sales contract, the person owning such vehicle, upon furnishing  
34 satisfactory proof to the county treasurer of such ownership, may procure a  
35 certificate of title to the vehicle. When a vehicle is registered in another  
36 state and is repossessed in another state, the owner of such vehicle shall  
37 not be entitled to obtain a valid Kansas title or registration, except that  
38 when a vehicle is registered in another state, but is financed originally by a  
39 financial institution chartered in the state of Kansas or when a financial  
40 institution chartered in Kansas purchases a pool of motor vehicle loans  
41 from the resolution trust corporation or a federal regulatory agency, and  
42 the vehicle is repossessed in another state, such Kansas financial  
43 institution shall be entitled to obtain a valid Kansas title or registration. In

1 addition to any other fee required for the issuance of a certificate of title,  
2 any applicant obtaining a certificate of title for a repossessed vehicle shall  
3 pay a fee of \$3.

4 (3) Dealers shall execute, upon delivery to the purchaser of every  
5 new vehicle, a manufacturer's statement of origin stating the liens and  
6 encumbrances thereon. Such statement of origin shall be delivered to the  
7 purchaser at the time of delivery of the vehicle or at a time agreed upon by  
8 the parties, not to exceed 30 days, inclusive of weekends and holidays. The  
9 agreement of the parties shall be executed on a form approved by the  
10 division. In the event delivery of title cannot be made personally, the seller  
11 may deliver the manufacturer's statement of origin by restricted mail to the  
12 address of purchaser shown on the purchase agreement. The  
13 manufacturer's statement of origin may include an attachment containing  
14 assignment of such statement of origin on forms approved by the division.  
15 Upon the presentation to the division of a manufacturer's statement of  
16 origin, by a manufacturer or dealer for a new vehicle, sold in this state, a  
17 certificate of title shall be issued if there is also an application for  
18 registration, except that no application for registration shall be required for  
19 a travel trailer used for living quarters and not operated on the highways.

20 (4) The fee for each original certificate of title shall be \$10 in  
21 addition to the fee for registration of such vehicle, trailer or semitrailer.  
22 The certificate of title shall be good for the life of the vehicle, trailer or  
23 semitrailer while owned or held by the original holder of the certificate of  
24 title.

25 (5) Except for a vehicle registered by a federally recognized Indian  
26 tribe, as provided in paragraph (16), upon sale and delivery to the  
27 purchaser of every vehicle subject to a purchase money security interest as  
28 provided in article 9 of chapter 84 of the Kansas Statutes Annotated, and  
29 amendments thereto, the dealer or secured party may complete a notice of  
30 security interest and when so completed, the purchaser shall execute the  
31 notice, in a form prescribed by the division, describing the vehicle and  
32 showing the name and address of the secured party and of the debtor and  
33 other information the division requires. On and after July 1, 2007, only one  
34 lien shall be taken or accepted for vehicles with a gross vehicle weight  
35 rating of 26,000 pounds or less. As used in this section "gross vehicle  
36 weight rating" shall have the meaning ascribed thereto in K.S.A. 66-1,108,  
37 and amendments thereto. The dealer or secured party, within ~~30~~ ~~60~~ **{30}**  
38 days of the sale and delivery, may mail or deliver the notice of security  
39 interest, together with a fee of \$2.50, to the division. The notice of security  
40 interest shall be retained by the division until it receives an application for  
41 a certificate of title to the vehicle and a certificate of title is issued. The  
42 certificate of title shall indicate any security interest in the vehicle. Upon  
43 issuance of the certificate of title, the division shall mail or deliver

1 confirmation of the receipt of the notice of security interest, the date the  
2 certificate of title is issued and the security interest indicated, to the  
3 secured party at the address shown on the notice of security interest. The  
4 proper completion and timely mailing or delivery of a notice of security  
5 interest by a dealer or secured party shall perfect a security interest in the  
6 vehicle, as referenced in K.S.A. 2011 Supp. 84-9-311, and amendments  
7 thereto, on the date of such mailing or delivery. The county treasurers shall  
8 mail a copy of the title application to the lienholder. For any vehicle  
9 subject to a lien, the county treasurer shall collect from the applicant a  
10 \$1.50 service fee for processing and mailing a copy of the title application  
11 to the lienholder.

12 (6) It shall be unlawful for any person to operate in this state a vehicle  
13 required to be registered under this act, or to transfer the title to any such  
14 vehicle to any person or dealer, unless a certificate of title has been issued  
15 as herein provided. In the event of a sale or transfer of ownership of a  
16 vehicle for which a certificate of title has been issued, which certificate of  
17 title is in the possession of the transferor at the time of delivery of the  
18 vehicle, the holder of such certificate of title shall endorse on the same an  
19 assignment thereof, with warranty of title in a form prescribed by the  
20 division and printed thereon and the transferor shall deliver the same to the  
21 buyer at the time of delivery to the buyer of the vehicle or at a time agreed  
22 upon by the parties, not to exceed ~~30~~ **60** days, inclusive of weekends and  
23 holidays, after the time of delivery. The agreement of the parties shall be  
24 executed on a form provided by the division. The requirements of this  
25 paragraph concerning delivery of an assigned title are satisfied if the  
26 transferor mails to the transferee by restricted mail the assigned certificate  
27 of title within the ~~30~~ **60** days, and if the transferor is a dealer, as defined by  
28 K.S.A. 8-2401, and amendments thereto, such transferor shall be deemed  
29 to have possession of the certificate of title if the transferor has made  
30 application therefor to the division. The buyer shall then present such  
31 assigned certificate of title to the division at the time of making application  
32 for registration of such vehicle. A new certificate of title shall be issued to  
33 the buyer, upon payment of the fee of \$10. If such vehicle is sold to a  
34 resident of another state or country, the dealer or person making the sale  
35 shall notify the division of the sale and the division shall make notation  
36 thereof in the records of the division. When a person acquires a security  
37 interest that such person seeks to perfect on a vehicle subsequent to the  
38 issuance of the original title on such vehicle, such person shall require the  
39 holder of the certificate of title to surrender the same and sign an  
40 application for a mortgage title in form prescribed by the division. Upon  
41 such surrender such person shall immediately deliver the certificate of  
42 title, application, and a fee of \$10 to the division. Delivery of the  
43 surrendered title, application and tender of the required fee shall perfect a

1 security interest in the vehicle as referenced in K.S.A. 2011 Supp. 84-9-  
2 311, and amendments thereto. On and after July 1, 2007, only one lien  
3 may be taken or accepted for security for an obligation to be secured by a  
4 lien to be shown on a certificate of title for vehicles with a gross vehicle  
5 weight rating, as defined in K.S.A. 66-1,108, and amendments thereto, of  
6 26,000 pounds or less. A refinancing shall not be subject to the limitations  
7 of this act. A refinancing is deemed to occur when the original obligation  
8 is satisfied and replaced by a new obligation. Lien obligations created  
9 before July 1, 2007, which are of a continuing nature shall not be subject  
10 to the limitations of this act until the obligation is satisfied. A lien in  
11 violation of this provision is void. Upon receipt of the surrendered title,  
12 application and fee, the division shall issue a new certificate of title  
13 showing the liens or encumbrances so created, but only one lien or  
14 encumbrance may be shown upon a title for vehicles with a gross vehicle  
15 rating of 26,000 pounds or less, and not more than two liens or  
16 encumbrances may be shown upon a title for vehicles in excess of 26,000  
17 pounds gross vehicle weight rating. When a prior lienholder's name is  
18 removed from the title, there must be satisfactory evidence presented to  
19 the division that the lien or encumbrance has been paid. When the  
20 indebtedness to a lienholder, whose name is shown upon a title, is paid in  
21 full, such lienholder shall comply with the provisions of K.S.A. 2011  
22 Supp. 8-1,157, and amendments thereto.

23 (7) It shall be unlawful for any person to buy or sell in this state any  
24 vehicle required to be registered, unless, at the time of delivery thereof or  
25 at a time agreed upon by the parties, not to exceed ~~30~~ **60** days, inclusive of  
26 weekends and holidays, after the time of delivery, there shall pass between  
27 the parties a certificate of title with an assignment thereof. The sale of a  
28 vehicle required to be registered under the laws of this state, without  
29 assignment of the certificate of title, is fraudulent and void, unless the  
30 parties shall agree that the certificate of title with assignment thereof shall  
31 pass between them at a time other than the time of delivery, but within ~~30~~  
32 **60** days thereof. The requirements of this paragraph concerning delivery of  
33 an assigned title shall be satisfied if (A) the seller mails to the purchaser by  
34 restricted mail the assigned certificate of title within ~~30~~ **60** days, or (B) if  
35 the transferor is a dealer, as defined by K.S.A. 8-2401, and amendments  
36 thereto, such seller shall be deemed to have possession of the certificate of  
37 title if such seller has made application therefor to the division, or (C) if  
38 the transferor is a dealer and has assigned a title pursuant to paragraph (9)  
39 of this subsection (c).

40 (8) In cases of sales under the order of a court of a vehicle required to  
41 be registered under this act, the officer conducting such sale shall issue to  
42 the purchaser a certificate naming the purchaser and reciting the facts of  
43 the sale, which certificate shall be prima facie evidence of the ownership

1 of such purchaser for the purpose of obtaining a certificate of title to such  
2 motor vehicle and for registering the same. Any such purchaser shall be  
3 allowed ~~30~~ 60 days, inclusive of weekends and holidays, from the date of  
4 sale to make application to the division for a certificate of title and for the  
5 registering of such motor vehicle.

6 (9) Any dealer who has acquired a vehicle, the title for which was  
7 issued under the laws of and in a state other than the state of Kansas, shall  
8 not be required to obtain a Kansas certificate of title therefor during the  
9 time such vehicle remains in such dealer's possession and at such dealer's  
10 place of business for the purpose of sale. The purchaser or transferee shall  
11 present the assigned title to the division of vehicles when making  
12 application for a certificate of title as provided in subsection (c)(1).

13 (10) Motor vehicles may be held and titled in transfer-on-death form.

14 (11) Notwithstanding the provisions of this act with respect to time  
15 requirements for delivery of a certificate of title, or manufacturer's  
16 statement of origin, as applicable, any person who chooses to reaffirm the  
17 sale in writing on a form approved by the division which advises them of  
18 their rights pursuant to paragraph (7) of subsection (c) and who has  
19 received and accepted assignment of the certificate of title or  
20 manufacturer's statement of origin for the vehicle in issue may not  
21 thereafter void or set aside the transaction with respect to the vehicle for  
22 the reason that a certificate of title or manufacturer's statement of origin  
23 was not timely delivered, and in such instances the sale of a vehicle shall  
24 not be deemed to be fraudulent and void for that reason alone.

25 (12) The owner of any vehicle assigning a certificate of title in  
26 accordance with the provisions of this section may file with the division a  
27 form indicating that such owner has assigned such certificate of title. Such  
28 forms shall be furnished by the division and shall contain such information  
29 as the division may require. Any owner filing a form as provided in this  
30 paragraph shall pay a fee of \$10. The filing of such form shall be prima  
31 facie evidence that such certificate of title was assigned and shall create a  
32 rebuttable presumption. If the assignee of a certificate of title fails to make  
33 application for registration, an owner assigning such title and filing the  
34 form in accordance with the provisions of this paragraph shall not be held  
35 liable for damages resulting from the operation of such vehicle.

36 (13) Application for a certificate of title on a boat trailer with a gross  
37 weight over 2,000 pounds shall be made by the owner or the owner's agent  
38 upon a form to be furnished by the division and shall contain such  
39 information as the division shall determine necessary. The division may  
40 waive any information requested on the form if it is not available. The  
41 application together with a bill of sale for the boat trailer shall be accepted  
42 as prima facie evidence that the applicant is the owner of the boat trailer,  
43 provided that a Kansas title for such trailer has not previously been issued.



1 If the application and bill of sale are used to obtain a certificate of title for  
2 a boat trailer under this paragraph, the certificate of title shall not be issued  
3 until an inspection in accordance with subsection (a) of K.S.A. 8-116a, and  
4 amendments thereto, has been completed.

5 (14) In addition to the two forms for reassignment under paragraph  
6 (2) of subsection (c), a dealer may attach one additional reassignment form  
7 to a certificate of title. The director of vehicles shall prescribe and furnish  
8 such reassignment forms. The reassignment form shall be used by a dealer  
9 when selling the vehicle to another dealer or the ultimate owner of the  
10 vehicle only when the two reassignment forms under paragraph (2) of  
11 subsection (c) have already been used. The fee for a reassignment form  
12 shall be \$6.50. A dealer may purchase reassignment forms in multiples of  
13 five upon making proper application and the payment of required fees.

14 (15) A first stage manufacturer, as defined in K.S.A. 8-2401, and  
15 amendments thereto, who manufactures a motor vehicle in this state, and  
16 who sells such motor vehicles to dealers located in a foreign country, may  
17 execute a manufacturers statement of origin to the division of vehicles for  
18 the purpose of obtaining an export certificate of title. The motor vehicle  
19 issued an export certificate of title shall not be required to be registered in  
20 this state. An export certificate of title shall not be used to register such  
21 vehicle in the United States.

22 (16) A security interest in a vehicle registered by a federally  
23 recognized Indian tribe shall be deemed valid under Kansas law if validly  
24 perfected under the applicable tribal law and the lien is noted on the face  
25 of the tribal certificate of title.

26 (17) On and after January 1, 2010, a certificate of title issued for a  
27 rebuilt salvage vehicle for the initial time, shall indicate on such title, the  
28 reduced classification of such vehicle as provided under K.S.A. 79-5104,  
29 and amendments thereto.

30 *{Sec. 3. K.S.A. 2011 Supp. 8-135c is hereby amended to read as*  
31 *follows: 8-135c. (a) The provisions of this section shall be a part of and*  
32 *supplemental to the provisions of article 1 of chapter 8 of the Kansas*  
33 *Statutes Annotated, and as used in this section, the words and phrases*  
34 *defined by K.S.A. 8-126, and amendments thereto, shall have the*  
35 *meanings respectively ascribed to them therein.*

36 *(b) As used in this section:*

37 *(1) "Nonrepairable vehicle" means any motor vehicle which: (A)*  
38 *Has been damaged, destroyed, wrecked, burned or submerged in water*  
39 *to the extent that such motor vehicle is incapable of safe operation for*  
40 *use on roads or highways and has no resale value except as a source of*  
41 *parts or scrap only; or (B) the owner irreversibly designates as a source*  
42 *of parts or scrap;*

43 *(2) "nonrepairable vehicle certificate" means a motor vehicle*

1 *ownership document issued by the division designating that vehicle a*  
2 *nonrepairable vehicle.*

3 *(c) (1) Except as otherwise provided by this section, the owner of a*  
4 *vehicle that meets the definition of a nonrepairable vehicle shall apply to*  
5 *the division for a nonrepairable vehicle certificate before the ownership*  
6 *of the motor vehicle is transferred. In no event shall such application be*  
7 *made more than ~~30~~ 60 days after the vehicle is determined to be a*  
8 *nonrepairable vehicle.*

9 *(2) Every insurance company, which pursuant to a damage*  
10 *settlement, acquires ownership of a vehicle that has incurred damage*  
11 *requiring the vehicle to be designated a nonrepairable vehicle, shall*  
12 *apply to the division for a nonrepairable vehicle certificate within ~~30~~ 60*  
13 *days after the title is assigned and delivered by the owner to the*  
14 *insurance company, with all liens released.*

15 *(3) Every insurance company which makes a damage settlement for*  
16 *a vehicle that has incurred damage requiring such vehicle to be*

21 *for a salvage title for the motor vehicle, and shall notify the division of*  
22 *this fact in accordance with procedures established by the division. The*  
23 *vehicle owner shall apply for a salvage title within ~~30~~ 60 days after being*  
24 *notified by the insurance company.*

25 *(4) The lessee of any vehicle which incurs damage requiring the*  
26 *vehicle to be designated a salvage vehicle shall notify the lessor of this*  
27 *fact within 30 days of the determination that the vehicle is a salvage*  
28 *vehicle.*

29 *(5) The lessor of any motor vehicle which has incurred damage*  
30 *requiring the vehicle to be titled as a salvage vehicle, shall apply for a*  
31 *salvage title within ~~30~~ 60 days after being notified of this fact by the*  
32 *lessee.*

33 *(6) Every person acquiring ownership of a motor vehicle that meets*  
34 *the definition of a salvage vehicle, for which a salvage title has not been*  
35 *issued, shall apply for the required document prior to any further*  
36 *transfer of such vehicle, but in no event, more than ~~30~~ 60 days after*  
37 *ownership is acquired.*

38 *(7) Every purchaser of a salvage vehicle, whether assigned a*  
39 *salvage title or a regular certificate of title with the form specified in*  
40 *paragraph (2) of subsection (b) attached, shall make application to the*

14 *(e) A nonhighway certificate of title or salvage title shall be in form*  
15 *and color as prescribed by the director of vehicles. A nonhighway*  
16 *certificate of title or salvage title shall indicate clearly and distinctly on*  
17 *its face that it is issued for a nonhighway vehicle or salvage vehicle,*  
18 *whichever is applicable. A nonhighway certificate of title or salvage title*  
19 *shall contain substantially the same information as required on a*

1 *with K.S.A. 8-116a, and amendments thereto, and the notice required in*  
2 *paragraph (3)(B) of this subsection has been attached to such vehicle.*

3 *(B) As part of the inspection for a rebuilt salvage title conducted*  
4 *under K.S.A. 8-116a, and amendments thereto, the Kansas highway*  
5 *patrol shall attach a notice affixed to the left door frame of the rebuilt*  
6 *salvage vehicle indicating the vehicle identification number of such*  
7 *vehicle and that such vehicle is a rebuilt salvage vehicle. In addition to*  
8 *any fee allowed under K.S.A. 8-116a, and amendments thereto, a fee of*  
9 *\$5 shall be collected from the owner of such vehicle requesting the*  
10 *inspection for the notice required under this paragraph. All moneys*  
11 *received under this paragraph shall be remitted in accordance with*

13 *(C) Failure to apply for a rebuilt salvage title as provided by this*  
14 *paragraph shall be a class C nonperson misdemeanor.*

15 *(g) The owner of a salvage vehicle which has been issued a salvage*  
16 *title and has been assembled, reconstructed, reconstituted or restored or*  
17 *otherwise placed in an operable condition may make application to the*  
18 *county treasurer for a permit to operate such vehicle on the highways of*  
19 *this state over the most direct route from the place such salvage vehicle*  
20 *is located to a specified location named on the permit and to return to*  
21 *the original location. No such permit shall be issued for any vehicle*  
22 *unless the owner has motor vehicle liability insurance coverage or an*

 16 *under the provisions of this section for such work-site utility vehicle,*  
 17 *unless the person transfers an interest in such work-site utility vehicle.}*
