1 AN ACT concerning agriculture; relating to noxious weeds; amending
2 K.S.A. 2-1314b, 2-1320, 2-1323, 2-1330 and 2-1332 and K.S.A. 2014
3 Supp. 2-1314, 2-1315, 2-1316, 2-1317, 2-1318, 2-1319, 2-1322 and 2-
4 1331 and repealing the existing sections; also repealing K.S.A. 2-
5 1316a, 2-1325, 2-1326, 2-1328 and 2-1329 and K.S.A. 2014 Supp. 2-
6 1327 and 2-1334.

8 *Be it enacted by the Legislature of the State of Kansas:*

9 New Section 1. (a) The provisions of article 13 of chapter 2 of the
10 Kansas Statutes Annotated, and amendments thereto, and sections 1
11 through 5, and amendments thereto, shall be known and may be cited as
12 the noxious weed act.

13 (b) For the purposes of this act:

14 (1) "Act" means the noxious weed act;

15 (2) "article" means any material or tangible object that could harbor,
16 carry or is capable of disseminating noxious weeds;

17 (3) "certified weed free" means any unprocessed plant product that
18 has been inspected by authorized state or county officials and found to be
19 free of the reproductive parts of noxious and invasive weeds according to
20 standards set forth by the North American invasive species management
21 association;

22 (4) "control" means the removal or destruction of the reproductive
23 parts of any noxious weeds before such weeds propagate and spread or
24 whenever required by the secretary or the county weed supervisor;

25 (5) "governing body" means the board, body or persons in which the
26 powers of a political subdivision as a body corporate are vested;

27 (6) "governmental agency" means the state or any agency or political
28 subdivision thereof or the government of the United States or any agency
29 or instrumentality thereof;

30 (7) "noxious weed" means any species of plant that the secretary shall
31 determine to be a noxious weed in rules and regulations adopted and
32 promulgated by the secretary;

33 (8) "noxious weed plant material" means any noxious weed plant or
34 plant part that is capable of reproducing sexually or asexually;

35 (9) "political subdivision" means any agency or unit of the state
36 authorized to levy taxes or empowered to cause taxes to be levied;

1 (10) "secretary" means the secretary of agriculture or the secretary's
2 designated representative; and

3 (11) "weed supervisor" means a person hired by a country, township
4 or city and approved by the secretary to enforce the noxious weed act and
5 to control and manage noxious weeds within the confines of the
6 supervisor's jurisdiction.

7 New Sec. 2. (a) The secretary may make an emergency declaration of
8 noxious weeds if:

9 (1) A new and potentially harmful noxious weed is discovered
10 growing in the state and is verified by the secretary; or

11 (2) the state is facing a potential influx of noxious weeds as the result
12 of a natural disaster.

13 (b) Once a weed, or weeds, has been declared noxious under this
14 section, the secretary shall consider such weed or weeds as noxious as
15 provided in K.S.A. 2-1314, and amendments thereto, and take every action
16 and use any means available to control or eradicate such noxious weed
17 species as authorized in this act.

18 (c) The secretary shall not make an emergency declaration for the
19 same weed more than once without the recommendation of the state
20 advisory committee.

21 (d) The declaration shall remain in effect for the earlier of 18 months
22 or until action can be taken by the secretary to declare the species a
23 noxious weed by rules and regulations.

24 New Sec. 3. (a) There is hereby created the state noxious weed
25 advisory committee, referred to in this section as the "state advisory
26 committee." The state advisory committee shall consist of 11 voting
27 members and the secretary or a duly appointed representative of the
28 secretary as a non-voting ex officio member. Representation on the state
29 advisory committee shall reflect the different geographic areas of the state
30 equally to the greatest extent possible. Such members shall receive no
31 compensation for serving on such state advisory committee, but shall be
32 paid subsistence allowances, mileage and other expenses as provided in
33 K.S.A. 75-3223, and amendments thereto, from moneys appropriated
34 therefor to the Kansas department of agriculture. The 11 voting members
35 shall be appointed by the secretary as follows:

36 (1) One member shall represent a natural resource management
37 professional from the Kansas department of wildlife, parks and tourism;

38 (2) two members shall represent weed specialists from Kansas state
39 university college of agriculture or the Kansas state research and extension
40 and shall be appointed upon the recommendation of the dean of the college
41 of agriculture and the director of Kansas state research and extension;

42 (3) one member shall be a county commissioner and shall be
43 appointed upon recommendation of the Kansas association of counties;

- 1 (4) three members shall be private landowners;
- 2 (5) two members shall represent county weed directors and shall be
3 appointed upon the recommendation of the county weed directors
4 association of Kansas board of directors; and
- 5 (6) two members shall represent the agricultural industries in the state
6 and shall be appointed upon the recommendation of the Kansas
7 agribusiness retailers association board of directors.
- 8 (b) (1) Except as provided in this section, the term of office of each
9 member of the committee shall be four years. The initial appointments to
10 the committee shall be as follows:
- 11 (A) Four members shall be appointed for terms of two years;
- 12 (B) four members shall be appointed for terms of three years; and
- 13 (C) three members shall be appointed for terms of four years.
- 14 (2) The secretary shall designate the term of office for each member
15 appointed to the first committee. Appointees shall be limited to serving a
16 total of two full terms each. Each state advisory committee member shall
17 hold office until the expiration of the term for which such member is
18 appointed or until a successor has been duly appointed.
- 19 (3) In the event of a vacancy on the state advisory committee, the
20 appointing body of the vacating member shall fill such vacancy for the
21 remainder of the unexpired term before the next meeting.
- 22 (4) The secretary may remove any member of the state advisory
23 committee for misconduct, incompetence or neglect of duty.
- 24 (5) A quorum of the state advisory committee shall be six of the
25 members duly appointed to the state advisory committee.
- 26 (6) A quorum of the state advisory committee shall elect or appoint
27 annually a chairperson and a vice-chairperson.
- 28 (7) The state advisory committee shall meet at least quarterly.
- 29 (c) The state advisory committee shall, among other duties assigned
30 by the secretary:
- 31 (1) Review the state weed management plan every five years and
32 recommend changes and updates to the secretary for approval;
- 33 (2) through the use of a risk assessment, designated by the secretary,
34 recommend the designation and classification of state noxious weeds;
- 35 (3) review the noxious weed act and the list of species declared to be
36 noxious weeds by rules and regulations of the secretary every four years
37 and recommend changes to the secretary;
- 38 (4) review the official eradication and control methods for each state
39 noxious weed and recommend changes to the secretary; and
- 40 (5) before January 1 of each odd-numbered year report to the
41 secretary on the expenditure of state funds on noxious weed control;
42 specifically how such funds were spent; the status of the state and county
43 programs; and recommendations for the continued best use of state funds

1 for noxious weed control. The report shall include recommendations as to
2 the long-term needs regarding noxious weed control.

3 (d) Recommendations of the state advisory committee shall be made
4 by a majority vote of the members of the state advisory committee.

5 New Sec. 4. It shall be unlawful for any person, company or
6 corporation:

7 (a) To import, introduce, plant, sow, move or knowingly allow to
8 grow any weed declared and designated as noxious pursuant to K.S.A. 2-
9 1314, and amendments thereto, except in accordance with such conditions
10 as the secretary may prescribe by rules and regulations to prevent the
11 dissemination of such noxious weeds into this state;

12 (b) to sell, barter or give away nursery stock, plants, packing
13 materials, animal fertilizer and soil or sod for landscaping or fertilizer use
14 which contains, or is infested with, noxious weed plant material or seeds;

15 (c) to transport articles, seed, screening, grains, crops, straw, hay,
16 forage, offal material or feed of any kind containing noxious weed plant
17 material or seeds unless such materials shall have been carried or
18 transported in such vehicles or containers which prevent the leaking or
19 scattering thereof or are processed by grinding or other means adequate to
20 destroy the viability of all such noxious weed plant material or seeds,
21 except such feeds that are to be fed to livestock may be sold for
22 consumption on the same farm where grown or may be sold to commercial
23 processors or commercial feed mixers. All common carriers shall
24 thoroughly clean and destroy any noxious weed plant material or seeds in
25 or on cars, trucks, vehicles or other receptacles used by them after each
26 load shall have been delivered to a consignee before again placing such
27 car, truck, vehicle or receptacle into service; or

28 (d) to bring any harvesting or threshing machinery, portable feed
29 grinders, portable seed cleaners, field ensilage cutters or other farm
30 vehicles or machinery into the state or from any field or farm within the
31 state that is infested with any noxious weed without first cleaning such
32 equipment free from any noxious weed plant material or seeds.

33 (e) This section shall not apply to:

34 (1) Research sanctioned by a state or federal agency or an accredited
35 university or college; or

36 (2) activities specifically permitted by the secretary.

37 New Sec. 5. Any and all alfalfa, grass, hay or other forage, straw or
38 mulch carried onto or used for any purpose within the boundaries of any
39 lands owned or managed by the state government and of its agencies must
40 be certified noxious weed free.

41 Sec. 6. K.S.A. 2014 Supp. 2-1314 is hereby amended to read as
42 follows: 2-1314. (a) *The secretary shall adopt rules and regulations to*
43 *declare the weeds of the state that are noxious weeds. Once a weed has*

1 *been declared to be a noxious weed, it shall be considered a noxious weed*
2 *in every county of the state. The secretary shall not declare any species to*
3 *be a noxious weed without the recommendation of the state advisory*
4 *committee, except under an emergency declaration as provided in section*
5 *2, and amendments thereto. It shall be the duty of persons, associations of*
6 *persons, the secretary of transportation, the boards of county*
7 *commissioners, the township boards, school boards, drainage boards, the*
8 *governing body of incorporated cities, railroad companies and other*
9 *transportation companies or corporations or their authorized agents and*
10 *those supervising state-owned lands to control the spread of and to*
11 *eradicate all weeds declared by legislative action to be noxious on all lands*
12 *owned or supervised by them and to use such methods for that purpose and*
13 *at such times as are approved and adopted by the Kansas department of*
14 *agriculture. The term noxious weeds shall mean*

15 *(b) The following shall be considered noxious weeds: kudzu (Pueraria*
16 *lobata), field bindweed (Convolvulus arvensis), Russian knapweed*
17 *(Centaurea repens), hoary cress (Cardaria draba), Canada thistle (Cirsium*
18 *arvense), quackgrass (Agropyron repens), leafy spurge (Euphorbia esula),*
19 *bur ragweed (Ambrosia grayii), pignut (Hoffmannseggia densiflora), musk*
20 *(nodding) thistle (Carduus nutans L.), Johnson grass (Sorghum halepense)*
21 *and sericea lespedeza (Lespedeza cuneata). The provisions of this*
22 *subsection shall expire on July 1, 2016.*

23 *(c) A board of county commissioners may, with the approval of the*
24 *secretary, publish a list of the species of weeds to be controlled in the*
25 *county, in addition to those declared as noxious pursuant to this section.*
26 *Any species so listed shall be considered to be a noxious weed within the*
27 *boundaries of that county.*

28 *(1) The board of county commissioners shall, for any species to be*
29 *listed as provided in this subsection that previously has not been listed by*
30 *another county, submit to the secretary for approval official methods for*
31 *the control and eradication of such species. Any county subsequently*
32 *listing the same species shall adopt the official methods for the control*
33 *and eradication of that species as approved by the secretary.*

34 *(2) If any species listed by the board of county commissioners of any*
35 *county is later declared a noxious weed by rules and regulations of the*
36 *secretary, the official methods adopted by the secretary for the control and*
37 *eradication of such species pursuant to, K.S.A. 2-1315, and amendments*
38 *thereto, shall control over any methods adopted by the board of county*
39 *commissioners.*

40 *(3) Cost share chemicals, in accordance with K.S.A. 2-1322, and*
41 *amendments thereto, shall be made available for the control and*
42 *eradication of any species listed by a board of county commissioners*
43 *pursuant to this subsection.*

1 Sec. 7. K.S.A. 2-1314b is hereby amended to read as follows: 2-
2 1314b. (a) The board of county commissioners of any county may declare
3 the multiflora rose (*Rosa multiflora*) or the bull thistle (*Cirsium vulgare*),
4 or both, to be a noxious weed within the boundaries of such county. In
5 such event, all of the provisions of article 13 of chapter 2 of the Kansas
6 Statutes Annotated, *and amendments thereto*, which pertain to the control
7 and eradication of noxious weeds shall apply to the control and eradication
8 of the multiflora rose or the bull thistle, or both, within any such county.

9 (b) If the board of county commissioners of any county does not
10 declare the multiflora rose or the bull thistle, or both, to be a noxious weed
11 within the boundaries of such county, a petition requesting the secretary of
12 agriculture to declare the multiflora rose or the bull thistle, or both, to be a
13 noxious weed within the boundaries of such county, signed by not less
14 than 5% of the qualified electors of the county, may be filed with the
15 county election officer of the county. Upon receipt of any such petition, the
16 county election officer shall certify the sufficiency of the petition and
17 submit it to the secretary of agriculture. Thereupon, the secretary of
18 agriculture may declare the multiflora rose or the bull thistle, or both, to be
19 a noxious weed within the boundaries of such county. In such event, all of
20 the provisions of article 13 of chapter 2 of the Kansas Statutes Annotated,
21 *and amendments thereto*, which pertain to the control and eradication of
22 noxious weeds shall apply to the control and eradication of the multiflora
23 rose or the bull thistle, or both, within any such county. *The provisions of*
24 *this section shall expire on July 1, 2016.*

25 Sec. 8. K.S.A. 2014 Supp. 2-1315 is hereby amended to read as
26 follows: 2-1315. The secretary of agriculture is hereby empowered to
27 decide and adopt methods as official for control and eradication of noxious
28 weeds and to publish such methods, and to make and publish such rules
29 and regulations as in the secretary's judgment are necessary to carry into
30 effect the provisions of this act, and to alter or suspend such rules and
31 regulations when necessary. The secretary of agriculture may establish not
32 to exceed five noxious weed control districts within this state and define
33 the boundaries of such districts. Such districts shall be established to
34 provide for the most efficient control and eradication of noxious weeds
35 and for the most economical supervision by the state. ~~The secretary may~~
36 ~~designate any county as a sericea lespedeza disaster area to provide for the~~
37 ~~control and eradication of sericea lespedeza within such county. The~~
38 ~~secretary shall consult with the board of county commissioners of any~~
39 ~~county prior to designation of such county as a sericea lespedeza disaster~~
40 ~~area pursuant to this subsection.~~

41 The secretary may consult, advise or render assistance to county and
42 city weed supervisors as to the best and most practical methods of noxious
43 weed control and eradication. It shall be the duty of the county agricultural

1 agent to cooperate with and assist the county weed supervisors in an
2 intensive educational program on weed control. The secretary of
3 agriculture is hereby authorized to enter into agreements with any agencies
4 of the federal government for cooperation in the control and eradication of
5 noxious weeds in Kansas in keeping with the provisions of this act.

6 Sec. 9. K.S.A. 2014 Supp. 2-1316 is hereby amended to read as
7 follows: 2-1316. (a) *The responsibility for the enforcement of the*
8 *provisions of this act shall be vested in the board of county commissioners*
9 *as to all lands, unless otherwise provided for, within the boundaries of*
10 *such county. Cities and townships may enter into an agreement with the*
11 *board of county commissioners to take upon themselves the responsibility*
12 *of the enforcement of the provisions of this act. If, at any time, a board of*
13 *county commissioners determines that a city or township within the*
14 *boundaries of the county that has taken upon itself the responsibility of the*
15 *enforcement of the provisions of this act, is unable or unwilling to fulfill*
16 *those responsibilities, the board of county commissioners may revoke the*
17 *terms of the agreement and resume the responsibility for the enforcement*
18 *of the provisions of this act.*

19 (b) The board of county commissioners of each county shall, and the
20 governing body of any incorporated city or any group of counties or cities
21 may, employ for a stated time each year, with the approval of the secretary
22 of agriculture, ~~a competent person as~~ county, city or district weed
23 supervisor.

24 ~~(b) (c) The weed supervisor shall consult and cooperate with the state~~
25 ~~division of noxious weeds and with the assistant weed control director~~
26 ~~appointed for the supervisor's district, make annual surveys of infestations~~
27 ~~(compile data on areas eradicated and under treatment), and submit an~~
28 ~~annual report to the county commissioners and to the state division of~~
29 ~~noxious weeds, to consult and advise upon~~ *secretary in* all matters
30 pertaining to the best and most practical methods for noxious weed control
31 and eradication and to render every possible assistance and direction for
32 the most effective control and eradication within the supervisor's district;
33 investigate or aid in the investigation and prosecution of any violation of
34 this act and report violations of which the supervisor has knowledge to the
35 county attorney.

36 ~~(e) (d) The salary of the county weed supervisor shall be borne as~~
37 ~~follows: The Kansas department of agriculture to pay not more than one-~~
38 ~~fourth thereof from any funds available, not less than three-fourths thereof~~
39 ~~to be paid out of the county noxious weed fund or, if the county noxious~~
40 ~~weed program is funded primarily through county general funds, the~~
41 ~~salary shall be paid from the county general funds, prorated as may be~~
42 ~~decided at the time of such employment by the governing body or bodies~~
43 ~~employing such supervisor. If the noxious weed program is funded from~~

1 *more than one source, the salary shall be paid from each source in*
2 *proportion to which it contributes to the noxious weed program.*

3 ~~(d) (e) The boards of county commissioners, governing bodies of~~
4 ~~cities and township boards, with the aid of their weed supervisors, shall~~
5 ~~make by February 15th each year an annual weed eradication progress~~
6 ~~report to the secretary of agriculture for the preceding calendar year, on a~~
7 ~~form supplied by the secretary, and such other weed reports as established~~
8 ~~by rules and regulations of the secretary of agriculture. The weed~~
9 ~~supervisor shall make annual surveys of infestations and ascertain the~~
10 ~~approximate amount of land and highways infested with each kind of~~
11 ~~noxious weed and its location in the county not later than October 31 of~~
12 ~~each year. The weed supervisor shall compile data on areas eradicated~~
13 ~~and under treatment and any other data the secretary may deem~~
14 ~~necessary, and submit, by March 15 of each year, an annual weed~~
15 ~~eradication progress report for the preceding calendar year to the board~~
16 ~~of county commissioners for their signatures and then to the secretary. The~~
17 ~~weed supervisor shall prepare and submit, by March 15 of each year, a~~
18 ~~management plan for the coming year, to the board of county~~
19 ~~commissioners and to the secretary for approval.~~

20 Sec. 10. K.S.A. 2014 Supp. 2-1317 is hereby amended to read as
21 follows: 2-1317. The secretary of agriculture or the secretary's duly
22 authorized representative and the local district or county weed supervisor
23 shall confer, at such time or times as seems necessary and advisable *to the*
24 *secretary*, with persons and associations of persons, the secretary of
25 transportation, the board of county commissioners, the township boards or
26 other boards and the governing body of cities, railroad companies or other
27 corporations, or their authorized agents, as to the extent of noxious weed
28 infestation on their lands, and the methods deemed best suited to the
29 control and eradication of each kind of noxious weeds within their
30 respective jurisdictions. ~~The county commissioners and the governing~~
31 ~~body of cities, shall report to the secretary of agriculture as to the extent~~
32 ~~and the official methods of control and eradication of noxious weeds to be~~
33 ~~undertaken in any one season in their jurisdiction, subject to the approval~~
34 ~~of the secretary.~~

35 Sec. 11. K.S.A. 2014 Supp. 2-1318 is hereby amended to read as
36 follows: 2-1318. ~~The county weed supervisor of each county is hereby~~
37 ~~directed and it shall be the duty of the county weed supervisor to ascertain~~
38 ~~each year the approximate amount of land and highways infested with~~
39 ~~each kind of noxious weeds and its location in the county, and transmit~~
40 ~~such information tabulated by cities and townships not later than June 1 of~~
41 ~~each year, to the secretary of agriculture, board of county commissioners,~~
42 ~~and to the governing body of each city and township in the district~~
43 ~~pertaining to such noxious weed infestation in their respective jurisdiction.~~

1 (a) On the basis of such information of the infestation survey, prescribed
2 by K.S.A. 2-1316, and amendments thereto, the tax levying body of each
3 county, township or incorporated city shall either make a tax levy each
4 year for the purpose of paying their part of the cost of control and
5 eradication of noxious weeds thereof as provided in this act and, or set
6 aside a portion of the county general fund equivalent to the budget of the
7 county weed program. In the case of cities and counties, a portion of the
8 tax levy may be used to pay a portion of the principal and interest on bonds
9 issued under the authority of K.S.A. 12-1774, and amendments thereto, by
10 cities located in the county. Each county, city, and township, separately,
11 shall make a levy each year for such purpose. Any township or city may
12 budget expenditures for weed control within its general operating fund in
13 lieu of levying a special tax therefor or maintaining a separate noxious
14 weed eradication fund. Moneys collected from such levy, except for an
15 amount to pay a portion of the principal and interest on bonds issued under
16 the authority of K.S.A. 12-1774, and amendments thereto, by cities located
17 in the county, shall be set apart as a noxious weed eradication fund and
18 warrants duly verified by the county weed supervisor or, if such be
19 employed, city supervisor if such be employed or if no supervisor be
20 employed, then by county, township or city clerk, as the case may be, may
21 be drawn against this fund for all items of expense incident to control of
22 noxious weeds in such district respectively. Any moneys remaining in the
23 noxious weed eradication fund at the end of any year for which a levy is
24 made under this section may shall either be transferred to the noxious
25 weed capital outlay fund for making of capital expenditures incident to the
26 control of noxious weeds or remain in the noxious weed eradication fund
27 for use in the next year.

28 (b) All records relating to funds received into and spent from both the
29 noxious weed eradication fund and the noxious weed capital outlay fund
30 shall be retained by the county for not fewer than five years and shall be
31 made available to the Kansas department of agriculture upon request.

32 Sec. 12. K.S.A. 2014 Supp. 2-1319 is hereby amended to read as
33 follows: 2-1319. (a) The cost of controlling and eradicating noxious weeds
34 on all lands or highways owned or supervised by a state agency,
35 department or commission shall be paid by the state agency, department or
36 commission supervising such lands or highways from funds appropriated
37 to its use; on county lands and county roads, on township lands and
38 township roads, on city lands, streets and alleys by the county, township or
39 city in which such lands, roads, streets and alleys are located, and from
40 funds made available for that purpose; on drainage districts, irrigation
41 districts, cemetery associations and other political subdivisions of the state,
42 the costs shall be paid from their respective funds made available for the
43 purpose. If the governing body of any political subdivision owning or

1 supervising lands infested with noxious weeds within their jurisdiction
2 fails to control such noxious weeds after 15 days' notice directing any such
3 body to do so, the board of county commissioners shall proceed to have
4 proper control and eradication methods used upon such lands, and shall
5 notify the governing body of the political subdivision by certified mail of
6 the costs of such operations, with a demand for payment. The governing
7 body of the political subdivision shall pay such costs from its noxious
8 weed fund, or if no such fund is available, from its general fund or from
9 any other funds available for such purpose. A copy of the statement,
10 together with proof of notification, shall at the same time be filed with the
11 county clerk, and if the amount is not paid within 30 days, such clerk shall
12 spread the amount upon the tax roll of the subdivision, and such amount
13 shall become a lien against the entire territory located within the particular
14 political subdivision, and shall be collected as other taxes are collected.

15 (b) All moneys collected pursuant to this section shall be paid into the
16 county noxious weed eradication fund *or, if the noxious weed program is*
17 *funded primarily through the county general fund, such moneys shall be*
18 *paid into the county general fund. If the noxious weed program is funded*
19 *from more than one source, all moneys collected pursuant to this section*
20 *shall be paid from each source in proportion to which it contributes to the*
21 *noxious weed program.*

22 (e) ~~As used in this section, "governing body" means the board, body,~~
23 ~~or persons in which the powers of a political subdivision as a body~~
24 ~~corporate are vested; and "political subdivision" means any agency or unit~~
25 ~~of the state authorized to levy taxes or empowered to cause taxes to be~~
26 ~~levied.~~

27 (d) ~~On all other lands the owner thereof shall pay the cost of control~~
28 ~~and eradication of noxious weeds. Except as provided in K.S.A. 2-1333,~~
29 ~~and amendments thereto, chemical materials for use on privately owned~~
30 ~~lands may be purchased from the board of county commissioners at a price~~
31 ~~fixed by the board of county commissioners which shall be in an amount~~
32 ~~equal to not less than 50% nor more than 75% of the total cost incurred by~~
33 ~~the county in purchasing, storing and handling such chemical materials.~~
34 ~~However, once the tax levying body of a county, city or township has~~
35 ~~authorized a tax levy of 1.5 mills or more, the board of county~~
36 ~~commissioners may collect from the owner of privately owned lands an~~
