1 AN ACT concerning postsecondary education; relating to the nursing
2 service scholarship program; removing limits on the amount of
3 scholarship awards and the number of scholarships; removing the
4 requirement to obtain a sponsor; modifying the terms and conditions
5 for interest accrual on repayment obligations; abolishing the nursing
6 service scholarship review committee; amending K.S.A. 74-3292, 74-
7 3293, 74-3294, 74-3295, 74-3296, 74-3297 and 74-3298 and repealing
8 the existing sections; also repealing K.S.A. 74-3299.

10 *Be it enacted by the Legislature of the State of Kansas:*

11 Section 1. K.S.A. 74-3292 is hereby amended to read as follows: 74-
12 3292. As used in this act:

 13 **the provisions of K.S.A. 19-4001 through 19-4015, and amendments**
 14 **thereto, and licensed pursuant to K.S.A. 39-2001 et seq., and**
 15 **amendments thereto;**

16 **(4) any mental health clinic organized pursuant to the provisions**

31 **(c) "School of nursing" means a school within the state of Kansas**
 32 ~~which~~ **that is approved by the state board of nursing to grant an associate**
 33 **degree or a baccalaureate degree in professional nursing or a certificate of**
 34 **completion in practical nursing and is:**

35 **(1) Under the control and supervision of the state board of regents;**

36 **(2) a municipal university; or**

37 **(3) a not-for-profit independent institution of higher education that**
 38 **has its main campus or principal place of operation in Kansas, maintains**
 39 **open enrollment as such term is defined in K.S.A. 74-32,120, and**
 40 **amendments thereto, and is operated independently and not controlled or**
 41 **administered by the state or any agency or subdivision thereof.**

42 ~~(f) "Sponsor" means any adult care home licensed under the adult~~
 43 ~~care home licensure act, any medical care facility licensed under K.S.A.~~

1 65-425 et seq., and amendments thereto, any home health agency licensed
2 under K.S.A. 65-5101 et seq., and amendments thereto, any local health
3 department as defined in K.S.A. 65-241, and amendments thereto, any
4 mental health or treatment facility and any state agency which employs
5 licensed practical nurses or licensed professional nurses.

6 **(d) "Sponsor" means any of the following that is located in a**
7 **rural opportunity zone as defined in K.S.A. 74-50,222, and**
8 **amendments thereto:**

9 **(1) An adult care home licensed under the adult care home**
10 **licensure act, K.S.A. 39-923 et seq., and amendments thereto;**

11 **(2) a medical care facility licensed under K.S.A. 65-425 et seq.,**
12 **and amendments thereto;**

13 **(3) a home health agency licensed under K.S.A. 65-5101 et seq.,**
14 **and amendments thereto;**

15 **(4) a local health department as defined in K.S.A. 65-241, and**
16 **amendments thereto;**

17 **(5) a mental health or treatment facility; or**

18 **(6) a state agency that employs licensed practical nurses or**
19 **licensed professional nurses.**

20 Sec. 2. K.S.A. 74-3293 is hereby amended to read as follows: 74-
21 3293. (a) There is hereby established the nursing service scholarship
22 program. A scholarship may be awarded under the nursing service
23 scholarship program to any qualified nursing student enrolled in or
24 admitted to a school of nursing in a course of instruction leading to
25 licensure as a licensed professional nurse or licensed practical nurse. A
26 nursing student shall not be required to be a resident of Kansas to qualify
27 for a scholarship under the nursing service scholarship program. ~~The~~
28 ~~number of new scholarships awarded under the nursing service scholarship~~
29 ~~program in each year shall not exceed 250. Of this number, except as~~
30 ~~otherwise provided in this section, 100 scholarships shall be awarded to~~
31 ~~nursing students whose sponsors are located in rural areas and who are~~
32 ~~enrolled in a course of instruction leading to licensure as a registered~~
33 ~~professional nurse, 50 scholarships shall be awarded to nursing students~~
34 ~~enrolled in a course of instruction leading to licensure as a licensed~~
35 ~~practical nurse and the remaining 100 scholarships shall be awarded to any~~
36 ~~nursing students who have a sponsor and who are enrolled in a course of~~
37 ~~instruction leading to licensure as a registered professional nurse. If all~~
38 ~~scholarships authorized to be awarded under this section to nursing~~
39 ~~students whose sponsors are located in rural areas have not been awarded~~
40 ~~by a date established by the state board of regents, the scholarships which~~
41 ~~have not been awarded by that date may be awarded to nursing students~~
42 ~~who have a sponsor and who are otherwise qualified to be awarded a~~
43 ~~scholarship under the nursing service scholarship program. The~~

1 determination of the individuals qualified for such scholarships shall be
2 made by the executive officer ~~after seeking advice from the committee.~~
3 ~~Within each scholarship category prescribed by this subsection,~~
4 Scholarships shall be awarded on a priority basis to qualified applicants:
5 (1) ~~Whose sponsor is a mental health or treatment facility; and (2) who~~
6 ~~have the greatest financial need for such scholarships. To the extent~~
7 ~~practicable and consistent with the other provisions of this section,~~
8 ~~consideration shall be given to minority applicants.~~

9 (b) Scholarships awarded under the nursing service scholarship
10 program shall be awarded for the length of the course of instruction
11 leading to licensure as a licensed professional nurse or licensure as a
12 licensed practical nurse which the student is enrolled in or admitted to
13 unless otherwise terminated before the expiration of such period of time.
14 Such scholarships shall provide to a nursing student:

15 (1) ~~If the nursing student is enrolled in a school of nursing operated~~
16 ~~by a state educational institution, an amount not to exceed 70% of the in-~~
17 ~~state tuition cost of attendance for an academic year at the school of~~
18 ~~nursing in which the nursing student is enrolled; or~~

19 (2) ~~if the nursing student is enrolled in a school of nursing not~~
20 ~~operated by a state educational institution, the lesser of: (A) An amount not~~
21 ~~to exceed 70% of the in-state tuition cost of attendance for a year at the~~
22 ~~school of nursing in which the nursing student is enrolled; or (B) an~~
23 ~~amount not to exceed 70% of the average amount of the in-state tuition~~
24 ~~cost of attendance for a year at the schools of nursing operated by the state~~
25 ~~educational institutions.~~

26 (c) **(1) Except as provided in paragraph (2),** the amount of each
27 scholarship shall be established annually by the executive officer ~~and shall~~
28 ~~be financed equally by the sponsor of the nursing student and by the state~~
29 ~~of Kansas except if:~~

30 (1) ~~The sponsor is located in a rural area or is a health care facility~~
31 ~~which has less than 100 beds, and is not a mental health or treatment~~
32 ~~facility pursuant to K.S.A. 74-3292(e)(1), (e)(5) or (e)(6), and amendments~~
33 ~~thereto, the total amount of the scholarship financed by such sponsor shall~~
34 ~~not exceed \$1,000 and the balance of such amount shall be paid by the~~
35 ~~state of Kansas; or~~

36 (2) ~~the sponsor is a mental health or treatment facility pursuant to~~
37 ~~K.S.A. 74-3292(e)(2), (e)(3), (e)(4) or (e)(7), and amendments thereto, the~~

40 **(2) If the nursing student has a sponsor, then the amount of the**
41 **scholarship for such nursing student shall not exceed the amount**
42 **established under paragraph (1) multiplied by 125%.**

43 Sec. 3. K.S.A. 74-3294 is hereby amended to read as follows: 74-

1 3294. (a) An applicant for a scholarship under the nursing service
2 scholarship program shall provide to the executive officer, on forms
3 supplied by the executive officer, the following information:

4 (1) The name and address of the applicant;

5 (2) the name and address of the school of nursing in which the
6 applicant is enrolled or to which the applicant has been admitted; ~~and~~

7 ~~(3) the name and address of the sponsor of the applicant and a~~
8 ~~verified copy of the agreement entered into by the applicant and the~~
9 ~~sponsor in accordance with the provisions of the nursing service~~
10 ~~scholarship program; and the name and address of the sponsor of the~~
11 **applicant and a verified copy of the agreement entered into by the**

15 (b) As a condition to awarding a scholarship under the nursing
16 service scholarship program, the executive officer and the applicant for a
17 scholarship shall enter into an agreement ~~which that~~ shall require that the
18 scholarship recipient:

19 (1) Complete the required course of instruction and, *within six*
20 *months after completion*, attain licensure with the Kansas state board of
21 nursing as a licensed professional nurse or a licensed practical nurse;

22 (2) *complete the free application for federal student aid for each*
23 *academic year for which scholarship funds are awarded under the*
24 *agreement;*

25 (3) *within six months after attaining licensure*, engage in the full-time
26 practice of nursing, or the equivalent to full-time practice, in ~~the~~
27 ~~employment of the sponsor in accordance with the agreement entered into~~
28 ~~by the scholarship recipient and the sponsor~~ *Kansas* and continue such
29 full-time practice, or the equivalent to full-time practice, for the total
30 amount of time required under the agreement, which shall be for a period
31 of not less than the length of the course of instruction for which
32 scholarship assistance was provided, or engage in the part-time practice of
33 nursing in ~~the employment of the sponsor in accordance with the~~
34 ~~agreement entered into by the scholarship recipient and the sponsor~~
35 *Kansas* and continue such part-time practice for the total amount of time
36 required under the agreement, which shall be for a period of time that is
37 equivalent to full time, as determined by the state board of regents,
38 multiplied by the length of the course of instruction for which scholarship
39 assistance was provided. **If the scholarship recipient has a sponsorship**
40 **agreement, then the scholarship recipient shall engage in the practice**
41 **of nursing in the employment of such sponsor in accordance with such**
42 **sponsorship agreement for the period of time required under this**
43 **paragraph, except as provided in K.S.A. 74-3296, and amendments**

2 ~~(3)(4) commence the full-time practice of nursing, or the equivalent to~~
3 ~~full-time practice, or the part-time practice of nursing, within six months~~
4 ~~after registration in accordance with the agreement entered into by the~~
5 ~~scholarship recipient and the sponsor, continue such practice for the total~~
6 ~~amount of time required under the agreement, and comply with such other~~
7 ~~terms and conditions as may be specified by such agreement;~~

8 ~~(4)(5) maintain records and make reports to the executive officer as~~

22 ~~such amount shall be deposited in the nursing service scholarship program~~
23 ~~fund in accordance with K.S.A. 74-3298, and amendments thereto.~~

24 ~~(d) The sponsorship by a scholarship recipient may be transferred~~
25 ~~from one sponsor to another upon the agreement of the original sponsor,~~
26 ~~the scholarship recipient and the sponsor to which the sponsorship is to be~~
27 ~~transferred. The terms, conditions and obligations of the transferred~~
28 ~~agreement shall be substantially similar to the terms, conditions and~~
29 ~~obligations of the original agreement. No sponsorship shall be transferred~~
30 ~~unless the agreement transferring such sponsorship provides for service in~~
31 ~~a rural area or in a mental health or treatment facility and is approved by~~
32 ~~the executive officer as consistent with the provisions of the nursing~~
33 ~~service scholarship program and as consistent with any rules and~~

37 Sec. 4. K.S.A. 74-3295 is hereby amended to read as follows: 74-
38 3295. (a) Except as provided in K.S.A. 74-3296, and amendments thereto,
39 upon the failure of any person to satisfy the obligation under any
40 agreement entered into pursuant to the nursing service scholarship
41 program, such person shall pay to the executive officer an amount equal to
42 the total amount of money received by such person pursuant to such
43 agreement ~~which~~ *that* was financed by the state of Kansas plus accrued

1 interest at a rate which is equivalent to the interest rate applicable to loans
2 made under the federal PLUS program at the time such person first entered
3 into an agreement plus five percentage points and shall pay to the sponsor
4 an amount equal to the total amount of money received by such person
5 pursuant to such agreement which was financed by the sponsor plus
6 accrued interest at a rate which is equivalent to the interest rate applicable
7 to loans made under the federal PLUS program at the time such person
8 first entered into an agreement plus five percentage points of 5% per
9 annum. Interest shall begin to accrue on the date of the action or
10 circumstances that cause such person to fail to satisfy the obligations of
11 such agreement, as determined by the executive officer based upon the
12 circumstances of each individual case. Installment payments of any such
13 amounts may be made in accordance with the provisions of agreements
14 entered into by the scholarship recipient and the sponsor or if no such
15 provisions exist in such agreements, in accordance with rules and
16 regulations of the state board of regents, except that. Such installment
17 payments shall commence six months after the date of the action or
18 circumstances that cause the failure of the person to satisfy the obligations
19 of such agreements, as determined by the executive officer based upon the
20 circumstances of each individual case on which interest begins to accrue.
21 Amounts paid under this section to the executive officer shall be deposited
22 in the nursing service scholarship repayment fund in accordance with
23 K.S.A. 74-3298, and amendments thereto.

24 (b) The state board of regents is authorized to turn any repayment
25 account arising under the nursing service scholarship program over to a
26 designated loan servicer or collection agency, the state not being involved
27 other than to receive payments from the loan servicer or collection agency
28 at the interest rate prescribed under this section.

18 **(c) (1) An obligation under any sponsorship agreement shall be
19 satisfied if:**

20 **(A) Because of bankruptcy, loss of licensure or certification or
21 other failure in the operations of the sponsor, such sponsor cannot or
22 will not employ the person obligated; or**

23 **(B) the sponsor releases the person obligated from employment
24 with such sponsor.**

25 **(2) Notwithstanding the provisions of paragraph (1), the person
26 obligated shall still be required to complete the terms, conditions and
27 obligations of the agreement with the state board of regents by
28 engaging in the practice of nursing in Kansas.**

30 3297. ~~(a) The state board of regents, after consultation with the committee,~~

31 ~~may adopt rules and regulations establishing minimum terms, conditions~~

33 ~~agreement entered into between a sponsor and the recipient of a~~

34 ~~scholarship under the nursing service scholarship program. The terms,~~

35 ~~conditions and obligations shall be consistent with the provisions of law~~

11 scholarship program fund. The executive officer shall remit all moneys
12 received from ~~sponsors, which are paid under K.S.A. 74-3294, and~~
13 ~~amendments thereto, pursuant to scholarship awards, or from a school of~~
14 ~~nursing, which that~~ are paid because of nonattendance or discontinued
15 attendance by scholarship recipients, to the state treasurer in accordance
16 with the provisions of K.S.A. 75-4215, and amendments thereto. Upon
17 receipt of each such remittance, the state treasurer shall deposit the entire
18 amount in the state treasury to the credit of the nursing service scholarship
19 program fund. All expenditures from the nursing service scholarship
20 program fund shall be for scholarships awarded under the nursing service
21 scholarship program ~~or refunds to sponsors~~ and shall be made in
22 accordance with appropriation acts upon warrants of the director of
23 accounts and reports issued pursuant to vouchers approved by the
24 executive officer or by a person designated by the executive officer.

25 (b) The nursing student scholarship discontinued attendance fund is
26 hereby abolished. On the effective date of this act, the director of accounts
27 and reports shall transfer all moneys remaining in the nursing student
28 scholarship discontinued attendance fund to the nursing service
29 scholarship program fund.

30 (c) There is hereby created in the state treasury the nursing service
31 scholarship repayment fund. The executive officer shall remit all moneys
32 received for amounts paid under K.S.A. 74-3295, and amendments thereto,
33 to the state treasurer in accordance with the provisions of K.S.A. 75-4215,
34 and amendments thereto. Upon receipt of each such remittance the state
35 treasurer shall deposit the entire amount in the state treasury to the credit
36 of the nursing service scholarship repayment fund. All expenditures from
37 the nursing service scholarship repayment fund shall be for scholarships
38 awarded under the nursing service scholarship program and shall be made
39 in accordance with appropriation acts upon warrants of the director of
40 accounts and reports issued pursuant to vouchers approved by the
41 executive officer or by a person designated by the executive officer.
